## 2023 Chicago Bears Kids Club Supermarket Scavenger Hunt Sweepstakes

## **OFFICIAL RULES**

## NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.
