

Atrium Health Fan Experience Sweepstakes
Administered by Panthers Football, LLC
Official Rules
NO PURCHASE NECESSARY TO ENTER OR WIN.

1) Eligibility: The Atrium Health Fan Experience Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of North Carolina and South Carolina who, prior to the date of entry are eighteen (18) years of age or older (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of Panthers Stadium, LLC, Panthers Football, LLC (hereafter, "Sponsor"), the National Football League, its member professional football clubs, NFL Ventures, L.P., Charlotte-Mecklenburg Hospital Authority d/b/a Atrium Health, each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. 2) Promotion Period: Sweepstakes starts at 8:00:00 am Eastern Time ("ET") on September 28, 2023 and ends at 11:59:59 pm ET on October 25, 2023 (hereafter, "Promotion Period").

3) How to Enter: During the Promotion Period, visit WEBSITE and follow the instructions to complete and submit the registration form to receive one (1) entry into the Sweepstakes.

Limit of one (1) entry per person throughout the Promotion Period. Entries received in excess of the stated limitation will be void. Entries must be received by 11:59:59 pm ET on October 25, 2023. Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, inaccurate, destroyed or undelivered entries, entry information or for telephonic, human or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, emails or the announcement of a prize; or for any injury or damage to entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Sponsor reserves the right, in its sole discretion, to void any entries of entrants who Sponsor believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes or is

4) Winner Selection: One (1) potential prize winner will be randomly selected from among all entries received throughout the Promotion Period. Drawings will be conducted by Sponsor on or about October 27, 2023. Odds of winning a prize depends upon the total number of eligible entries received throughout the Promotion Period. By entering, entrants agree to be bound by these Official Rules and to the decisions of the Sponsor and judges, which will be final and binding in all respects. The potential winners will be notified by telephone and/or email and may be required to execute and return a Prize Claim form, and/or any other required documentation required by Sponsor within two (2) days of the date of issuance of notification. Non-compliance with the foregoing, with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner.

5) Prizes: One (1) Grand Prize winner will receive two (2) lower level tickets to the Carolina Panthers home game scheduled for November 5, 2023 at Bank of America Stadium (the "Game"). In addition, the Grand Prize winner will receive one (1) premium parking pass, two (2) pre-game hospitality passes, two (2) tunnel walk passes, two (2) pre-game field passes opportunity to meet one (1) Panthers Legend, opportunity to meet the Carolina Panthers play-by-play game day announcers, one (1) tour of Bank of America Stadium and one (1) prize pack consisting of one (1) Carolina Panthers autographed Item. Average Retail Value ("ARV") of Prize Is \$7,750.

Location of seats subject to Sponsor sole discretion. Food and beverage at Home Game, transportation to Home Game, hotel/lodging accommodations (if necessary) and all other costs or expenses associated with prize are NOT included and the responsibility of each prize winner. Odds of winning a prize depends upon the total number of eligible entries received throughout each Entry Period. Limit one (1) prize per winner. Prizes are not transferable. No substitution or transfer of prize permitted except at the sole discretion of the Sponsor. Prizes are awarded "as is" without any warranty or guarantee, either express or implied by Sponsor.
