

Sweepstakes Official Rules
NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

Purchase does not increase chance of winning.

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Participation constitutes your (each eligible person to enter is an (“Entrant”)) full and unconditional agreement to and acceptance of these Official Rules. The information in Rule No. 2 outlines the specifics for this Sweepstakes.
2. **Name of Sweepstakes:** Highmark x Buffalo Bills Igloo Village Sweepstakes (the “Sweepstakes”)
Sweepstakes Period: Begins 12:01am ET on October 2, 2023 and ends 11:59pm ET on October 11, 2023 (the “Sweepstakes Period”)
Drawing Dates: On or around October 12, 2023.
Prize Description: Three (3) winners will each win six (6) tickets to the Bills regular season game vs the New York Giants on October 15, 2023 at 8:20 PM and one (1) igloo tailgate experience for themselves and five (5) guests. The Igloo Tailgate experience will be located in Tailgate Village and each winner will also receive one (1) parking pass. Each igloo can seat up to six (6) individuals and includes furniture, lighting, wifi, TVs, light appetizers, and water/soft drinks. The tailgate will run for four (4) hours, starting when the lots open and ending at kickoff.
Quantity and Value of Prizes to be Given Away: Three (3) Winners; Approximate total retail value of each prize is \$835.00 The total for all prizes is \$2,505.00.

3. Open to legal residents of the United States residing in New York State eighteen (18) years or older at time of entry.
