

**2023 CHICAGO BEARS WELCOME HOME FANS SWEEPSTAKES
BROUGHT TO YOU BY ENJOY ILLINOIS
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. HOW TO ENTER: The 2023 Chicago Bears Welcome Home Fans Sweepstakes brought to you by Enjoy Illinois (the "Sweepstakes") starts October 2, 2023 at 10:00AM Central Time ("CT") and ends on October 6, 2023 at 3:00PM CT ("Entry Period"). To enter the Sweepstakes, visit <https://www.chicagobears.com/sweepstakes/welcome-home> and complete the entry form by providing your name, address, date of birth, email address, and phone number ("CB.com Entry Form"). Limit one (1) entry per person during the Entry Period. Entrants that use multiple email addresses to enter the Sweepstakes will be disqualified.

2. ELIGIBILITY: The Sweepstakes is open to all legal residents of the United States, except residents of Rhode Island, ages 18 years and over as of October 2, 2023. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc. ("Sponsor" or "Chicago Bears"), the National Football League, Illinois Office of Tourism ("Enjoy Illinois") and their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies, and their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, half-sister) and/or those living in the same household of each are not eligible. Approximate retail value of the Prize is \$976 Sponsor reserves the right to substitute any part of the Prize with another of equal value should any unforeseen circumstances occur. All state, federal, and local taxes or other expenses not specified herein are the sole responsibility of the Prize Winner, including, without limitation, any costs or expenses associated with travel to and from the Game.
