## 2023 Chicago Bears Club Level "Guess The Chocolate Candies" Contest Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. HOW TO ENTER: The 2023 Chicago Bears Club Level "Guess The Chocolate Candies" Contest (the "Contest") starts on September 10, 2023 at 10:00 a.m. central time ("CT") and ends on January 9, 2024 at 11:59 p.m. CT ("Entry Period"). To enter the Contest, entrants scan a QR code to complete the entry form and guess the amount of chocolate candies in the cylindrical container (each, and "Entrant," and collectively, "Entrants").
