

2023 Chicago Bears Crucial Catch Sweepstakes
OFFICIAL RULES

HOW TO ENTER: The entry period for the Chicago Bears Crucial Catch Sweepstakes (the "Sweepstakes") begins Sunday, October 15, 2023 at 7 a.m. central standard time ("CT") and ends Sunday, October 15, 2023 11:59 p.m. CT ("Entry Period"). To enter the Sweepstakes, Fill out the Sweepstakes entry form ("Entry Form") during the Entry Period. Limit one entry per person.

2. ELIGIBILITY: The Sweepstakes is open to all legal residents of the United States ages 18 years and over as of October 15, 2023.
