

Sweepstakes Official Rules
NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

Purchase does not increase chance of winning.

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Participation constitutes your (each eligible person to enter is an (“Entrant”)) full and unconditional agreement to and acceptance of these Official Rules. The information in Rule No. 2 outlines the specifics for this Sweepstakes.
2. **Name of Sweepstakes:** BFLO Invasion – Bengals Game (the “Sweepstakes”)
Sweepstakes Period: Begins 12:01am on October 27, 2023 and ends 11:59pm on November 2, 2023 (the “Sweepstakes Period”)

Prize Description: Two (2) tickets to Bills at Bengals game on November 5, 2023 in Cincinnati, Ohio, two (2) pregame on field passes and one (1) BFLO Store Prize Pack
Quantity and Value of Prizes to be Given Away: One (1) winner, approx. value of prize: \$900.00
Sponsor(s): Buffalo Bills, LLC, One Bills Drive, Orchard Park, NY 14127 (the “Bills”) and The BFLO Store (collectively, the “Sponsor”)
3. Open to legal residents of the United States residing in New York State 18 years or older at time of entry (each eligible person to enter is an “Entrant”). Employees of the Sponsor and its affiliates and subsidiaries; their advertising, promotion, and fulfillment agencies; and members of the immediate family or household of each of the above are not eligible to participate.
