

## Morris-Jenkins Heat It Up Sweepstakes 2023

### Official Rules

#### NO PURCHASE NECESSARY TO ENTER OR WIN.

1) Eligibility: The Morris-Jenkins Heat It Up Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of North Carolina and South Carolina residing in a radius approximate 30 miles from Charlotte, NC, who, prior to the date of entry, are twenty-one (21) years of age-or older and a homeowner (hereafter, "Eligible Entrants").

By submitting your completed online entry form and all other requested information as directed, you will receive one (1) entry in the Sweepstakes. Limit of one (1) entry per person throughout the Promotion Period. Entrants must fully complete and submit all data requested on the online entry form to be eligible. Incomplete entries are void. Online entrants to the

Sweepstakes will be given the option to receive commercial e-mails from Released Parties; however, eligibility to participate in the Sweepstakes is not dependent upon entrant's consent to receive such e-mails and consenting to do so will not increase your chances of winning.

Administrator reserves the right, in its sole and absolute discretion, to void any Entries or Follow requests of entrants and disqualify such entrants whom Administrator believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes and/or who are in violation of these Official Rules.

Drawing will be conducted by Administrator on or about one (1) business day following the conclusion of the Promotion Period. The potential winners will be notified via email by Administrator as determined by Administrator in its sole and absolute discretion.
