

2024 Season Suite and Loge Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN ANY PRIZE. MUST BE 21+. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Deadlines: To be eligible for any prize, you must submit a valid entry between September 4, 2023 at 9:00 AM PT and December 1, 2023 at 11:59 PM PT (the “Sweepstakes Period”). Each prize has its own deadline by which a valid entry must be received (“Prize Entry Deadline”).

2. Prize: The table below sets forth the dates by which valid entries must be received in order to be included in the drawing for each prize (each, a “Prize Entry Deadline”), description of the prizes, the number of prizes being awarded and the AVR value for each prize. There will be three Prize Entry Deadlines: October 1, 2023; November 1, 2023; and December 1, 2023. For each person that submits a valid entry (each an “Entrant”) prior to each Prize Entry Deadline, such Entrant shall be eligible for Prizes that have Prize Entry Deadlines that occur after such entry date. Prize winners (each a “Winner”) will be selected at random to win the below Prize. Once an Entrant wins a prize, they will not be eligible to win subsequent drawings. There will be eleven (11) prizes awarded (each, a “Prize”).

For purposes of example only, an Entrant with an entry received on October 15, 2023 would be not be eligible for Prizes 1-3. Such Entrant will be entered into a drawing for Prize 4. If Entrant is not selected as a winner, Entrant will be entered into a drawing for Prize 5. If not selected as a winner, Entrant will be entered into the drawing for Prize 6, and so on. If such Entrant is selected as a winner for any Prize, such Entrant will not be eligible for any other Prizes.

Any difference between stated value and actual value will not be awarded.

Selection of Winners: Random drawings each Prize (each, a "Random Drawing") will be conducted by Sponsor within four (4) weeks of each Prize Entry Deadline. The odds of winning depend on the number of eligible entries received. Potential winners are subject to verification of eligibility and compliance with these Official Rules (the "Official Rules"). Potential winners will be notified by telephone or e-mail after the Random Drawing with instructions on how to claim a Prize. Failure to provide all required information within the stated time period may result in forfeiture of winner's right to claim a Prize, and may result in the Prize being awarded to an alternate winner, if time permits. Each potential winner may be subject to a background check before the Prize is awarded. Sponsor reserves the right to disqualify the potential winner based on the results of such background check if Sponsor determines in its sole discretion that awarding the Prize to any such individual might reflect negatively on the LV Stadium Events Company, LLC ("Sponsor") and its owners, parents, subsidiaries and affiliates. Upon verification of eligibility, each Prize will be mailed or otherwise delivered to the winner at the physical address (P.O. Boxes are not permitted) provided during winner verification (or at the time of entry if the potential winner entered via the Online Entry). Raiders Football Club, LLC, Sponsor, The Oakland Raiders, a California limited partnership, the Las Vegas Stadium Authority and each of their respective parent companies, subsidiaries, affiliates, divisions, suppliers, distributors, advertising/promotion agencies, and each such company's officers, directors, employees, representatives and agents (collectively, the "Raiders Entities") shall not be held responsible for any delays in awarding a Prize for any reason. If a potential winner is found to be ineligible, is not in compliance with these Official Rules, declines to accept the Prize, or any winner notification is returned as undeliverable or the potential winner fails to respond to a winner notification within the timeframe specified in such winner notification, or if a potential winner does not answer the initial telephone notification, the Prize may be forfeited. If a Prize is forfeited for any reason, it may be awarded to an alternate potential winner, at the Sponsor's sole and absolute discretion, selected at random from the remaining pool of eligible entries received during the applicable Entry Period and Prize Entry Deadline, time permitting. If, after a good-faith attempt, Sponsor is unable to award or deliver a Prize, the Prize may not be re-awarded. Prizes are not transferable and include only the items specifically listed as part of each Prize. Any portion of Prize not accepted by winner will be forfeited. To the extent any Prize includes access or pricing for Entrant guest(s), Entrant agrees that any such guest must complete any prize-related documentation (including but not limited to release of liability waivers and use of image licenses). Any guest(s) that does not complete such documentation may not be able to participate. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for any Prize won. ARVs are as of the time these Official Rules were printed and the value of a Prize may fluctuate. A winner is not entitled to any difference between the ARV and the actual value of the Prize at the time the Prize is awarded. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. Each Prize will only be awarded to a verified winner. Sponsor shall have no liability for any potential Prize winning notification that is lost, intercepted or not received by any potential prizewinner for any reason.

To the extent the fulfillment of any Prize involves the distribution of any credit, pre-paid cards or gift cards, the use of any such credit, pre-paid card or gift card shall be subject to the terms and conditions set forth thereon which shall govern the use of such credit, pre-paid card or gift card. Use of a credit, pre-paid card or gift card constitutes the user's acceptance of the terms and conditions so each winner should read the terms and conditions on the credit, pre-paid card or gift card carefully. A credit, pre-paid card or gift card will not be replaced or replenished if it is lost, stolen, damaged, destroyed or used without the winner's permission and will be voided if altered or defaced.

In no event will more Prize than are stated in these Official Rules be awarded. If, for any reason, more Prize notifications are sent (or more claims are received) than the number of Prize offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of Prize through a random drawing from among all eligible Prize claims received. Limit of one (1) Prize per person/household. No Prize substitution or exchange will be allowed, except by Sponsor, who reserves the right (but not the obligation) to substitute a prize of equal or greater value in case of unavailability of a Prize or force majeure.

All selections shall be done via random drawing.

3. How to Enter: All Entrants agree that all decisions of the Sponsor shall be final and Entrants waive any right to challenge any decisions made by the Las Vegas Raiders. **Entrants expressly agree to be bound by the terms and conditions of these Official Rules and expressly agree to all of the terms and conditions herein.**

There are two ways to submit a valid entry. Only one entry is allowed per account.

- A. **Season renewal and payment in full.** Internet access and a valid e-mail address are required for this form of entry. Each Raiders Loge and Suite license holder that pays his or her season tickets for the 2023-2024 NFL season by submitting payment in full on or before a Prize Entry Deadline will receive an email to a public link to the entry (the "Website") for online entry. Prior to a Prize Entry Deadline, an eligible entrant must logon the Website and submit an entry form on the website and agree to be bound by the terms and conditions of these Official Rules. The information requested on the registration form may include without limitation: entrant's first and last name (initials are not permitted), valid e-mail address, complete mailing address (P.O. Boxes are not permitted), date of birth, telephone number and affirmation that he/she has read and agrees to be bound by these Official Rules. Upon completion and submission of the registration form, the entrant will receive one (1) entry into the Sweepstakes. Only one entry permitted per PSL account.
- B. **Mail a Postcard.** To enter without purchase, send a postcard with your name, address, email address, telephone number, age, signature, and the phrase "I agree to the terms and conditions of the Official Rules of the 2024 Season Ticket Sweepstakes as posted on the Raiders website" via US Mail to the following address: The Las Vegas Raiders, Attn: 2024 Season Ticket Sweepstakes Entry, 1475 Raiders Way, Henderson, NV 89052. One entry per person or account. An entry via this method is valid only upon receipt by Sponsor. Sponsor are not responsible for delayed, misdirected, or lost deliveries.

4. Other Terms of Entry. A purchase does not increase the odds of winning. Each Entrant and/or Winner expressly consents to the use of his or her name, likeness, and biographical information for all publicity purposes by Sponsor or any sponsor, without further compensation, except where prohibited by law. **Winners will be solely responsible for any federal, state or local taxes on Prize.** Prize are non-transferable; no substitutions or cash redemptions. Sponsor are not responsible for incorrect or inaccurate entry information whether caused by technical difficulty or human error. Odds of winning depend on number of eligible Entries received.

For Prize that involve travel, Winner and his/her guests must travel together on same itinerary and are responsible for obtaining all required travel documents, including but not limited to passports. Winner and guest may be required to provide a credit card and/or identification at time of hotel/lodge check-in or at airport. Sponsor is not responsible for travel delays or cancellations. In the event Winner cannot obtain required travel documents or clearances, Winner shall forfeit the Prize and no substitute Prize shall be awarded to Winner. In the event the game is postponed and rescheduled or if subject to attendance limits for any reason, Sponsor will take commercially reasonable efforts to reschedule or provide alternate prizing in Sponsor's sole determination. In the event the game is postponed and not rescheduled for any reason, no compensation or substitution for such portion of the Prize will be provided.

Winners and applicable guest must comply with rules and regulations of Allegiant Stadium and the Las Vegas Raiders as well as any applicable ticketback release and waiver, including but not limited to any COVID-19 protocols. Failure to do so may result in forfeiture of such portion of the prize and removal from event. Sponsor reserves the right to remove or to deny attendance to Winner and/or guest if such person engages in a non-sportsmanlike or disruptive manner, or behave in any way that is annoying, abusive, threatening or harassing any other person at the game. The tickets are subject to the terms and conditions specified thereon. If unused, tickets cannot be returned, refunded or exchanged for cash value or substitute tickets. Any costs incurred due to changes to the original itinerary are solely Winner's responsibility. Game date is subject to change. Seating assignments to be determined by Sponsor, in its sole discretion, at a later date. Travel and accommodations are at the Sponsor discretion and subject to availability and change. Ground transportation, meals, gratuities, Passport fees, and all other expenses not specified herein are solely Winner's responsibility.

5. Eligibility and Liability: Sweepstakes is open to legal U.S. residents (except residents of Florida, New York, Rhode Island, and where otherwise prohibited) over the age of 21 who submit a valid entry per the terms of the Official and agree to be bound to these Official Rules. Employees, officers and directors of Sponsor, Raiders Football Club, LLC, Raiders Foundation, Raider Image, LLC, or their respective affiliates, officers, directors, or their immediate family members are ineligible. The Sweepstakes is subject to all federal, state, and local laws and regulations, and is void in Rhode Island, New York, Florida, and where prohibited. By entering the Sweepstakes or accepting any prize, all Entrants expressly agree to forever waive, release, discharge, and covenant not to sue Sponsor, Raiders Football Club, LLC, Oakland Raiders, a California limited partnership, Raiders Foundation, The Raider Image, LLC, the Las Vegas Stadium Authority and each of their respective parent companies, subsidiaries, affiliates, divisions, suppliers, distributors, advertising/promotion agencies, and each such company's officers, directors, employees, representatives and agents (collectively "Raiders Related Parties") of, for and from any and all claims, debts, liabilities, demands, obligations, costs, fees, expenses, actions and causes of action whatsoever, of every nature, character and description (collectively, "Claims"), known and unknown, including, but not limited to, all those arising out of or in any way related to the Sweepstakes; these Official Rules; the legality of these Official Rules; Entrant's entry; the negligence of Sponsor or any Raiders Related Party; the acceptance, possession, misuse or use of any

Prize; any travel related to any prize; any purchase of tickets; any participation in the Sweepstakes; and any presence at any stadium or on the field or sideline. Entrant represents and warrants that he or she owns and/or has the authority to release the Claims stated herein expressly waives Section 1542 of the California Civil Code, which provides:

A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party.

The Released Parties are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a Prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. Further, the Released Parties are not responsible for any undelivered text messages or e-mails, including without limitation, e-mails that are not received because of an entrant's privacy or spam filter settings that may divert any winner notification or other Sweepstakes related e-mail to a spam or junk folder. Sponsor reserves the right to, in its sole discretion, cancel, modify, or suspend the Sweepstakes at any time. Sponsor also reserves the right to substitute any similar prize or a prize of equal or greater value for any prize listed in these Official Rules or any other communication regarding the Sweepstakes and reserves the right to revoke the prize of any Entrant, at any time, if the Entrant acts in a manner that is, in the Sponsor's discretion, offensive, harassing, threatening, repugnant, or violent at any time.

These Official Rules shall be construed and interpreted according to the laws of the state of Nevada without regard to choice of law principles. As a condition of participating in this Sweepstakes, each Entrant agrees that any and all disputes which cannot be resolved between the parties, and causes of action arising out of or connected with this Sweepstakes, shall be resolved individually, without resort to any form of class action, exclusively before a court located in Clark County, Nevada having jurisdiction. If Sponsor determines (in its sole and absolute discretion) that, for any reason, the Sweepstakes is not capable of running as planned, or the integrity and/or feasibility of the Sweepstakes is undermined by any event beyond the control of Sponsor, including but not limited to fire, flood, epidemic, pandemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, war (declared or undeclared), terrorist threat or activity, or any federal, state or local government law, order, or regulation, order of any court or jurisdiction, infection by computer virus, unauthorized intervention, technical failures or other cause not reasonably within the control of Sponsor (each a "Force Majeure" event or occurrence), Sponsor reserves the right, at its sole and absolute discretion, to abbreviate, cancel, terminate, modify or suspend the Sweepstakes and/or proceed with the Sweepstakes, including the selection of winners in a manner it deems fair and reasonable, including the selection of winners from among eligible entries received prior to such cancellation, termination, modification or suspension without any further obligation provided a sufficient number of eligible entries are received. If Sponsor, in its discretion, elects to alter this Sweepstakes as a result of a Force Majeure event, a notice will be posted at the Website.

WITHOUT LIMITING THE FOREGOING, EVERYTHING REGARDING THIS SWEEPSTAKES, INCLUDING THE PRIZE, IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NON-INFRINGEMENT.

- 7. DISPUTES:** THESE OFFICIAL RULES SHALL BE CONSTRUED AND INTERPRETED ACCORDING TO THE LAWS OF THE STATE OF NEVADA WITHOUT REGARD TO CHOICE OF LAW PRINCIPLES. AS A CONDITION OF PARTICIPATING IN THIS SWEEPSTAKES, EACH ENTRANT AGREES THAT ANY AND ALL DISPUTES WHICH CANNOT BE RESOLVED BETWEEN THE PARTIES, AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THIS SWEEPSTAKES, SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION, EXCLUSIVELY BEFORE A COURT LOCATED IN CLARK COUNTY, NEVADA HAVING JURISDICTION. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
- 8. PRIVACY POLICY:** Any personally identifiable information collected during an entrant's participation in the Sweepstakes will be collected by Sponsor or its designee and used by Sponsor, its affiliates, designees, agents and marketers for purposes of the proper administration and fulfillment of the Sweepstakes as described in these Official Rules and otherwise in accordance with Sponsor's privacy policy at <https://www.raiders.com/footer/privacy-policy>.
- 9. PUBLICITY RIGHTS:** By participating in the Sweepstakes and/or accepting a Prize, each entrant hereby grants to Sponsor, the Raiders Entities, and their designee(s) a non-exclusive, royalty-free worldwide, perpetual right and license to use his/her name, biographical information, photos and likeness, voice recording, video images and all related footage, and statements for Sweepstakes, trade, commercial, advertising and publicity purposes, at any time or times, in all media now known or hereafter discovered worldwide including but not limited to television (including live television), radio, Internet, without notice, review or approval and without additional compensation except where prohibited by law.
- 10. GENERAL:** This Sweepstakes is subject to all federal, state and local laws and regulations. Winning a Prize is contingent upon fulfilling all requirements set forth herein.
