

**2024 Chicago Bears Baby Bear Photoshoot Sweepstakes**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.  
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. HOW TO ENTER:** The entry period for the 2024 Chicago Bears Baby Bear Photo Shoot Sweepstakes (the "Sweepstakes") starts April 29, 2024 at 10:00 AM central time ("CT") and ends on May 3, 2024 at 11:59 PM CT ("Entry Period"). You may enter one (1) or more of your children or legal wards in the Sweepstakes. Each child you enter into the Sweepstakes must be a member of the Chicago Bears Baby Bears in order to be eligible to participate in the Sweepstakes. **2. ELIGIBILITY:** The Sweepstakes is open to all legal residents of the United States ages 18 years and over as of April 29, 2024 excluding residents of Rhode Island, and who has a child or legal ward who is a member of the Chicago Bears Baby Bears. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc. ("Sponsor" or "Chicago Bears"), Advocate Health Care Network ("Advocate"), and their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, advertising and promotion agencies, and their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, half-sister) and/or those living in the same household of each are not eligible. **3. PRIZE:** One (1) child that is entered into the Sweepstakes by their parents or legal guardian will be selected as the "Prize Winner." The Prize Winner will win a Chicago Bears themed photoshoot with a photographer at Halas Hall on a date to be determined by Chicago Bears ("Prize"). The approximate retail value of the Prize is \$750.

Sponsor reserves the right to substitute the Prize with another of equal value should any unforeseen circumstances occur. All state, federal, and local taxes or other expenses not specified herein are the sole responsibility of the Prize Winner and his or her parent or legal guardian. The Prize is not transferable. No Prize substitutions or cash redemption will be made except in Sponsor's sole discretion.

**4. SELECTION OF WINNER:** One (1) Prize Winner will be selected in a random drawing held on or about: May 3, 2024 from among all eligible entries received up to date of the drawing. Sponsor will contact the parent or legal guardian who entered the Prize Winner in the Sweepstakes via email or telephone. Odds of winning depend upon the number of eligible entries received.

**5. AGREEMENT TO OFFICIAL RULES:** By participating in the Sweepstakes, each Entrant accepts and agrees to comply with and abide by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respect.
