

2024 Chicago Bears Kid Reporter Sweepstakes

OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

1. **HOW TO ENTER:** The entry period for the 2024 Chicago Bears Kid Reporter Sweepstakes (the "Sweepstakes") starts July 22, 2024 at 10 AM CT and ends on July 26, 2024 at 12:00 PM CT ("Entry Period"). You may enter one (1) or more of your children or legal wards in the Sweepstakes during the Entry Period. To enter your child in the Sweepstakes, your child must be a member of the Chicago Bears Kids Club. You can sign a child up for a free Chicago Bears Kids Club membership at: <https://www.chicagobears.com/fan-zone/kid-zone>. Membership is limited to children between the ages of 3 and 12. You can enter a child in the Sweepstakes by completing the entry form available at <https://www.chicagobears.com/sweepstakes/kid-zone/kids-club-press-conference>. The parent/legal guardian of each child entered into the Sweepstakes is referred to as an "Entrant".

2. **ELIGIBILITY:** The Sweepstakes is open to all legal residents of the United States, ages 18 years and over as of July 22, 2024 who has a child or legal ward who is a member of the Chicago Bears Kids Club. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc. ("Sponsor" or "Chicago Bears"), Albertsons Companies Inc. and Its Banner Stores, Jewel-Osco ("Jewel-Osco") and their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, advertising and promotion agencies, and their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, half-sister) and/or those living in the same household of each are not eligible. 3. **PRIZE:** One (1) child who is entered into the Sweepstakes by their parent/ legal guardian will be selected as the "Grand Prize Winner". The Grand Prize Winner will win the following prizes (collectively referred to as the "Grand Prize"):

- (a) Four (4) tickets to one (1) day of Chicago Bears Training Camp located at Halas Hall, 1920 Football Drive, Lake Forest, IL 60045 ("Event") on a date to be determined by Chicago Bears in its sole discretion;
- (b) A tour of Halas Hall, including the Chicago Bears studio set, for the Grand Prize Winner and their three (3) guests on the date of the Event. One (1) parent or legal guardian of Grand Prize Winner must be a part of the guest list;
- (c) An opportunity to interview one (1) current Chicago Bears player, as determined by Chicago Bears in its sole discretion, at Event; and
- (d) One (1) autographed helmet by a current Chicago Bears player, as determined by Chicago Bears in its sole discretion.

The approximate retail value of the Grand Prize is Four Hundred Fifty Dollars (\$450).

Additionally, ten (10) children who are entered into the Sweepstakes by their parents or legal guardians will be selected as "First Prize Winners" (each a "First Prize Winner"). Each First Prize Winner will win the following prizes (collectively referred to as "First Prize"):

- (a) Two (2) tickets to one (1) day of the Event" on a date to be determined by Chicago Bears in its sole discretion. One (1) parent or legal guardian of Prize Winner must accompany each First Prize Winner;
- (b) Participate in a press conference by having the chance to ask one (1) question at Event with fellow Prize Winners with one (1) or two (2) current Chicago Bears players to be determined by Chicago Bears in its sole discretion; and,
- (c) One (1) small prize pack from the Chicago Bears including a hat, Kids Club flag or bandana, Staley figure and backpack.

Approximate retail value of each First Prize is \$150.

Grand Prize Winner and First Prize Winner collectively referred to as "Prize Winner".

Grand Prize and First Prize collectively referred to as "Prize".

Sponsor reserves the right to substitute the Prize with another of equal value should any unforeseen circumstances occur. All state, federal, and local taxes or other expenses, (including but not limited to transportation to and from Event and any food and beverage consumed at Event), not specified herein are the sole responsibility of each Prize Winner and their parents or legal guardians. The Prize is not transferable. No prize substitutions or cash redemption will be made except in Sponsor's sole discretion.

4. **SELECTION OF WINNER:** Each Prize Winner will be selected in a random drawing held on or about July 29, 2024. Sponsor will contact the parent or legal guardian who entered each Prize Winner in the Sweepstakes via email or telephone. Odds of winning depend upon the number of eligible entries received.

5. **AGREEMENT TO OFFICIAL RULES:** By participating in the Sweepstakes, each Entrant, on behalf of Entrant and his or her child, accepts and agrees to comply with and abide by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respect.
