

Carolina Panthers FanFest Sweepstakes
Official Rules
NO PURCHASE NECESSARY TO ENTER OR WIN.

1) Eligibility: The Carolina Panthers FanFest Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of North Carolina and South Carolina who, prior to the date of entry are eighteen (18) years of age or older (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of Panthers Stadium, LLC, Panthers Football, LLC (hereafter, "Sponsor"), the National Football League, its member professional football clubs, NFL Ventures, L.P., each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies, sponsors (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void outside of North Carolina, South Carolina, and where prohibited by law. All applicable federal, state & local laws apply.

2) Promotion Period: Sweepstakes starts at 1:00 pm Eastern Time ("ET") on July 15, 2024 and ends at 11:59 pm ET on August 1, 2024 (hereafter, "Promotion Period").

3) How to Enter: Each Eligible Entrant who attends the Carolina Panthers FanFest will automatically receive one (1) entry into the Sweepstakes for a maximum of eight (8) entries during the Promotional Period. Eligible Entrants must (i) have a valid ticket to the Carolina Panthers FanFest and (ii) attend the Carolina Panthers FanFest in Clemson, South Carolina. *Attend* means the electronic scanning of the ticket barcode or QR code from Eligible Entrant's active TicketMaster Account or mobile wallet at the Carolina Panthers FanFest entry point(s).

To enter the Sweepstakes without attending the Carolina Panthers FanFest, print your name, address, city, state, zipcode, phone number and email address on a 3.5" by 5" postcard or piece of paper, and mail the entry to Sponsor's address below. Mailed entries must be received by August 3, 2024, in order to be included in the random drawing. One entry per person will be accepted throughout the Promotional Period. No mechanically reproduced or photocopied entries will be accepted.

Entries must be received by 7:00:00 pm ET on 8/1/2024 to be eligible. **Limit of one (1) entry per person throughout the Promotion Period for a maximum of eight (8) entries throughout the Promotional Period. Entries received in excess of the stated limitation will be void.** All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. The use of script, macro or automated devices (or any other

devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor's sole discretion and in accordance with these Official Rules) are void. In the event of a dispute as to the identity of any entrant, such entrant will be deemed, to be the "authorized account holder" of the e-mail address submitted at the time of entry provided he/she is eligible according to these Official Rules. "Authorized account holder" is defined as the natural person who is assigned to the e-mail address by an Internet access provider, online service provider or other organization (e.g., a business, educational institution, etc.) which is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, inaccurate, destroyed or undelivered entries, entry information or for telephonic, human or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, emails or the announcement of a prize; or for any injury or damage to entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Sponsor reserves the right, in its sole discretion, to void any entries of entrants who Sponsor believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes or is in violation of these Official Rules.

4) Winner Selection: Winners will be randomly selected from among all entries received during the Promotional Period on August 4, 2024. Odds of winning a prize depends upon the total number of eligible entries received throughout each Entry Period. By entering, entrants agree to be bound by these Official Rules and to the decisions of the Sponsor and judges, which will be final and binding in all respects. The potential winners will be notified by text, telephone and/or email and may be required to execute and return a Prize Claim form, and/or any other required documentation required by Sponsor within two (2) days of the date of issuance of notification. Non-compliance with the foregoing, with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner.

Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than entrant's actual out-of-pocket expenses (i.e., costs associated with participating in this Sweepstakes), and entrant further waives all rights to have damages multiplied or increased.
