

**Panthers Joint Practice Sweepstakes**  
**Presented by Ticketmaster**  
**Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

1) **Eligibility:** The Carolina Panthers Joint Practice Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of North Carolina or South Carolina, (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of Panthers Stadium, LLC, Panthers Football, LLC, the National Football League, its member professional football clubs, NFL Ventures, L.P., Ticketmaster, LLC, and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win.
