

2024 Chicago Bears Monsters of the Midway Trading Cards Sweepstakes
OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.

1. HOW TO ENTER: The entry period for 2024 Chicago Bears Monsters of the Midway Trading Card Sweepstakes (the “Sweepstakes”) will be conducted throughout the 2024 Chicago Bears regular season between August 30, 2024 at 10:00AM Central Time (“CT”) and ends on January 5, 2025 at 11:59PM CT and will be comprised of four (4) separate entry periods (each, an “Entry Period”) as follow:

To enter the Sweepstakes log onto <https://www.chicagobears.com/fan-zone/monsters-of-the-midway-trading-cards> and complete the online entry form during the Entry Period. Limit one entry per person per Entry Period (“Entrant”).

2. ELIGIBILITY: The Sweepstakes is open to all legal residents of the United States ages 18 years and over as of August 30, 2024 , excluding residents of Rhode Island. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc. (“Sponsor”), ATHLiTACOMiCS, LLC, and their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, half-sister) and/or those living in the same household of each are not eligible. 4. SELECTION OF PRIZE WINNERS: On or about the next day following the Entry Period the Prize Winners will be chosen. Sponsor will contact the Prize Winners via email or telephone. Odds of winning depend upon the number of eligible entries received during each Entry Period.
