

**Miami Dolphins MSC Cruises 2024 Ultimate Cruise Sweepstakes
Official Rules**

Normal time rates, if any, charged by Internet service provider will apply. Note, if you enter via social media, you are providing your information to Sponsor and not Instagram, Facebook, or X.

This Sweepstakes is in no way sponsored, endorsed, administered by, or associated with Instagram, Facebook, or X.

Limit one (1) entry per person.

By submitting an entry, entrants fully and unconditionally agree to be bound by these Official Rules and the decisions of Sponsor and its appointed agents, which will be final and binding in all matters relating to the Sweepstakes.
