

## Las Vegas Raiders 2025 Suite & Loge Guaranteed Gift Giveaway Rules

The 2025 Suite & Loge Guaranteed Gift Giveaway (the “**Giveaway**”) is sponsored by Raiders Football Club, LLC (“**Sponsor**”) and governed by these official rules (“**Official Rules**” or “**Rules**”). The Giveaway is available only to authorized Suite & Loge Licensees (individually, a “**Suite & Loge Licensee**,” collectively, the “**Suite & Loge Licensees**”) and is offered in conjunction with payment of their 2025-2026 Raiders License Fee (“**License Fee**”) for such Suite & Loge Licensee accounts. **PLEASE READ THESE OFFICIAL RULES CAREFULLY.**

- 1. HOW TO PARTICIPATE.** To obtain a Gift, you (“**You**” or “**Your**” or “**Suite & Loge Licensee**”) must (i) log into Your Suite & Loge Licensee account manager or call Your suite service manager, and (ii) pay Your renewal invoice for Your License Fee for Your Suite & Loge Licensee account between September 5<sup>th</sup>, 2024, and January 31<sup>st</sup>, 2025 (“**Promotion Period**”). Once payment has been made, You will receive Your free Gift (as defined in Section 2), that will vary depending on when payment was made during the Promotion Period. Receiving a Gift is contingent upon fulfilling all requirements set forth herein.

By participating and thereby electing to receive a Gift, You unconditionally accept and agree to comply with and abide by these Official Rules, Sponsor’s Privacy Policy, waive any right to claim ambiguity in the Official Rules or related advertising/materials and agree that the decisions of Sponsor with respect to the Giveaway and the awarding of the Gifts shall be final and binding in all respects. Sponsor reserves the right to alter the terms of these Official Rules at their discretion. Any such changes to the Official Rules will be prominently displayed and any conflicting changes to the Official Rules will be superseded by the most recent version of the Official Rules.

FREE GIFT.** Upon successfully paying Your renewal invoice for Your License Fee for Your Suite & Loge Licensee account as directed above, You will be eligible to receive the free gift that corresponds with the time Your payment was received during the Promotion Period (each a “**Gift**”, collectively referred to as “**Gifts**”). The time periods and corresponding Gifts are as follows:

- 2.1.** Suite & Loge Licensees who submit payment between September 5<sup>th</sup>, 2024, at 12:01 a.m. Pacific Daylight Time (“**PDT**”) and November 29<sup>th</sup>, 2024, at 11:59 p.m. Pacific Standard Time (“**PST**”), will receive all of the following:

- 2.1.1.** The choice of one (1) of the following: one (1) \$1,000 The Raider Image Shopping Experience Gift Card (“**Shopping Gift Card**”)– OR –one (1) \$1,000 food and beverage gift card or credit (“**Food Gift Card**”) (collectively, the “**Gift Card(s)**”). The Food Gift Card is to be used at Las Vegas Raiders regular season or postseason games played at Allegiant Stadium (excluding any Super Bowl). Such Food Gift Card shall be valid for the 2025-2026 NFL season only and will not roll over to other NFL seasons. The Gift Card cannot be redeemed for cash and cannot be subject to refunds as a result of nonuse. Any additional money spent in excess of the Gift Card and all taxes, gratuity and fees will be Your responsibility. Standard gift card or credit terms and conditions shall apply.

- 2.1.2.** One (1) Allegiant Stadium Tour Experience (“**Tour**”) for four (4) people to be used by the authorized Suite & Loge Licensee and three (3) companions to attend one (1) Allegiant Stadium Tour Experience to be taken between January 1<sup>st</sup>, 2025, and December 31<sup>st</sup>, 2025. All details, including date of Tour, are to be decided in the Sponsor’s sole discretion.

- 2.1.3.** One (1) Lunch and Tour Experience (“**Lunch and Tour**”) for four (4) people to be used by the authorized Suite & Loge Licensee and three (3) companions to attend one (1) lunch and one (1) tour of the Raiders Practice Facility to be taken between January 1<sup>st</sup>, 2025, and December

31<sup>st</sup>, 2025. All details, including the date of the Lunch and Tour, are to be decided in the Sponsor's sole discretion.

2.2. Suite & Loge Licensees who submit payment between November 30<sup>th</sup>, 2024, at 12:00 a.m. PST and December 27, 2024, at 11:59 p.m. PST, will receive all of the following:

2.2.1. One (1) Allegiant Stadium Tour Experience ("**Tour**") for four (4) people to be used by the authorized Suite & Loge Licensee Holder and three (3) companions to attend one (1) Allegiant Stadium Tour Experience to be taken between January 1<sup>st</sup>, 2025, and December 31<sup>st</sup>, 2025. All details, including date of Tour, are to be decided in the Sponsor's sole discretion.

2.2.2. One (1) Lunch and Tour Experience ("**Lunch and Tour**") for four (4) people to be used by the authorized Suite & Loge Licensee and three (3) companions to attend one (1) lunch and one (1) tour of the Raiders Practice Facility to be taken between January 1<sup>st</sup>, 2025, and December 31<sup>st</sup>, 2025. All details, including the date of the Lunch and Tour, are to be decided in the Sponsor's sole discretion.

2.3. Suite & Loge Licensees who submit payment between December 28<sup>th</sup>, 2024, at 12:00 a.m. PST and January 31<sup>st</sup>, 2025, at 11:59 p.m. PST, will receive all of the following:

2.3.1. One (1) Lunch and Tour Experience ("**Lunch and Tour**") for four (4) people to be used by the authorized Suite & Loge Licensee and three (3) companions to attend one (1) lunch and one (1) tour of the Raiders Practice Facility to be taken between January 1<sup>st</sup>, 2025, and December 31<sup>st</sup>, 2025. All details, including the date of the Lunch and Tour, are to be decided in the Sponsor's sole discretion.

### **3. GIFT CONDITIONS.**

3.1. No more than three (3) Gifts awarded per authorized Suite & Loge Licensee. The awarding of all Gifts is subject to verification by Sponsor, whose decisions are final. Gifts cannot be transferred, redeemed for cash or substituted by recipient. All federal, state, provincial and local taxes, and all costs and expenses, related to the acceptance or use of the Gift, and not specified herein as being provided, are the sole responsibility of the recipient. Any required tax reporting forms will be furnished to the appropriate authorities. Sponsor reserves the right in its sole and absolute discretion to award a substitute Gift of equal or greater estimated value if a Gift described in these Rules is unavailable or cannot be awarded, in whole or in part, for any reason. That determination is final and binding and cannot be appealed. Sponsor makes no representation or warranty concerning the appearance, safety or performance of any Gift awarded.

3.2. All Gifts may be claimed in and shipped to an address in the 50 United States and/or the District of Columbia, except in Sponsor's sole and absolute discretion. All Gifts may be delivered by regular mail, United Postal Service or courier such as Federal Express or any other delivery method at Sponsor's sole and absolute discretion. Sponsor estimates that Gift delivery will take approximately 6-8 weeks for delivery after verification. Sponsor is not responsible for and will not replace any lost, mutilated or stolen Gifts. Sponsor assumes no liability for non-deliverability.

3.3. In the event that the Giveaway is cancelled or postponed by Sponsor for any reason whatsoever, the Gifts shall not be awarded except and solely to the extent decided by Sponsor in its sole and absolute discretion or as otherwise required by law. Sponsor shall have no responsibility or obligation to anyone who is unable or unavailable to, or who does not for any reason, accept or

utilize the Gift. In the event of non-compliance with these Official Rules, or if the Gift is unclaimed, the Gift will be forfeited.

- 3.4. Gift Cards are subject to additional cardholder terms and conditions imposed by issuer. No credit or cash will be returned or refunds issued if the full value of a Gift Cards has not been used by its respective expiration date, if any. Gift Card Gifts will not be replaced if lost or stolen but Sponsor may, in its sole and absolute discretion, replace a lost, stolen or malfunctioning card. In no event will a Gift Card's value exceed its stated value.

By participating in this Giveaway or accepting a Gift, a Suite & Loge Licensee further acknowledges and agrees to the following Gift restrictions: a Suite & Loge Licensee and his or her companion must follow all instructions of Sponsor and/or the NFL relative to the Gift and any element thereof. In the event a Suite & Loge Licensee or his or her travel companion engages in behavior that, as determined by Sponsor at its sole discretion, is obnoxious or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to terminate the Gift or other applicable experience early, in whole or in part.
- 3.7. Nonmonetary Gifts such as tours, trips, experiences, game tickets, club tickets, or other Gifts must be taken or utilized on date specified by Sponsor or the applicable Gift will be forfeited and Sponsor will have no further obligation to the Suite & Loge Licensee. Sponsor reserves right to change dates. The Suite & Loge Licensee is responsible for all other costs and expenses not expressly stated in the Official Rules, including without limitation, incidentals and transportation. Suite & Loge Licensees and their companions are subject to all Allegiant Stadium, other NFL venue, and Sponsor rules, procedures, and code of conduct when participating in any Gift experience, and the failure to comply with such policies may result in forfeiture of such portion of Gift.
- 3.8. Sponsor reserves the right to require Suite & Loge Licensees and their companions to complete and execute Sponsor's standard indemnity/waiver agreement prior to participating in the experiences.
- 3.9. Gifts will be awarded to the authorized Suite & Loge Licensee. In the event of a dispute regarding the identity of the authorized Suite & Loge Licensee, the authorized subscriber of the email for the Suite & Loge Licensee account at the time of payment of License Fee will be deemed to be the Suite & Loge Licensee and must comply with these Rules. Authorized account subscriber is the natural person who is assigned the email address for the Suite & Loge Licensee account, by the Internet Service Provider ("ISP"), on-line service provider, or other organization responsible for assigning the Suite & Loge Licensee account in question

#### **4. NOTIFICATION OF GIFT AWARD.**

- 4.1. Within twenty-one (21) days of the conclusion of each respective payment time period noted in Section 2 above, Sponsor will contact the Suite & Loge Licensees who submitted payment during that time period at the email address associated with the Suite & Loge Licensee Account. If the

Suite & Loge Licensee fails to respond to the verification email within seven (7) days of notification or the email notification is returned as undeliverable after two (2) attempts, the Suite & Loge Licensee may be deemed to have forfeited the Gift. All Suite & Loge Licensees are subject to verification of eligibility and compliance with the terms of these Official Rules, prior to being awarded a Gift.

- 4.2. Sponsor is not responsible for any delay or failure to receive notification for any reason, including inactive account(s), technical difficulties associated therewith, or a Suite & Loge Licensee's failure to adequately monitor their email. Suite & Loge Licensees may be required to sign and return an affidavit or declaration of eligibility and release of liability, and a publicity release (collectively the "**Gift Claim Documents**"). Further, the Suite & Loge Licensees may also be required to complete and file an IRS Form 1099 or W-9 with the Internal Revenue Service and/ or provide their Social Security number or tax ID for tax reporting purposes if Sponsor is required to file an IRS Form 1099 or W-9 with the Internal Revenue Service for the fair market value of a Gift awarded and accepted. Suite & Loge Licensees hereby waive any claims that they may have or acquire against the Sponsor for libel, slander, invasion of privacy, copyright or trademark violation, moral rights, right of publicity, rights of privacy, or false light arising out of or in connection with such use. Suite & Loge Licensees agree that this is a waiver of privacy rights and constitutes a valid consent to uses of any PII as may be required under applicable data protection laws. Any PII that You provide in participating in the Giveaway is subject to the privacy policies of the Sponsor. Please review the Sponsor privacy policy at [Raiders Privacy Policy](#). By entering the Giveaway, You grant Sponsor permission to share Your email address and any other PII with the other Gift partners for the purpose of administration and Gift fulfillment. Suite & Loge Licensees, by acceptance of Gift, except where legally prohibited, grant permission for Sponsor and its designees to use his/her name, address (city and state), photograph, voice and other likeness and Gift information for advertising, trade and promotional purposes without further compensation, in all media (including digital media) now known or hereafter discovered, worldwide in perpetuity, without notice or review or approval.
- 5.2. YOU ACKNOWLEDGE AND AGREE, WHEN APPLICABLE THAT YOU HAVE READ AND CONSENT TO SPONSOR'S PRIVACY POLICY. YOU FURTHER ACKNOWLEDGE THAT YOUR PII MAY BE DISCLOSED TO THIRD PARTIES.

## **6. GENERAL CONDITIONS.**

Released Parties (as defined below) are not responsible for failure to send, lost, late, incomplete, inaccurate, stolen, misdirected, undelivered, or for any failed payments of Your License Fee for Your

respective Suite & Loge Licensee account; or for lost, interrupted or unavailable network, server, Internet Service Provider (“ISP”), websites, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Giveaway, including, without limitation, errors or difficulties which may occur in connection with the administration of the Giveaway, the processing of payment, the awarding of Gifts or in any Giveaway-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by other Suite & Loge Licensees or third parties, tampering, hacking, or by any equipment or programming associated with or utilized in the Giveaway.
