

2024 CHICAGO BEARS TICKETMASTER PLAZA AUGMENTED REALITY (“AR”) STATUES SWEEPSTAKES

September 8, 2024 – November 25, 2024

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE

A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. HOW TO ENTER: The 2024 Chicago Bears Ticketmaster Plaza AR Statues Sweepstakes (the “Sweepstakes”) starts September 8, 2024 at 10:00AM Central Time (“CT”) and ends on November 25, 2024 at 11:59PM CT (“Entry Period”). You may enter the Sweepstakes by doing the following: visit the Ticketmaster Plaza at Gate “0” and scan the QR code next to the George Halas and Walter Payton statues (each a “Statue” and collectively the “Statues”) and watch the hologram presentation. At the end of the presentation a link will be provided to an “Entry Form” to enter the Sweepstakes. Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different addresses, and /or any other methods will void that Entrant’s entries and that Entrant may be disqualified from the Sweepstakes. Entries submitted by anyone other than the Entrant are void. The Sponsor will verify receipt of entries for Entrants. All entries submitted become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, damaged or postage-due mailed entries.

Limit one (1) entry per person during the Entry Period.

2. ELIGIBILITY: The Sweepstakes is open to (a) all residents of the United States (excluding residents of Florida, New York, and Rhode Island), and (b) who are at least 18 years of age as of the date of entry. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc. (“Sponsor”), Ticketmaster L.L.C. (“Ticketmaster”), and their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, advertising and promotion agencies, and their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, half-sister) and/or those living in the same household of each are not eligible. All federal, state and local laws and regulations apply. Void where prohibited by law.

3. AGREEMENT TO RULES: By participating in the Sweepstakes, you (a) agree to be fully and unconditionally bound by these Rules, which constitute a contract, (b) represent and warrant that you meet the eligibility requirements set forth herein, and (c) agree that the decisions of the Sponsor shall be final and binding in all respects.

4. SELECTION OF WINNER: On or about November 26, 2024, four (4) “Grand Prize Winners” will be selected in a random drawing from all the eligible entries received during the Entry Period and each winner will be eligible to receive the following (collectively, the “Grand Prize”):

(a) Eight (8) suite tickets for the Grand Prize Winner and seven (7) guests (“Guests”) to the Chicago Bears vs. Seattle Seahawks regular season home game to be

played at Soldier Field on December 26, 2024 (the “Game”) which includes food and non-alcoholic beverages; and,

(b) Two (2) parking passes to the Game;

One the day after each regularly scheduled home game played at Soldier Field during the Entry Period, one (1) “First Prize Winner” will be selected in a random drawing at noon (12:00PM CT) from among all eligible entries received to date for a Chicago Bears autographed item (collectively, the “First Prize”). There will be a total of six (6) First Prize Winners. Odds of winning any prize depend upon the number of eligible entries received to date. There will be no random drawing following the Chicago Bears’ international game, scheduled for October 13, 2024. First Prize Winners remain eligible to win the Grand Prize.

Grand Prize Winners and First Prize Winners are collectively referred to as “Prize Winners”.

Grand Prize and First Prize are collectively referred to as (“Prize”).

Total ARV of Prize is \$24,680.00 Sponsor reserves the right to substitute Prize with another of equal value should any unforeseen circumstances occur. All state, federal, and local taxes or other expenses not specified herein are the sole responsibility of the Prize Winners, including transportation to and from Game. No Prize substitutions or cash redemption will be made except in Sponsor’s sole discretion. Sponsor will arrange electronic transfer of all Game tickets and parking passes to each Grand Prize Winner at the email address provided by each Grand Prize Winner, respectively. Sponsor will mail First Prize to each First Prize Winner to the address provided by the First Prize Winner. Sponsor will be responsible for all mailing costs.

6. 8. PUBLICITY RELEASE: Except where prohibited by law, by participating in the Sweepstakes, each entrant irrevocably grants the Released Parties the right to use each such entrant's name, photograph, image, video, and biographical information, in any and all media for any purpose, including, without limitation, advertising and promotional purposes, without additional compensation and each entrant hereby releases the Released Parties from any liability with respect thereto, except where prohibited.

All entrants, as a condition of entry, agree to abide by and be bound by these Official Rules and the decisions of Sponsor.
