HOW TO ENTER: The 2024 Chicago Bears Ticketmaster Plaza AR Statues Sweepstakes (the "Sweepstakes") starts September 8, 2024 at 10:00AM Central Time ("CT") and ends on November 25, 2024 at 11:59PM CT ("Entry Period"). You may enter the Sweepstakes by doing the following: visit the Ticketmaster Plaza at Gate "0" and scan the QR code next to the George Halas and Walter Payton statues (each a "Statue" and collectively the "Statues") and watch the hologram presentation. At the end of the presentation a link will be provided to an "Entry Form" to enter the Sweepstakes. Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different addresses, and /or any other methods will void that Entrant's entries and that Entrant may be disqualified from the Sweepstakes. Entries submitted by anyone other than the Entrant are void. The Sponsor will verify receipt of entries for Entrants. All entries submitted become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, damaged or postage-due mailed entries.

Limit one (1) entry per person during the Entry Period.

- **2.
