

Raiders On Location Sweepstakes Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

Raiders Football Club, LLC (“Sponsor”) is pleased to introduce the Raiders On Location Sweepstakes (“Sweepstakes”). The Sweepstakes entry period begins today at the start time of this event (“Event”) and ends today when the Raiders On Location experience ends (the “Sweepstakes Entry Period”). Pacific Time shall control for all purposes of the Sweepstakes. Sponsor’s computer shall be the official clock for purposes of the Sweepstakes.

As a legal requirement for participating in this Sweepstakes as an entrant (“Entrant” or “You”), You hereby agree to be bound by these Sweepstakes Rules (the “Official Rules” or “Rules”) whose decisions shall be final and binding in all respects, and to waive any right to claim ambiguity in the Sweepstakes, these Official Rules, and the corresponding Sweepstakes materials. These Official Rules form a legal contract by and between You and Sponsor. If You do not agree and consent to these Rules, please do not enter the Sweepstakes. The Sweepstakes is subject to applicable federal, state, and local laws and regulations and is **VOID WHERE PROHIBITED OR RESTRICTED BY LAW**. Winning and receiving a Prize (as defined in Section 6) is contingent upon fulfilling all requirements set forth herein.

1. ELIGIBILITY.

The Sweepstakes is open only to natural persons who: (i) are attendees of the Event during the Sweepstakes Entry Period; (ii) are legal residents of the fifty (50) United States or the District of Columbia and are at least eighteen (18) years of age at the time of entry; (iii) are not barred from participation in the Sweepstakes under the laws of the United States, including but not limited to all federal, state, and local laws and regulations; and (iv) at all times abide by these Official Rules. Proof of age and eligibility may be required.

Sponsor, its parents, subsidiaries, affiliates, distributors, retailers, sales representatives, Sweepstakes administrator, advertising and promotion agencies; and each of their respective officers, directors, employees, consultants and contractors (the “Sponsor Entities”), as well as their immediate family and household members are ineligible to enter the Sweepstakes or win any related Prize. “Household Members” means those people who share the same residence as any Sponsor Entity for at least three (3) months during a given year. “Immediate Family Members” means parents, step-parents, legal guardians, children, step-children, siblings, step-siblings or spouses of any Sponsor Entity. Household Members and Immediate Family Members of any Sponsor Entities are also not eligible to enter or win the Sweepstakes.

2. HOW TO ENTER.

During the Sweepstakes Entry Period, eligible persons may enter this Sweepstakes by:

- A. Visiting Sponsor’s booth (the “Raiders Booth”) at the Event;
- B. Obtaining a free entry form;
- C. Completing the entry form as directed; and
- D. Manually submitting the entry form at the Raiders Booth.

Entry forms for the Sweepstakes can be found at the Raiders Booth. The entry form must be manually submitted at the Raiders Booth during the Sweepstakes Entry Period. While entry is completely free, You may be required to provide some or all of the following information: your name, address, city, state, zip code, telephone number, date of birth, and email address for purposes of administering the Sweepstakes.

Limit one (1) entry per person. If an Entrant submits more than one (1) entry, Sponsor reserves the right to void all such entries at its sole and absolute discretion. A valid entry will be entered into the Drawing (as defined in Section 4). Attempting to subvert the Sweepstakes entry process is prohibited and may

result in disqualification. In the event of a dispute over who submitted a winning entry, the Authorized Account Holder for the email address associated with the entry will be deemed to be the Entrant. The Authorized Account Holder is defined as the natural person that has established the corresponding account with the respective platform. No photocopied or mechanically reproduced entries will be accepted. Illegible, incomplete and duplicate entries will be disqualified.

Sponsor is not responsible for an Entrant failing to submit the entry form or for any incorrect or inaccurate transcription of entry information, computer, online or human error, technical malfunctions, any omission, interruption, defect, or any other error, including, without limitation, lost, late, incomplete, invalid, unintelligible or misdirected entries, all of which may constitute grounds for disqualification in Sponsor's sole discretion. If a problem occurs in the entry process, the Entrant is solely responsible for verifying that the entry process has been validly completed. Sponsor shall have no obligation to advise You of an incomplete, late or undeliverable entry. All entries become the sole and exclusive property of Sponsor and will not be acknowledged or returned. Entrant is responsible for all online charges incurred with any Internet service provider and/or wireless carrier.

3. WINNER SELECTION AND ODDS OF WINNING.

On or about thirty (30) days following the conclusion of the Event, Sponsor will conduct one (1) random drawings. The random drawing will be from among all eligible entries from the Sweepstakes Entry Period (each, a "Drawing") to select the one (1) potential winner ("Potential Winner") for the Prize, subject to verification of eligibility requirements.

Odds of winning a Prize depend on the number of eligible entries received during the Sweepstakes Entry Period for the Drawing. No more than the stated number of Prizes will be awarded.

4. WINNER NOTIFICATION AND VERIFICATION.

Within two (2) weeks after the conclusion of the Drawing, the Potential Winner will be contacted via email on the account noted on the entry form in which they entered and won. The Potential Winner will be awarded the applicable Prize subject to verification of eligibility and compliance with all terms and conditions of these Official Rules. If the Potential Winner fails to respond to the direct message within seventy-two (72) hours of notification or the direct message is returned as undeliverable after two (2) attempts, the Potential Winner may be disqualified in Sponsor's sole and absolute discretion. Winners will be required to provide proof of their government identification to verify their age.

Winner also may be required to provide their Social Security number or tax ID for tax reporting purposes if Sponsor is required to file an IRS Form 1099 with the Internal Revenue Service for the fair market value of a Prize awarded and accepted. Except where prohibited, Potential Winner also may be required to sign and return to Sponsor, within five (5) business days from the date when Sponsor's initial verification email was sent, an affidavit eligibility and release of liability, and a publicity release ("Affidavit") via email to the address specified in the Affidavit to claim his or her Prize. If Potential Winner fails to complete, sign and return the applicable Affidavit within the required time period, or if the Affidavit is returned as undeliverable or incomplete, the Potential Winner may be disqualified in Sponsor's sole and absolute discretion. Further, the Potential Winner may also be required to complete and file an IRS Form 1099 or W-9 with the Internal Revenue Service and/ or provide their Social Security number or tax ID for tax reporting purposes if Sponsor is required to file an IRS Form 1099 or W-9 with the Internal Revenue Service for the fair market value of a Prize awarded and accepted. In the case of Prizes that include guests, the potential Winner understands and agrees that, as a condition of participation in the Prize, guests may be required to sign and return a similar release of liability and a publicity release that grants Sponsor the same permissions for use of their names, likenesses and other information as set out in Section 8 below, and that refusal to sign those releases may result in guest being denied the ability to participate in the Prize. No substitution or transfer of a Prize is permitted except by Sponsor.

In the event Potential Winner is disqualified for any reason, or if a Prize is unclaimed, the Prize will be forfeited. Sponsor, at its sole and absolute discretion, may award the forfeited Prize to an alternate Potential Winner by random drawing from among all remaining eligible entries from the Sponsorship Entry Period. Within seventy-two (72) hours of the secondary drawing, alternate Potential Winner(s) will be

contacted via direct message in the same email address in which they won, by contacting the same email address affiliated with the winning entry. If the alternate Potential Winner(s) fails to respond to the direct message within seventy-two (72) hours of notification or the email notification is returned as undeliverable after two (2) attempts, the alternate Potential Winner may be disqualified in Sponsor's sole and absolute discretion. Sponsor retains the right to repeat this process until an alternate Potential Winner complies with the verification of eligibility requirements. If, after a second good-faith attempt, Sponsor is unable to award or deliver a Prize, the Prize may not be re-awarded.

ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR. SPONSOR'S DECISIONS AS TO THE ADMINISTRATION AND OPERATION OF THE SWEEPSTAKES, ANY CHANGES TO THESE OFFICIAL RULES, AND THE SELECTION OF POTENTIAL WINNERS IS FINAL AND BINDING IN ALL MATTERS RELATED TO THE SWEEPSTAKES.

5. PRIZE.

Subject to verification of eligibility and compliance with the Official Rules, there will be one (1) Potential Winner. Only the stated Prize below that will be given.

A. Signed Memorabilia Item

At the conclusion of Sweepstakes Entry Period, subject to verification and Sponsor's discretion, one (1) winner will win one (1) signed Raiders memorabilia item ("Memorabilia Item"). The approximate retail value ("ARV") for the prize is \$200 ("Prize").

The ARV is a reasonable estimate based on the time these Official Rules were drafted. If the actual retail value of the Prize is less than or greater than the stated ARV, the Prize winner will not receive the difference.

ALL FEDERAL, STATE, AND LOCAL TAXES AND FEES ARE THE SOLE RESPONSIBILITY OF THE PRIZE WINNERS. ALL OTHER COSTS AND EXPENSES RELATED TO ANY PRIZE NOT SPECIFIED HEREIN AND OTHER EXPENSES INCURRED BY ACCEPTING THE PRIZE ARE ALSO THE SOLE RESPONSIBILITY OF THE WINNER. No more than one (1) Prize will be awarded per person. All Potential Winners are subject to verification by Sponsor, whose decisions are final. Prizes cannot be transferred, redeemed for cash or substituted by an Entrant. All federal, state, and local taxes, and all costs and expenses related to the acceptance and use of the Prize not specified herein as being provided, are the sole responsibility of the Winner. Any required tax reporting forms will be furnished to the appropriate authorities. Sponsor reserves the right in its sole and absolute discretion to award a substitute Prize of equal or greater estimated value if a Prize described in these Rules is unavailable or cannot be awarded, in whole or in part, for any reason. That determination is final and binding, and cannot be appealed. Sponsor makes no representation or warranty concerning the appearance, safety or performance of any Prize awarded.

Sponsor reserves the right to determine if and how Prizes will be delivered to any Potential Winner. All Prizes may be claimed in and shipped to an address in the 50 United States and/or the District of Columbia, except in Sponsor's sole and absolute discretion. Prizes may be delivered to the Winner by regular mail, United Postal Service or courier such as Federal Express or any other delivery method at Sponsor's discretion. Type of delivery service will be at sole and absolute discretion of Sponsor.

Please allow 6-8 weeks for delivery. Sponsor is not responsible for and will not replace any lost, mutilated or stolen Prizes. Sponsor assumes no liability for non-deliverability.

In the event that the Sweepstakes is cancelled or postponed by Sponsor for any reason whatsoever, the ARV of the Prizes will be awarded to the extent required by law. Sponsor shall have no responsibility or obligation to a Potential Winner who is unable or unavailable to, or who does not for any reason, accept or utilize the Prize. In the event of non-compliance with these Official Rules, or if the Prize is unclaimed, the Prize will be forfeited. A forfeited Prize may be awarded to an alternate winner, at Sponsor's sole discretion.

If applicable, Gift Card Prizes are subject to additional cardholder terms and conditions imposed by issuer. No credit or cash will be returned or refunds issued if the full value of a Gift Card Prize has not been used by its respective expiration date, if any. By participating in this Sweepstakes and/or accepting a Prize, Entrants further acknowledge and agree to the following Prize restrictions: Potential Winner and his or her companion must follow all instructions of Sponsor relative to the Prize or any Prize and any element thereof. A Prize winner is subject to all Allegiant Stadium and Sponsor rules, procedures, and code of conduct when participating in the Field Experience or Tour, and Sponsor reserves the right to require all Prize participants to complete and execute Sponsor's standard indemnity/waiver agreement prior to participating in the Field Experience or Tour or any portion of the applicable Prize. The Field Experience will provide an opportunity to Prize participants to watch warmups from the field, but prior to the game starting, the Prize participants will return to their assigned seat. All federal, state and local taxes and all other costs associated with Prize acceptance and use not specified herein as being provided are the sole responsibility of the Potential Winner.

ALL PRIZES ARE AWARDED AS IS AND WITHOUT WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. SOME JURISDICTIONS MAY NOT ALLOW (OR MAY LIMIT) DISCLAIMERS OF CERTAIN WARRANTIES, IN WHICH CASE THE FOREGOING DISCLAIMERS WILL BE ENFORCED TO THE MAXIMUM EXTENT PERMITTED BY LAW.

7. ENTRY CONDITION AND RELEASE.

By entering, Entrant agrees to: (a) comply with and be bound by these Official Rules and the decisions of Sponsor as they may be amended from time to time and (b) release, indemnify, defend, and hold harmless Sponsor, LV Stadium Events Company, LLC, The Raider Image, LLC, LVR Real Property, LLC, The Oakland Raiders, a California limited partnership, Raiders Foundation NV, Clark County Stadium Authority, each of their respective parents, subsidiaries, affiliates, suppliers, retailers, distributors, advertising and promotion agencies, and each of their respective past and present officers, directors, employees, agents,

shareholders, contractors, representatives and successors, and the NFL Entities (defined below)(collectively, the “Released Parties”) from and against any and all claims, expenses, and liability resulting or arising from the Sweepstakes (including reasonable attorneys’ fees), including, but not limited to, negligence and damages of any kind to persons and property, invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright, or other intellectual property rights, property damage, or death or personal injury arising out of or relating to the entry, creation of an entry or submission of an entry, participation in the Sweepstakes, acceptance, use, or misuse of a Prize, or the broadcast, exploitation, or use of an entry. By participating in this Sweepstakes and/or accepting a Prize, Entrant also acknowledges they will be sharing their personal information with Sponsor. In addition, Entrant agrees to Sponsor’s use of an Entrant’s personal information as described in its respective Privacy Policy. Please refer to Sponsor’s Privacy Policy, available at [Raiders Privacy Policy](#) for important information regarding our collection, use and disclosure of personal information. Sponsor is not responsible for disclosures made by any third party. By entering the Sweepstakes, Entrant grants Sponsor permission to share their email address and any other PII with the other Sweepstakes partners for the purpose of administration and prize fulfillment, including use in a publicly available winners list. Potential Winner, by acceptance of Prize, except where legally prohibited, grants permission for Sponsor and its designees to use his/her name, address (city and state), photograph, voice, statements, biographical information, testimonials, personal story, voice, address, and other identifying information for any and all commercial purposes of the Sponsor, including, without limitation, advertising and promotional purposes for this and similar promotions, worldwide, and in perpetuity, in any and all forms of media, now known or hereafter devised without additional compensation, review or approval rights, notification or permission, now known or hereafter discovered, worldwide in perpetuity, without notice or review or approval.

9. INTELLECTUAL PROPERTY OWNERSHIP.

exhibit, broadcast, use, reproduce, distribute, perform and license others to use all or any part of the Content; (ii) edit or modify the Content in any manner, or combine same with any other materials; and (iii) use and license third parties to use the Content and/or any portion thereof in any manner of exploitation and, in the case of (i), (ii) or (iii), in any digital, print or other medium whether now known or hereafter discovered, worldwide and in perpetuity with no obligation of further consideration or of notice, review or approval.

10. GENERAL CONDITIONS.

The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Winning a Prize is contingent upon accepting these Official Rules and fulfilling all requirements of these Official Rules. Sponsor also reserves the right to disqualify any individual it finds to be tampering or interfering with the operation of the Sweepstakes, acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner and void such individual's entry.

Except where prohibited by law, as a condition of participating in this Sweepstakes, Entrant agrees to the following: any and all disputes and causes of action arising out of or connected with this Sweepstakes, or any Prizes awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration before Private Trials in Clark County, Nevada. Unless otherwise specified in these Official Rules, words importing the singular include the plural and vice versa and words importing gender include all genders. All dollar amounts referred to in these Official Rules are in lawful money of the United States of America. The Released Parties are not responsible for any damages caused by delay or failure to perform undertakings pursuant to these Official Rules when the delay or failure is due to weather, event cancellations, fires, strikes, floods, pandemics, acts of God or the state's enemies, lawful acts of public authorities, delays or defaults caused by common carriers, or other events that cannot reasonably be foreseen or provided against.

14. OFFICIAL RULES AND WINNERS LIST.

A complete copy of these Official Rules can be obtained at the Event on the entry device or by sending a self-addressed, stamped envelope to the offices of Sponsor at 1475 Raiders Way, Henderson, NV, 89052 or emailing a request to Sweepstakes@raiders.com. Requests must include the date of the Event. Request must be received no later than two (2) years following the date of the Event.

15. SEVERABILITY/WAIVER.

The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. The Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision.
