## Carolina Panthers Ticket Sweepstakes Official Rules

## NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASING A SINGLE GAME TICKET WILL NOT INCREASE YOUR CHANCE OF WINNING

- 1) Eligibility: The Carolina Panthers Ticket Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent U.S. residents, eighteen (18) years of age or older (hereafter, "Eligible Entrants").
