

**2024 ROAD GAME GETAWAY WITH
GEICO SWEEPSTAKES OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Eligibility

Sweepstakes is offered only in the United States to legal residents of Pennsylvania, Delaware, and New Jersey who are eighteen (18) years of age or older as of the date of entry. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (the “Eagles”), Government Employees Insurance Company (“GEICO”), and any of their respective agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize. 2. Sweepstakes Period

Sweepstakes period begins on Monday, October 28, 2024 at 12:00:00 a.m. Eastern Time (“ET”) and ends on Sunday, December 22, 2024 at 11:59:59 p.m. ET (the “Sweepstakes Period”).

3. Entry

You may enter by going to <https://forms.philadelphiaeagles.com/f/geico-road-game-getaway>, clicking on the icon to access the entry form during the Sweepstakes Period and entering your, name, address (no P.O. Boxes accepted), e-mail address, and confirming that you are 18 years of age or older and agree to the Official Rules. Entrants may optionally provide an answer to the following question, which has no bearing on an entrant’s chances of winning: Do you have a favorite Eagles away game memory or road trip story that you would like to share? Upon completing the entry method, and subject to the conditions below, you will automatically be entered into the Sweepstakes. Proof of entry submission does not equate to proof of receipt. 4. Drawing

For each Weekly Entry Period, one (1) random drawing will be held on the drawing date specified below from among all eligible entries received for the corresponding Weekly Entry Period and will be conducted by a representative of the Eagles for the Weekly Prizes. Winner of the drawing will be notified by email within approximately two (2) business days of the drawing. If, after two (2) attempts, contact has not been made, prize will be forfeited, and an alternate winner may be randomly selected from the eligible entries received during the Sweepstakes Period. 5. Prize/Odds
