## "2024 LEXUS EXPERIENCE AMAZING SWEEPSTAKES" OFFICIAL RULES ("Official Rules")

Then, check the boxes indicating you are at least twenty one (21) years of age and agree to these Official Rules and click the "Submit" button to receive one (1) entry into the Sweepstakes.

In order to be eligible and receive your entry into the Sweepstakes, you must complete the entire Entry Form, indicate you are over the age of twenty one (21), comply with the Eligibility requirements, agree to the Official Rules as provided herein, answer any questions and click "Submit". Products or any other element received as a prize may not be resold, auctioned, bartered, or placed into any other unauthorized channels of distribution.
