

Las Vegas Raiders 2026-2027 Suite & Loge Sweepstakes Rules

Welcome to the 2026 Suite & Loge Sweepstakes (the “**Sweepstakes**”), sponsored by Raiders Football Club, LLC (“**Sponsor**”). **PLEASE READ THESE SWEEPSTAKES RULES CAREFULLY BEFORE ENTERING INTO THE SWEEPSTAKES.**

THERE IS NO PURCHASE OR PAYMENT NECESSARY IN ORDER TO ENTER OR WIN THE SWEEPSTAKES. ANY PURCHASE OR PAYMENT OF ANY KIND THAT YOU MAKE WILL NOT INCREASE YOUR CHANCES OF WINNING. THE SWEEPSTAKES IS SUBJECT TO ALL APPLICABLE FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS, AND IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

This Sweepstakes is powered and administered by Wit Labs, Inc. (“**Wit**” or the “**Administrator**”) on behalf of Sponsor and is accessible via the Wit website at <https://web.witcontests.com/raiders/sweepstakes/win/raiders-suite-and-loge-250905> (the “**Platform**”). For the avoidance of doubt, Wit administers and provides the Platform for the Sweepstakes, but is not the sponsor for the Sweepstakes. As a legal requirement for participating in this Sweepstakes as an entrant (“**Entrant**” or “**You**”), You hereby agree to be bound by these Sweepstakes Rules (the “**Official Rules**” or “**Rules**”) which form a legal contract by and between You and Sponsor. If You do not agree and consent to these Rules, please do not enter the Sweepstakes or use the Platform. To participate in the Sweepstakes, You must agree to read and abide by the Wit [Terms of Use](#). The Sweepstakes is subject to applicable federal, state, provincial, municipal, territorial, and local laws and regulations and is **VOID WHERE PROHIBITED OR RESTRICTED BY LAW**. Winning and receiving a Grand Prize (as defined in Section 3.1) is contingent upon fulfilling all requirements set forth herein.

1. SWEEPSTAKES.

- 1.1. Sweepstakes Description. Entrant agrees to prepare and submit the required entry form for the Sweepstakes (an “**Entry**,” collectively the “**Entries**”) in accordance with the Official Rules as described herein. After submission, Entrant may or may not be deemed a Winner (as defined in Section 3.1) subject to eligibility and compliance with these Rules. Grand Prizes will be awarded for this Sweepstakes and will be publicly displayed on the Sweepstakes Landing Page (as defined in Section 5.1).
- 1.2. Sweepstakes Period. The Sweepstakes start date is September 5th, 2025, at 12:01 am Pacific Daylight Time (“**PDT**”). The Sweepstakes end date is February 6th, 2026, at 11:59 pm Pacific Standard Time (“**PST**”). The Sweepstakes will begin on the above start date and will last through the above end date (“**Sweepstakes Period**”). The Sweepstakes Period is comprised of three (3) entry periods (respectively, “**Entry Period 1**”, “**Entry Period 2**”, and “**Entry Period 3**”) as listed in the table below (each an “**Entry Period**”). Pacific Daylight Time and Pacific Standard Time, as applicable, shall control for all purposes of the Sweepstakes. Wit’s computer shall be the official clock for purposes of the Sweepstakes.

1.3. Rules. By participating in the Sweepstakes, Entrant unconditionally accepts and agrees to comply with and abide by these Rules, waives any right to claim ambiguity in the Rules or Sweepstakes related advertising/materials and agrees that the decisions of Wit or Sponsor with respect to the Sweepstakes and any Grand Prizes shall be final and binding in all respects. Sponsor reserves the right to alter the terms of these Official Rules at their discretion. Any such changes to the Official Rules will be prominently displayed and any conflicting changes to the Official Rules will be superseded by the most recent version of the Official Rules.

1.4. Sweepstakes Administration. Wit, on behalf of Sponsor, performs the collection, submission or processing of Entries, notification of Winners, as well as the overall administration of the Sweepstakes. Entrant may contact Wit with any questions, comments or problems related to administration of the Sweepstakes. Wit may be reached by email at raiders@witcontests.com during the Sweepstakes Period.

2. ELIGIBILITY.

2.1. Eligible Entrants. The Sweepstakes is open only to: (i) legal residents of all states in the United States, except for New York, Florida, and Rhode Island, who are of 21 years of age or older as of the date of entry; (ii) who are not a person barred from participation in the Sweepstakes; and (iii) who at all times abide by these Official Rules. Individuals may be asked to provide documentation verifying eligibility.

2.2. Non-eligible Persons. Sponsor, its parents, subsidiaries, affiliates, distributors, retailers, sales representatives, Sweepstakes administrator, advertising and promotion agencies; and each of their respective officers, directors, employees, consultants and contractors (the “**Sponsor Entities**”), are ineligible to enter the Sweepstakes or win any related prize. “**Household Members**” means those people who share the same residence as any Sponsor Entity for at least three (3) months during a given year. “**Immediate Family Members**” means parents, step-parents, legal guardians, children, step-children, siblings, step-siblings or spouses of any Sponsor Entity. Household Members and Immediate Family Members of any Sponsor Entities are also not eligible to enter or win the Sweepstakes.

3. PRIZES AND ODDS OF WINNING.

3.1. Grand Prizes Awarded. Subject to verification of eligibility and compliance with the Official Rules, there will be eight (8) winners for the Grand Prize (each a “**Winner**,” collectively the “**Winners**”) in the Sweepstakes. Grand Prizes available depend on the Entry Period in which the

Entry was received. The potential Winners for Entry Period 1, Entry Period 2, and Entry Period 3 will be randomly selected from all eligible Entries for that Entry Period on or about December 8th, 2025, January 7th, 2026, and February 9th, 2026, respectively, after the conclusion of each of the Entry Periods, as listed below. Potential Winners will be selected via random drawing, in sequential order as listed in Section 3.2 below, starting with the first Grand Prize referenced in the corresponding section, for the following items (each individually a “**Grand Prize**” and collectively referred to as the “**Grand Prize(s)**”):

3.2. Grand Prizes. There will be eight (8) Grand Prizes awarded consisting of:

3.2.1. Entry Period 1: To win any of the following Grand Prizes, You must (i) enter by the end date of Entry Period 1 of December 5th, 2025, and (ii) if You are submitting an Entry via digital method of entry pursuant to Section 5.1, You must pay for Your 2026-2027 License Fee (as defined in Section 5.1) on or before November 28th, 2025, at 11:59 pm PST.

3.2.1.1. One (1) Winner will receive a trip for two (2) (to be used by Winner and one (1) companion) to Super Bowl LX (“**Super Bowl Experience**”). Trip includes two (2) game tickets, coach class travel from within the continental United States to and from the Super Bowl city location and two (2) night accommodation in one (1) room. All travel and accommodation details, including but not limited to, airline travel, hotel accommodations, etc. shall be determined in Sponsor’s sole and absolute discretion. All other costs not described herein are the responsibility of Winner. The approximate retail value (“**ARV**”) of the Super Bowl Experience is \$10,000.

3.2.1.2. One (1) Winner will receive one (1) club suite to be used by Winner and eleven (11) companions for a third-party event at Allegiant Stadium held between January 1, 2026, and December 31, 2026 (“**Club Suite Experience**”). The third-party event will not include a Raiders game and will be selected by Sponsor in its sole and absolute discretion. The Club Suite Experience will include a food and beverage package to be determined by Sponsor. Any additional money spent and all taxes, gratuity, fees, or all

other costs not described herein are the responsibility of Winner. The ARV of the Club Suite Experience is \$15,000.

3.2.1.3. One (1) winner will receive one (1) experience for two (2) people (to be used by Winner and one (1) companion) to attend the 2026 NFL Draft with Inner Circle invitation ("**Draft Inner Circle Experience**"). The Draft Inner Circle Experience will consist of two (2) tickets to the 2026 NFL Draft with Inner Circle invitation, coach class travel for two (2) from within the continental United States to and from the Draft Inner Circle Experience city, and hotel accommodations for two (2). Exact dates, number of nights, and all other details shall be determined in Sponsor's sole and absolute discretion. All other costs not described herein are the responsibility of Winner. The ARV of the Draft Inner Circle Experience is \$6,000.

3.2.2. Entry Period 2: To win any of the following Grand Prizes, You must: (i) enter by the end date of Entry Period 2 of January 6th, 2026, and (ii) if You are submitting an Entry via digital method of entry pursuant to Section 5.1, You must pay for Your 2026-2027 License Fee on or before December 30th, 2025, at 11:59 pm PST.

3.2.2.1. One (1) Winner will receive one (1) experience for two (2) people (to be used by Winner and one (1) companion) to attend one (1) Raiders away game during the 2026-2027 Raiders regular season ("**Raiders Away Game Experience**"). Such Raiders Away Game Experience details shall be determined in Sponsor's discretion. The Raiders Away Game Experience will consist of two (2) game tickets to a Raiders away game, coach class travel for two (2) from within the continental United States to and from the Raiders Away Game Experience city, and hotel accommodations for two (2). Exact dates, number of nights, and all other details shall be determined in Sponsor's sole and absolute discretion. All other costs not described herein are the responsibility of Winner. The ARV of the Raiders Away Game Experience is \$4,000.

3.2.2.2. One (1) Winner will receive one (1) cabin on the Raiders Fan Cruise presented by Seaside Events for Winner and one (1) companion for cruise on March 2, 2026, to March 6, 2026 ("**Raiders Fan Cruise**"), provided that such Winner and their companion agree to all rules, terms, conditions, and regulations associated with Raiders Fan Cruise. Transportation to port of the Raiders Fan Cruise is not included. All details of the Raiders Fan Cruise shall be determined in Sponsor's sole and absolute discretion. The ARV of the Raiders Fan Cruise is \$5,000.

3.2.3. Entry Period 3: To win any of the following Grand Prizes, You must (i) enter by the end date of Entry Period 3 of February 6th, 2026, and (ii) if You are submitting an Entry via digital method of entry pursuant to Section 5.1, You must pay for Your 2026-2027 License Fee on or before January 30th, 2026 at 11:59 pm PST.

3.2.3.1. One (1) Winner will receive one (1) \$3,500 food and beverage gift card or credit ("**Gift Card**") to be used at a Raiders regular season game played at Allegiant Stadium. Such gift card or credit shall be for the 2026-2027 NFL season only and will not roll

over to other NFL seasons. Winners of the Gift Card will not be able to redeem the Gift Card for cash or be subject to refunds as a result of nonuse. Standard gift card or credit terms and conditions shall apply. Any additional money spent in excess of the Gift Card and all taxes, gratuity and fees will be responsibility of Winner. The ARV of the Gift Card is \$3,500.

3.2.3.2. One (1) Winner will receive one (1) table at the Wynn Field Club to be used by Winner and up to nine (9) guests for a third-party event, at Allegiant Stadium between March 1st, 2026 and December 31st, 2026 ("**Wynn Field Club Experience**"). The third-party event will not include a Raiders game and will be selected by Sponsor in its sole and absolute discretion. The Wynn Field Club Experience will include a \$2,500 food and beverage credit. Standard credit terms and conditions shall apply. Any additional money spent in excess of the credit and all taxes, gratuity and fees will be the responsibility of Winner. All participants must be 21 years old or older to participate. The ARV of the Wynn Field Club Experience is \$6,000-\$10,000.

3.2.3.3. One (1) Winner will receive one (1) Raiders Swag Bag ("**Raiders Swag Bag**"). The Raiders Swag Bag will include merchandise and memorabilia to be selected by Sponsor in Sponsor's sole and absolute discretion. The ARV of the Raiders Swag Bag is \$1,000.

3.3. Total ARV of the Grand Prizes. The total ARV of all eight (8) Grand Prizes to be awarded as part of the Sweepstakes is \$50,500 - \$54,500. The ARV for the Grand Prizes are an estimate made before the Sweepstakes begins. If the actual retail value of the Grand Prize is less than or greater than the stated ARV, the prize Winner will not receive the difference.

3.4. Odds of winning a Grand Prize depend on the number of eligible entries received by an Entry Period.

4. PRIZE CONDITIONS.

4.1. General Prize Conditions:

4.1.1. No more than one (1) Grand Prize will be awarded per Entrant. A winner of a Grand Prize in the immediately preceding year is not eligible to receive the same Grand Prize in the current Sweepstakes. If such potential Winner is randomly selected for the same Grand Prize, an alternate winner will be drawn. However, such potential Winner remains eligible to win any of the other available Grand Prizes in the current Sweepstakes. All potential Winners are subject to verification by Sponsor or Wit, whose decisions are final. Grand Prizes cannot be transferred, redeemed for cash or substituted by an Entrant. All federal, state, provincial and local taxes, and all costs and expenses, related to the acceptance or use of the Grand Prize, and not specified herein as being provided, are the sole responsibility of the Winner. Any required tax reporting forms will be furnished to the appropriate authorities. Sponsor reserves the right in its sole and absolute discretion to award a substitute Grand Prize of equal or greater estimated value if a Grand Prize

described in these Rules is unavailable or cannot be awarded, in whole or in part, for any reason. That determination is final and binding and cannot be appealed. Sponsor makes no representation or warranty concerning the appearance, safety or performance of any prize awarded.

- 4.1.2. Sponsor reserves the right to determine if and how the Grand Prizes will be delivered to any potential Winner. All Grand Prizes must be redeemed and used by December 31, 2026. All Grand Prizes may be claimed in and shipped to an address in the 50 United States and/or the District of Columbia, except for Florida, New York or Rhode Island and except in Sponsor's sole and absolute discretion. All Grand Prizes may be delivered to the Winner by regular mail, United Postal Service or courier such as Federal Express or any other delivery method at Sponsor's sole and absolute discretion. Sponsor estimates that the Grand Prize delivery will take approximately 6-8 weeks for delivery after Winner's verification. Sponsor is not responsible for and will not replace any lost, mutilated or stolen Grand Prizes. Sponsor assumes no liability for non-deliverability.
- 4.1.3. In the event that the Sweepstakes is cancelled or postponed by Sponsor for any reason whatsoever, the Grand Prizes (or their equivalent ARV) shall not be awarded except and solely to the extent decided by Sponsor or Wit in their sole and absolute discretion or as otherwise required by law. Sponsor and/ or Wit shall have no responsibility or obligation to the Winner or a potential Winner who is unable or unavailable to, or who does not for any reason, accept or utilize the Grand Prize. In the event of non-compliance with these Official Rules, or if the Grand Prize is unclaimed, the Grand Prize will be forfeited. A forfeited Grand Prize may be awarded to an alternate Winner, at Sponsor's sole and absolute discretion.
- 4.1.4. The Gift Card Grand Prize is subject to additional cardholder terms and conditions imposed by issuer. No credit or cash will be returned or refunds issued if the full value of the Gift Card has not been used by its respective expiration date, if any. The Gift Card will not be replaced if lost or stolen but Sponsor may, in its sole and absolute discretion, replace a lost, stolen or malfunctioning card. In no event will the Gift Card's value exceed its stated value.
- 4.1.5. EACH PRIZE IS AWARDED AS IS AND WITHOUT WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. SOME JURISDICTIONS MAY NOT ALLOW (OR MAY LIMIT) DISCLAIMERS OF CERTAIN WARRANTIES, IN WHICH CASE THE FOREGOING DISCLAIMERS WILL BE ENFORCED TO THE MAXIMUM EXTENT PERMITTED BY LAW.
- 4.1.6. By participating in this Sweepstakes or accepting a Grand Prize, Entrants further acknowledge and agree to the following Grand Prize restrictions: Winner and his or her companion must follow all instructions of Sponsor and/or the NFL relative to the Grand Prize and any element thereof. In the event the Winner or his or her travel companion engages in behavior that, as determined by Sponsor at its sole and absolute discretion, is

obnoxious or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to terminate the Grand Prize or other applicable experience early, in whole or in part. In such event, Winner may also be required to reimburse the Sponsor for the ARV of the Grand Prize.

4.1.7. Nonmonetary Grand Prizes that include tickets, tours, trips, experiences, or other Grand Prizes must be taken or utilized on date specified by Sponsor or the applicable Grand Prize will be forfeited, and Sponsor will have no further obligation to such Winner. Sponsor reserves right to change dates. Winner is responsible for all other costs and expenses not expressly stated in the Rules, including without limitation, incidentals and transportation, if not included. Winner is subject to all Allegiant Stadium, other NFL venue, and Sponsor Rules, procedures, and code of conduct when participating in any Grand Prize experience, and Sponsor reserves the right to require all participants to complete and execute Sponsor's standard indemnity/waiver agreement prior to participating in any Grand Prize as applicable.

4.1.8. Nonmonetary Grand Prizes that include tickets are subject to certain terms and conditions as specified thereon. Seat locations will be determined by Sponsor. Winner and his or her companion must comply with all venue rules and regulations. Failure to do so may result in forfeiture of such portion of the Grand Prize.

4.1.9. PARTICIPATION IN AND ATTENDANCE ON THE RAIDERS FAN CRUISE PRESENTED BY SEASIDE EVENTS IS SUBJECT TO ALL RULES, TERMS, CONDITIONS, AND REGULATIONS ASSOCIATED WITH THE FAN CRUISE. YOU ACKNOWLEDGE THAT THE FAN CRUISE IS NOT OPERATED, FACILITATED, OR IN ANY WAY ADMINISTERED BY RELEASED PARTIES AND SPONSOR SHALL NOT BE HELD VICARIOUSLY LIABLE FOR THE INTENTIONAL OR NEGLIGENT ACTS OF ANY PERSONS NOT EMPLOYED BY THE LAS VEGAS RAIDERS, INCLUDING WITHOUT LIMITATION ANY EMPLOYEES OF SEASIDE EVENTS, INC. OR ROYAL CARIBBEAN CRUISE LINES (TOGETHER, "**CRUISE ENTITIES**") NOR FOR ANY INTENTIONAL OR NEGLIGENT ACTS OF CRUISE ENTITIES' EMPLOYEES COMMITTED WHILE OFF DUTY OR OUTSIDE THE COURSE AND SCOPE OF THEIR EMPLOYMENT.

5. HOW TO ENTER.

Entrants may enter the Sweepstakes during the Sweepstakes Period in one of the following ways. Limit one (1) Entry per person during the Sweepstakes Period, regardless of the method of entry. An eligible Entry will be entered for that specific Entry Period in which the Entry was received. Any non-winning Entries from an Entry Period will roll over into subsequent Entry Periods.

5.1. **Digital Method of Entry:** Before visiting the Sweepstakes Landing Page (as defined below), Entrants must be a Las Vegas Raiders Suite & Loge Licensee ("**Suite & Loge Licensee**") and pay Sponsor for their 2026-2027 Raiders License Fee ("**License Fee**") for the 2026-2027 NFL season. After payment has been made, Entrant can visit the Sweepstakes Landing Page at: <https://web.witcontests.com/raiders/sweepstakes/win/raiders-suite-and-loge-250905> specified "**Sweepstakes Landing Page**") and complete and submit a Sweepstakes Entry form. The

Sweepstakes Entry form may require the following information and affirmative actions from each Entrant:

- 5.1.1. The email address used for an Entrant's Raiders Suite or Loge member account for contact and notification purposes;
 - 5.1.2. Entrant's First and last name;
 - 5.1.3. Entrant's zip code;
 - 5.1.4. Entrant must check the box to verify that the Entrant is at least twenty-one (21) years of age; and
 - 5.1.5. Entrant must check the box to verify that the Entrant has read and agreed to these Official Rules, and by entering the Sweepstakes, Entrant agrees to the Raiders Terms of Service and Raiders Privacy Policy.
- 5.2. By successfully transmitting a completed Sweepstakes Entry form as directed after visiting the Sweepstakes Landing Page, You will be entered into the Sweepstakes. Entrants must fully complete and submit all non-optional data requested on the Sweepstakes Entry form to be eligible. Incomplete or inaccurate entries are void. All entries must include a valid email address for the Entrant.
- 5.3. In the event of a dispute regarding Entries received from multiple users having the same email, and/or Suite or Loge Licensee account, the authorized subscriber of the email or Suite or Loge Licensee account at the time of Entry will be deemed to be the Entrant and must comply with these Rules. Authorized account subscriber is the natural person who is assigned the email address for the Suite & Loge Licensee account, by the Internet Service Provider ("ISP"), on-line service provider, or other organization responsible for assigning email addresses, Suite & Loge Licensee account in question.
- 5.4. **No Automated Entries.** All automated or robotic Entries submitted by individuals or organizations will be disqualified. All Entries by Entrants must be made manually by such Entrants. Any attempt by an Entrant to submit multiple Entries by using multiple/different email addresses, phone numbers, identities, registrations, logins or any other methods will void such Entrant's Entries and that Entrant may be disqualified. Final eligibility for the award of any Grand Prize is subject to the eligibility verification of these Rules. All Entries must be submitted by the end of the Sweepstakes Period in order to participate.

The date of receipt will be considered the date

of Entry for purposes of determining the applicable Entry Period and respective Grand Prize selection.

6. WINNER SELECTION AND NOTIFICATION.

- 6.1. Winners of the Sweepstakes are only potential Winners subject to notification, verification and acceptance of such Grand Prizes. The potential Winners for Entry Period 1, Entry Period 2, and Entry Period 3 will be randomly selected from all eligible Entries on or about December 8th, 2025, January 7th, 2026, and February 9th, 2026, respectively, after the conclusion of each of the Entry Periods for the Grand Prizes listed above. Potential Winners of the Grand Prizes will be selected in sequential order by random drawing for the Grand Prizes in the order listed above for the respective Entry Period.
- 6.2. Within twenty-one (21) days of the random drawing, Wit will contact the potential Winner of the Grand Prize at the email address provided at the time of Entry at the conclusion of each Entry Period. The potential Winner will be awarded the Grand Prize subject to verification of eligibility and compliance with the terms of these Official Rules. If the potential Winner fails to respond to the verification email within forty-eight (48) hours of notification or the email notification is returned as undeliverable after two (2) attempts, the potential Winner may be disqualified at Sponsor's sole and absolute discretion. In the event the potential Winner of the Grand Prize is disqualified for any reason, Sponsor may award the Grand Prize to an alternate potential Winner by random drawing from among all remaining eligible entries. Within twenty-four (24) hours of the secondary drawing, the alternate potential Winner of the Grand Prize will also be contacted at the email address provided at the time of Entry. If the alternate potential Winner of the Grand Prize fails to respond to the verification email within forty-eight (48) hours of notification or the email notification is returned as undeliverable after two (2) attempts, the alternate potential Winner of the Grand Prize may be disqualified at Sponsor's sole and absolute discretion.
