

EAGLES GAMEDAY BINGO

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

Void where prohibited or restricted by law, rule or regulation. Eagles Bingo is subject to all applicable federal, state and local laws, rules and regulations.

1. **ELIGIBILITY.** Eagles Bingo (“Bingo”) is open only to legal residents of the fifty (50) United States and the District of Columbia, except NY, FL, & RI, who are eighteen (18) years of age or older (or the age of majority in their respective jurisdiction) at the time of entry and who have downloaded and registered the Philadelphia Eagles Mobile Application (the “Application”). Employees, agents and representatives (and their immediate families (parent, child, spouse or sibling and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related) of Philadelphia Eagles, LLC (the “Administrator”), Autumn Lake Healthcare LLC (“Autumn Lake”), the NFL Entities (defined below) and their respective parents, affiliates, subsidiaries and advertising and promotion agencies are not eligible to enter or win. The NFL Entities shall be defined as the National Football League, its member professional football clubs, NFL Ventures, Inc., NFL Ventures, L.P., NFL Properties LLC, NFL Enterprises LLC, and each of their respective subsidiaries, affiliates, shareholders, officers, directors, agents, representatives, and employees. By participating, entrants agree to be bound by these Official Rules and the decisions of the Administrator, which are binding and final on matters relating to this contest. Only an individual meeting all eligibility requirements set forth in these Official Rules may participate in Bingo or win a Prize (as defined herein). In the event of any conflict or inconsistency with any other advertising, promotional or other materials, these Official Rules shall govern. Administrator reserves the right to verify the eligibility of winner before awarding any prize.

2. **ENTRY PERIOD.** The Bingo period will begin at the official start of the Eagles’ Week 1 game on September 4, 2025, and will end at the official end of the Season on or around January 4, 2026 (the “Bingo Period”). The Bingo Period will be divided into separate entry periods (each, an “Entry Period”), with each new Entry Period starting forty-eight (48) hours prior to kickoff of a Philadelphia Eagles game played during the Bingo Period (each, a “Game”) and each Entry Period ending forty-eight (48) hours following kickoff of such game as set forth in the chart below. Administrator’s computer is the official time keeping device for Bingo.

*Game dates and times are subject to change. In such event, the applicable Entry Period will adjust to 48 hours prior to kickoff and 48 hours after kickoff of the applicable Philadelphia Eagles game.

HOW TO PARTICIPATE. Prior to or during an Entry Period, participants must download the Application, available for free on the Apple App Store and Google Play, to their personal mobile device. Once the Application is downloaded to a personal device, participants must navigate to the promotional link to Eagles Bingo within the Application to participate. Once participant taps the “Eagles Bingo” button, a randomly generated electronic Bingo playing card (the “Bingo Board”) for the applicable Entry Period will appear on the screen of the mobile device. Each applicant has the opportunity to shuffle their Bingo card three (3) times prior to kickoff of the applicable Philadelphia Eagles game during each applicable Entry Period. During each Entry Period,

any plays or other events that occur during the applicable Game will automatically check off on participants' Bingo Board as they occur on the playing field (each, a "Game Event"). You may participate in Bingo only via the Application using your mobile device. No other method of entry will be accepted. For the purposes of Bingo, multiple participants are not permitted to share the same account in the Application. Limit of one (1) Bingo Board per participant per Entry Period. Any attempt by a participant to use multiple accounts, identities, registrations and logins, or any other methods, will void that participant's entry and that participant may be disqualified from Bingo in the Administrator's sole discretion. All entries become the exclusive property of the Administrator and will not be acknowledged or returned. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter Bingo is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Administrator's sole discretion and in accordance with these Official Rules) are void.

The Administrator, Autumn Lake, the NFL Entities, and each of their respective parents, subsidiaries and affiliates and each of their respective officers, directors, shareholders, owners, agents and employees (collectively, the "Released Parties"), is not responsible for delayed, incorrect or inaccurate entry of information, human error, unavailable network, server, Internet Service Provider (ISP), or website, technical malfunction, lost/delayed data transmission, omission, interruption, deletion, defect, line failure of any telephone, computer or other network, computer equipment, software or any combination thereof, inability to access Bingo, or errors or typographical, printing or otherwise relating to or in connection with Bingo, including, without limitation, errors or difficulties which may occur in connection with the administration of Bingo, the processing of entries, the announcement of the prize, or in any Bingo-related materials or these Official Rules. Administrator reserves the right, in its sole discretion, to void any entries of entrants whom Administrator believes have attempted to tamper with or impair the administration, security, fairness or proper play of Bingo or is in violation of these Official Rules.

WINNER DETERMINATION: There is one (1) way to win: Blackout Bingo (a "Winning Event").

- **BLACKOUT** - All of the Game Events on the Bingo game board are marked off.

Upon a Winning Event, a Bingo button in the Application will begin to pulse and you must tap on the button in order to submit your Bingo game board as a potential winning entry. **YOU MUST HIT THE PULSING BUTTON IN ORDER TO WIN.**

For each Entry Period, the first participant to hit the pulsing button during such Entry Period for a "Blackout" Bingo will be the potential winner and subject to verification of eligibility and compliance with these Official Rules, the potential winner will be declared the official winner (the "Winner"). Each Winner will be prompted to enter prize code, name, address (no P.O. Boxes accepted), e-mail address, confirm they are eighteen (18) years of age or older (or the age of majority in their respective jurisdiction) and agree to the Official Rules.

3. WINNER NOTIFICATION. The Application will automatically notify the participants if such participant is a potential winner. Participants must follow the instructions appearing in the Application prize notification to claim their Prize as directed and within the time frame noted in such prize notification. Unless noted otherwise in the prize notification, all Prizes must be

claimed thirty (30) days following the day of the applicable Game. Each entrant is responsible for monitoring his/her Application for prize notification and receipt of other communications related to Bingo. If a potential Prize winner does not claim his/her Prize during the time frame noted in the prize notification or above, as applicable, that potential Prize winner forfeits his/her Prize. Upon request of the Administrator, the potential winner may be required to return an Affidavit of Eligibility, Release and Prize Acceptance Form. If a potential winner fails to comply with these Official Rules, that potential winner will be disqualified and Administrator, in its sole discretion, may select the individual to achieve the applicable Winning Event after the applicable cut-off number noted above an alternate potential winner (e.g., if a potential winner is disqualified, the second 2nd individual whose Bingo board results in a Game Event's Winning Event may be selected as an alternate potential winner). Prizes in chart listed above in section 2 will be awarded depending on Winning Events occurring during the Entry Period. If no entrants have a Winning Event during the Entry Period, the prizes for such Entry Period will not be awarded. All prize details are at Administrator's sole and absolute discretion.

4. **PRIZE.** Prizes will be awarded per Entry Period as set forth below (each, a "Prize" and collectively, the "Prizes"). The exact number of Blackout Prizes depends on whether Game Events happen and whether a randomly generated Bingo game board results in a Winning Event.

Blackout Prize. Up to one (1) Blackout Prize will be awarded per Entry Period. The Winner will receive the prize set forth in the chart above in Section 2 during each Entry Period, (a "Blackout Prize").

Approximate retail value of all Blackout Prizes: \$4,116.

Except as determined by Philadelphia Eagles in its sole discretion, no substitution of Prize is offered, no transfer of Prize to a third party is permitted, and Prize may not be redeemed for cash value. Any difference between stated ARV of a Prize and actual value of such Prize will not be awarded. For the avoidance of doubt, the Philadelphia Eagles reserve the right to substitute a Prize (or applicable portion of a Prize) with one of comparable or greater value, as determined by the Philadelphia Eagles in their sole discretion.

5. **PRIZE RESTRICTIONS.** Odds of winning a Blackout Prize during an Entry Period depend on the order and type of Game Events to happen during the applicable Entry Period and the placement of the Game Events on your Bingo game board for such Entry Period.

No transfer, assignment, sale, duplication, cash redemption or substitution of Prize (or portion of Prize) is permitted, except by Administrator, which reserves the right to substitute a Prize (or applicable portion of Prize) with one of comparable or greater value, as determined by Administrator. Administrator is not responsible for and will not replace lost or stolen Prize or any component thereof. Non-compliance with these Official Rules may result in disqualification and, at Administrator's sole discretion, the awarding of prize to an alternate winner. Winner is solely responsible for any and all applicable fees, taxes and expenses associated with a Prize that are not specifically listed herein. Submission of Prize claim is the sole responsibility of participant. Administrator reserves the right to, in its sole and absolute discretion, not award a Prize to any participant.

6. VERIFICATION OF POTENTIAL WINNERS. ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY ADMINISTRATOR, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO BINGO. A PARTICIPANT IS NOT A WINNER OF ANY PRIZE UNLESS AND UNTIL PARTICIPANT'S ELIGIBILITY HAS BEEN VERIFIED AND PARTICIPANT HAS BEEN NOTIFIED THAT VERIFICATION IS COMPLETE.

7. PUBLICITY. Except where and as may be prohibited by law, participation in Bingo and acceptance of Prize constitutes express permission of winner for Administrator and those acting pursuant to the authority of Administrator to use such winner's name, photograph, image, likeness, voice, opinions, hometown, and/or state for advertising, trade, promotion, and publicity purposes in all forms of media now known or hereafter developed, worldwide in perpetuity, without further notice, review or approval, permission, or compensation. If you do not agree to these terms, you should not participate Bingo.

8. GENERAL CONDITIONS. Administrator reserves the right, in its sole discretion, to modify, suspend or terminate Bingo (or any portion thereof) should any virus, bug, fraud, non-authorized human intervention or other causes, including but not limited to weather, war or armed conflict (whether or not officially declared), labor controversy or threat thereof, and/or acts of God, corrupt or impair the administration, security, fairness or proper play of Bingo and, in the event of termination, at its discretion, select winner from among all eligible, non-suspect entries received as of the date of the event requiring such termination. Administrator reserves the right to disqualify any individual it determines, in its sole and absolute discretion, is or is attempting or intending to: (a) tamper with any aspect of the operation of Bingo, (b) defraud Administrator, (c) undermine the legitimate operation of Bingo by cheating, deception, or other unfair playing practices, (d) annoy, abuse, threaten, or harass any other participants, Released Parties, or representatives of the Released Parties, or (e) act in violation of these Official Rules. In such event(s), Administrator reserves the right (in addition to disqualification of such individual) to seek damages from any such person to the fullest extent permitted by law. Administrator's failure to enforce any provision of these Official Rules shall not constitute a waiver of that provision. No groups, clubs, newsletters, or organizations may reproduce or distribute any portion of these Official Rules to their members, and anyone who participates in Bingo through means not permitted by these Official Rules is subject to disqualification. No more than the stated number of Prizes will be awarded. In the event that production, technical, mechanical, typographical, or any other reasons cause more than stated number of Prizes as set forth in these Official Rules to be available and/or claimed, Administrator reserves the right, in its sole and absolute discretion, to award only the stated number of Prizes (previously not awarded) by means of a random drawing among all legitimate and eligible Prize claims. **ANY ATTEMPT BY ANY PERSON DELIBERATELY TO DAMAGE THE ELECTRONIC ENTRY FORM OR UNDERMINE THE LEGITIMATE OPERATION OF BINGO MAY BE IN VIOLATION OF CRIMINAL AND CIVIL LAWS, AND SHOULD SUCH AN ATTEMPT BE MADE, ADMINISTRATOR RESERVES THE RIGHT TO SEEK REMEDIES (INCLUDING ATTORNEYS' FEES) AND DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING CRIMINAL PROSECUTION.**

9. **AGREEMENT TO OFFICIAL RULES.** By participating in Bingo, entrants agree to be bound by these Official Rules and the decisions of the Administrator (including but not limited to Administrator's employees or agents handling Prize redemption), which are final and binding in all matters relating to Bingo. By participating in Bingo, each Participant waives any right to claim ambiguity in these Official Rules.

10. **RELEASE:** By participating in Bingo, participant agrees to release, indemnify, and hold harmless, the Released Parties and each of their respective officers, directors, owners, employees, agents, affiliates, owner-operators, designees and assigns, from any and all liability for any injuries, loss, harm, damage, cost, or expense of any kind to any person(s), including, without limitation, property damage, personal injury, and/or death, arising in whole or in part, directly or indirectly, from acceptance, possession, use, and/or misuse of a Prize or participation in Bingo or any Bingo-related activity and for any claims based on publicity rights, defamation, or invasion of privacy. The Released Parties are not responsible for cancellations or delays, or if any Prize cannot be awarded or used, or if Bingo cannot be conducted as planned for any reason due to non-authorized intervention, fraud, weather, force majeure event, acts of war, natural disasters, terrorism events or other causes beyond their control.

11. **LIMITATION OF LIABILITY:** Except where prohibited, participant agrees that: (1) any and all disputes, claims, and causes of action arising out of or connected with Bingo, or any Prize awarded, or the determination of the winner, shall be resolved individually, without resort to any form of class action; (2) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering Bingo not to exceed \$50 but in no event including attorneys' fees, and (3) under no circumstances will participant be permitted to obtain awards for and participant hereby waives all rights to claim punitive, incidental, consequential, and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.

SOME JURISDICTIONS MAY NOT ALLOW THE LIMITATIONS OR EXCLUSIONS OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES OR EXCLUSION OF IMPLIED WARRANTIES, SO SOME OF THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT APPLY. CHECK LOCAL LAWS FOR ANY RESTRICTIONS OR LIMITATIONS REGARDING THESE LIMITATIONS OR EXCLUSIONS.

12. **GOVERNING LAW.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of participants or the Released Parties in connection with Bingo will be governed by and construed in accordance with the internal laws of the Commonwealth of Pennsylvania, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws.

13. **PRIVACY.** Entrants' personally identifiable information will be used only in accordance
