OFFICIAL RULES

2025 Desnuda Tequila Register to Win Sweepstakes

NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE. A PURCHASE WILL NOT INCREASE PARTICIPANTS' CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW. This game may not be used to conduct, advertise, or promote any form of gambling.

1. ELIGIBILITY.

The 2025 Desnuda Tequila Register to Win Sweepstakes ("Sweepstakes") is open to legal residents of the United States who are 21 years of age or older as of the date of registration. The Sweepstakes, and participation in the Sweepstakes, are subject to these Official Rules. All entries become the property of Club and Sponsor (the "Released Parties") and will not be acknowledged or returned.

3. PRIZE.

The winner will receive four pregame sideline passes and four tickets to the Colts v. 49ers game on December 22, 2025, a Colts autographed item, and three bottles of Desnuda Tequila including a custom bottle of Blanco ("Prize"). There will be a total of one winner.

All costs and expenses associated with the acceptance and use of the Prize not specified herein as being awarded, including, but not limited to, all federal, state, and local taxes, are the winner's sole responsibility. Participants enter to win by visiting <u>www.colts.com/desnuda</u>, to complete the Sweepstakes registration form ("Entry Process"). Registration is free. Limit one registration per participant, per email address.

Multiple submissions may result in disqualification. The use of script, macro, other automated means, or any other device to subvert the Entry Process is prohibited and all such registrations will be void. In the

event of a dispute as to the identity of participant based on the e-mail address submitted at the time of registration, entry will be awarded to the person named on the applicable registration form (regardless of whether that is the name of the authorized account holder of the email address from which said registration form was submitted), provided such individual is eligible according to these Official Rules.

Released Parties are not liable for any error, omission, interruption, defect, or delay in any transmission or communication; or for any technical problem, including but not limited to any injury or damage to participant's or any other person's computer or mobile device related to or resulting from participation in this Sweepstakes; typographical, printing, or other errors in these Official Rules, in any Sweepstakes-related advertisements or other materials; the administration of the Sweepstakes, the processing of entries, the selection or announcement of winners, or the distribution of prizes; tabulation, timing errors, or other errors of any kind whether mechanical, human, electronic, typographical, or otherwise.

5. WINNER SELECTION.

One Prize Winner will be selected by a Club staff member no later than December 19, 2025, from all eligible entries received via the Entry Process during the Sweepstakes Period. There will be a total of four Prize Winners. By participating, participants agree to these Official Rules and to the decisions of Club and Sponsor, which will be final and binding in all respects. 6. WINNER NOTIFICATION.

The Prize Winner will be contacted via the e-mail address or telephone number provided on the registration form. If the Prize Winner does not acknowledge the Prize within 48 hours of notice, an alternative winner will be randomly selected and notified until Prize is claimed.
