1. Eligibility

The Nuggets with the Legends Sweepstakes ("Sweepstakes") is offered only in the United States to legal residents of Pennsylvania, New Jersey, Delaware, Maryland, and the District of Columbia, who are eighteen (18) years of age or older as of the date of entry.
