

NUGGETS WITH THE LEGENDS SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Eligibility

The Nuggets with the Legends Sweepstakes (“Sweepstakes”) is offered only in the United States to legal residents of Pennsylvania, New Jersey, Delaware, Maryland, and the District of Columbia, who are eighteen (18) years of age or older as of the date of entry. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (“Eagles”), Tyson Foods, Inc. (“Tyson” or “Sponsor”), and any of their respective agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize. By entering, you agree to these official rules (“Official Rules”) and the decisions of the Eagles (the judging organization), which are final and binding in all respects.

2. Sweepstakes Period

Sweepstakes period begins on Wednesday, December 3, 2025 at 9:00:00 a.m. Eastern Time (“ET”) and ends on Monday, January 5, 2026 at 11:59:59 p.m. ET (the “Sweepstakes Period”).

3. Entry

You may enter by going to <https://forms.philadelphiaeagles.com/f/tynson-legends>, clicking on the icon to access the entry form during the Sweepstakes Period and entering your date of birth and country of residence, and then entering your name, zip code, e-mail address, phone number and confirm that you have read and agree to the Official Rules. Next, you must upload and submit a photo of yourself with a bag of Tyson Eagles Chicken Nuggets to enter the Sweepstakes (the “Photo”). Upon completing the entry method, and subject to the conditions below, you will automatically be entered into the Sweepstakes. Proof of entry submission does not equate to proof of receipt. Entrants agree to be bound by the Official Rules. The Eagles’ computer shall be the official clock of the Sweepstakes.

Following the conclusion of the Sweepstakes Period, twenty-five (25) winners will be selected randomly by the Eagles from all eligible entries received during the Sweepstakes Period. Winners will be notified by e-mail on or about January 5, 2026 (the "Announcement Date"). If, after twenty-four (24) hours contact has not been made, any potential prize will be forfeited, and an alternate winner may be randomly selected from the eligible entries received during the Sweepstakes Period. Final designation as a winner depends on verification of eligibility as determined by Eagles. Winners may not substitute or redeem prize for cash, but Sponsor reserves the right to substitute prize with a prize of equal or greater value should the advertised prize become unavailable for any reason.

5. Prize/Odds

In accordance with these Official Rules, twenty-five (25) winners will be awarded the following prize: an invitation for each winner and their one (1) guest to attend the Tyson Nuggets with the Eagles Legends event at scheduled to take place at Lincoln Financial Field (or such other location to be determined by the Eagles in its sole discretion). Approximate retail value ("ARV") of the prize is \$100. The exact date of the event and Eagles Legends will be selected at the sole discretion of Eagles. Each winner's guest must be either eighteen (18) years of age or older, or, if guest is a minor, then winner must be the parent or legal guardian of such guest. Any other costs associated with attendance at the event, including transportation to and from Lincoln Financial Field (or such other location to be determined by Eagles in its sole discretion), shall be the sole responsibility of winners.

Odds of winning will be determined by the total number of eligible entries received during the Sweepstakes Period.
