

**2025 12 DAYS OF BEARS GIVEAWAYS BY VERIZON SWEEPSTAKES

1. **HOW TO ENTER:** The 2025 12 Days of Bears Giveaways by Verizon Sweepstakes Rules (the “**Sweepstakes**”) starts December 13, 2025 on 12:00AM Central Time (“**CT**”) and ends on December 24, 2025 at 11:59 PM CT (“**Entry Period**”). Entrants will have an opportunity to enter each date of the Entry Period (each an “**Entry Date**”) by completing the entry form available at: <https://www.chicagobears.com/sweepstakes/12-days-of-bears-giveaways> with your first name, last name, age, address, e-mail, and telephone number (“**Entry Form**”) during the Entry Period.
