

**EAGLES WALTER PAYTON MAN OF THE YEAR X SWEEPSTAKES 2025 –
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT
INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR
RESTRICTED BY LAW.**

By participating in the Sweepstakes promoted by @eagles (the “Official X Account”), you agree to these Official Rules, which are a contract. You must follow the directions provided by the Official X Account from time to time, in the discretion of Philadelphia Eagles, LLC (“Eagles”) and otherwise be bound by and follow these Official Rules to be eligible to receive a prize in connection with any Sweepstakes.

1. Eligibility

The Walter Payton Man of the Year X Sweepstakes (“Sweepstakes”) is offered only in the United States to legal residents of the 50 United States and the District of Columbia (excluding New York, Florida and Rhode Island) who are eighteen (18) years of age or older (or the age of majority in the jurisdiction in which they reside, whichever is older) as of the date of entry. Employees, officers, directors, agents and representatives of the Eagles and any of its respective agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize. By entering, you agree to these Official Rules and the decisions of the Eagles (the judging organization), which are final and binding in all respects.

2. Sweepstakes Period

The Sweepstakes period begins on December 9, 2025 at 10:00:00 a.m. Eastern Time (“ET”) and ends on January 6, 2026 at 11:59:59 p.m. ET (the “Sweepstakes Period”). There will be four (4) entry periods (each, an “Entry Period”) during the Sweepstakes Period.

3. Entry

To enter, you must have a valid, public (i.e. not “protected”) X (formerly known as Twitter) account and follow the Official X Account. If you do not have an X account, visit www.twitter.com and register in accordance with the enrollment instructions for a free X account. Each Entry Period begins when a new promotional post (“Post”) is posted by the Official X Account, as shown in the chart in Section 4 below. To enter, repost the Post during the applicable Entry Period. Entrants may receive up to one (1) entry during each Entry Period. Non-winning entries will not be eligible to win in subsequent Entry Periods.

Entrant must repost the Post verbatim, without modifying, changing, or rearranging the Post in any way. If an Entrant modifies, changes, or rearranges the Post, then the Entrant will not receive an entry into the Sweepstakes, and the entry will not be included in the drawing.

Failure to follow any instructions provided by the Official X Account or to submit your entry within the Sweepstakes Period may result in disqualification. The time of receipt of any valid X entry shall be the time such valid entry becomes available to the Eagles on Twitter.com. The Eagles’ computer shall be the official clock of the Sweepstakes. Upon completing the entry method, and subject to the conditions below, you will automatically be entered into the Sweepstakes. Proof of entry submission does not equate to proof of receipt. Entrants agree to be bound by the Official Rules.

LIMIT ONE ENTRY PER X ACCOUNT AND PERSON DURING EACH ENTRY PERIOD (REGARDLESS OF WHETHER MORE THAN ONE PERSON USES THE SAME X ACCOUNT). If more than one entry is submitted during each Entry Period, only the first entry will be entered into the Sweepstakes and all other entries will be disregarded. In the event of a dispute as to any entry, the authorized account holder of the X handle used to enter will be deemed to be the entrant. The “authorized account holder” is the natural person assigned to the X handle. The potential winner(s) may be required to show proof of being the authorized account holder.

If you choose to enter via a mobile device, STANDARD MESSAGE RATES AND DATA CHARGES MAY APPLY. Please consult the terms and conditions of your individual service plan prior to participating via a mobile device. A mobile device is not required to enter the Sweepstakes.

Any attempt by any person to submit more than the stated number of entries by using multiple/different accounts or any other methods will void that person’s entry and that person will be disqualified. Automated entries (including but not limited to any entries submitted using any robot, script, macro or other automated service) are not permitted and will be disqualified. No mass entries or mechanically reproduced entries will be accepted. All entries become the exclusive property of Eagles and will not be returned or acknowledged. Any attempts by an individual to access the Official X Account via a bot script or other brute-force attack will result in that IP address becoming ineligible. Eagles will prosecute any fraudulent activities to the fullest extent of the law. Eagles reserves the right to suspend or terminate this Sweepstakes without notice if, in Eagles’ sole discretion, the Sweepstakes becomes infected or otherwise corrupted.

Four (4) drawings will be held. One (1) winner will be selected randomly per drawing from all eligible entries **received during the dates detailed in the chart above** during the Sweepstakes Period, for a total of four (4) winners. The potential winners will be notified by the Eagles within approximately three (3) days of the random drawing via one (1) direct message to their X account. Subject to verification of eligibility and compliance with the terms of these Official Rules, the potential winners will be declared the official winners of the Sweepstakes and given instructions explaining how to claim the prize. **The potential winners must respond to the X direct message within twenty-four (24) hours of attempted notification and provide their first name, last name, address (No P.O. Boxes accepted), city, state, zip code, daytime phone number and age to claim the prize.** Return of any notification as undeliverable or if the potential winner(s) does not respond within twenty-four (24) hours of attempted notification with the required information, the prize will be forfeited in its entirety, and a potential alternate winner will be selected from the remaining eligible entries. Final designation as the winners depends on verification of eligibility as determined by the Eagles. Two (2) additional attempts will be made to award prizes to potential alternate winners. 5. Prize/Odds
