

Raiders Exclusive Drop Sweepstakes Rules

Welcome to the **Raiders Exclusive Drop** (the “**Sweepstakes**”), sponsored by Raiders Football Club, LLC (“**Sponsor**”). **PLEASE READ THESE SWEEPSTAKES RULES CAREFULLY BEFORE ENTERING INTO THE SWEEPSTAKES.**

THERE IS NO PURCHASE OR PAYMENT NECESSARY IN ORDER TO ENTER OR WIN THE SWEEPSTAKES. ANY PURCHASE OR PAYMENT OF ANY KIND THAT YOU MAKE WILL NOT INCREASE YOUR CHANCES OF WINNING. THE SWEEPSTAKES IS SUBJECT TO ALL APPLICABLE FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS, AND IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

This Sweepstakes is powered and administered by The Raiders Football Club, LLC with technology services provided by YinzCam, Inc. (“**YinzCam**”), and is accessible via the Official Raiders Mobile Application (“**App**”). For the avoidance of doubt, Sponsor administers the Sweepstakes and is responsible for prize fulfillment, while YinzCam provides the technology platform used for the Sweepstakes. As a legal requirement for participating in this Sweepstakes as an entrant (“**Entrant**” or “**You**”), You hereby agree to be bound by these Sweepstakes Rules (the “**Official Rules**” or “**Rules**”) which form a legal contract by and between You and Sponsor. If You do not agree and consent to these Rules, please do not enter the Sweepstakes or use the App. To participate in the Sweepstakes, You must agree to the Raiders Terms of Service, available at <https://www.raiders.com/about/website-mobile-application-terms-of-service>. The Sweepstakes is subject to applicable federal, state, provincial, municipal, territorial, and local laws and regulations and is **VOID WHERE PROHIBITED OR RESTRICTED BY LAW**. Winning and receiving the Prize (as defined in Section 3) is contingent upon fulfilling all requirements set forth herein.

1. SWEEPSTAKES.

- 1.1. Sweepstakes Description. Entrant agrees to prepare and submit the required entry form for the Sweepstakes (an “**Entry**,” collectively the “**Entries**”) in accordance with the Official Rules as described herein. After submission, Entrant may or may not be deemed a Winner (as defined in Section 3.1) subject to eligibility and compliance with these Rules. A Prize will be awarded for this Sweepstakes according to Sections 5 and 6 of these Rules.
- 1.2. Sweepstakes Period. **Sweepstakes Start Date**: December 18 at 4:00 pm Pacific Time (“PT”). **Sweepstakes End Date**: December 18 at 5:30 pm PT. The Sweepstakes will begin on the above Start Date and will last through the above End Date (“**Sweepstakes Period**”). The Sweepstakes Period is comprised of six (6) entry periods (respectively, “**Entry Period 1**”, “**Entry Period 2**”, “**Entry Period 3**”, “**Entry Period 4**”, “**Entry Period 5**”, “**Entry Period 6**”) as listed in the table below. Pacific Time shall control for all purposes of the Sweepstakes. The Sponsor’s computer shall be the official clock for purposes of the Sweepstakes.

- 1.3. Rules. By participating in the Sweepstakes, Entrant unconditionally accepts and agrees to comply with and abide by these Rules, waives any right to claim ambiguity in the Rules or Sweepstakes related advertising/materials and agrees that the decisions of YinzCam or Sponsor with respect to the Sweepstakes and any Prize awards shall be final and binding in all respects. Sponsor reserves the right to alter the terms of these Official Rules at their discretion. Any such changes to the Official Rules will be prominently displayed and any conflicting changes to the Official Rules will be superseded by the most recent version of the Official Rules.
- 1.4. Sweepstakes Administration. The Sweepstakes is administered by Sponsor, with technical support provided by YinzCam. Sponsor is responsible for promoting the Sweepstakes, executing follow-up paperwork, and distributing Prize(s). YinzCam provides technology services on behalf of Sponsor, including collection and processing of Entries and selection of Winners. Entrants should contact Sponsor for all inquiries regarding the Sweepstakes.

2. ELIGIBILITY.

- 2.1. Eligible Entrants. The Sweepstakes is open only to: (i) legal residents of all states in the United States except for Florida, New York and Rhode Island, who are 18 years of age or older as of the date of entry (ii) who are not a person barred from participation in the Sweepstakes; and (iii) who at all times abide by these Official Rules. Individuals may be asked to provide documentation verifying eligibility.
- 2.2. Non-eligible Persons. Sponsor, its parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies; and each of their respective officers, directors, employees, consultants and contractors (the “**Sponsor Entities**”), are ineligible to enter the Sweepstakes or win any related Prize. “**Household Members**” means those people who share the same residence as any Sponsor Entity for at least three (3) months during a given year. “**Immediate Family Members**” means parents, step-parents, legal guardians, children, step-children, siblings, step-siblings or spouses of any Sponsor Entity. Household Members and Immediate Family Members of any Sponsor Entities are also not eligible to enter or win the Sweepstakes.

3. PRIZE AND ODDS OF WINNING.

- 3.1. Number of Prize Winners. Subject to verification of eligibility and compliance with the Official Rules, there will be six (6) total potential winners (“Winners”, each a “Winner”).
- 3.2. Prize. Prizes available depend on the Entry Period in which the Entry was received. Each prize described in section 3.3 through 3.8 is individually referred to as a “Prize” and collectively as “Prizes.” Potential Winners for Entry Period 1 through 6 will be randomly selected from all eligible

Entries for that Entry Period after the conclusion of each of the Entry Periods. The Prizes are as follows:

3.2.1. **Entry Period 1:** one (1) Raiders themed merchandise package, which includes one (1) beanie, one (1) scarf, and one (1) blanket from the Raider Image (ARV: \$150).

3.2.2. **Entry Period 2:** one (1) mini-helmet autographed by a current Raiders player (ARV: \$1,500).

3.2.3. **Entry Period 3:** one (1) autographed Raiders Ashton Jeanty jersey (ARV: \$1,500).

3.2.4. **Entry Period 4:** one (1) autographed Raiders Brock Bowers jersey (ARV: \$1,500).

3.2.5. **Entry Period 5:** one (1) autographed Raiders Maxx Crosby jersey (ARV: \$1,500).

3.2.6. **Entry Period 6:** two (2) tickets to the Raiders v. Kansas City Week 18 game at Allegiant Stadium, the tickets to be used by Winner and one (1) companion. Exact game date to be determined by the National Football League (ARV: \$700).

3.3. **Total (ARV) of the Prizes.** The total ARV of the Prizes to be awarded as part of the Sweepstakes is (\$6,850). The ARV for each Prize is an estimate made before the Sweepstakes begins. If the actual retail value of a Prize is less than or greater than the stated ARV, the Prize Winner will not receive the difference.

3.4. **Odds of Winning.** Odds of winning depend on the number of eligible Entries received during each Entry Period.

4. PRIZE CONDITIONS.

4.1. General Prize Conditions:

4.1.1. No more than one (1) Prize will be awarded per person for the Sweepstakes. A potential Winner is subject to verification by Sponsor, whose decision is final. A Prize cannot be transferred, redeemed for cash or substituted by an Entrant. All federal, state, provincial and local taxes, and all costs and expenses, related to the acceptance or use of the Prize, and not specified herein as being provided, are the sole responsibility of the Winner. Any required tax reporting forms will be furnished to the appropriate authorities. Sponsor reserves the right in its sole and absolute discretion to award a substitute of equal or greater estimated value if a Prize described in these Rules is unavailable or cannot be awarded, in whole or in part, for any reason. That determination is final and binding and cannot be appealed. Sponsor makes no representation or warranty concerning the appearance, safety or performance of any Prize awarded.

4.1.2. Sponsor reserves the right to determine if and how the Prize will be delivered to the potential Winner. Prize may be claimed in and shipped to an address in the 50 United States and/or the District of Columbia except for Florida, New York, and Rhode Island, except in Sponsor's sole and absolute discretion. A Prize may be delivered to the Winner by regular mail, United Postal Service or courier such as Federal Express or any other delivery method at Sponsor's sole and absolute discretion. Type of delivery service will be at sole and absolute discretion of Sponsor. Sponsor estimates that Prize delivery will take approximately 6-8 weeks for delivery after Winner's verification. Sponsor is not responsible for and will not replace any lost, mutilated or stolen Prize. Sponsor assumes no liability for non-deliverability.

4.1.3. In the event that the Sweepstakes is cancelled or postponed by Sponsor for any reason whatsoever, the Prize(s) (or its equivalent ARV) shall not be awarded except and solely to

the extent decided by Sponsor in their sole and absolute discretion or as otherwise required by law. Sponsor shall have no responsibility or obligation to any Winner or a potential Winner who is unable or unavailable to, or who does not for any reason, accept or utilize the Prize. In the event of non-compliance with these Official Rules or any Prize is unclaimed, the Prize will be forfeited. A forfeited Prize may be awarded to an alternate potential Winner, at Sponsor's sole and absolute discretion.

4.1.4. EACH PRIZE IS AWARDED AS IS AND WITHOUT WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. SOME JURISDICTIONS MAY NOT ALLOW (OR MAY LIMIT) DISCLAIMERS OF CERTAIN WARRANTIES, IN WHICH CASE THE FOREGOING DISCLAIMERS WILL BE ENFORCED TO THE MAXIMUM EXTENT PERMITTED BY LAW.

4.1.5. Prizes that include tickets, tours, trips, experiences, or other Prizes must be taken or utilized on date specified by Sponsor or the applicable Prize will be forfeited, and Sponsor will have no further obligation to such Winner. Sponsor reserves right to change dates. Winner is responsible for all other costs and expenses not expressly stated in the Rules, including without limitation, incidentals and transportation, if not included. Winner is subject to all Allegiant Stadium, other NFL venue, and Sponsor Rules, procedures, and code of conduct when participating in any Prize experience, and Sponsor reserves the right to require all participants to complete and execute Sponsor's standard indemnity/waiver agreement prior to participating in any Grand Prize as applicable.

4.1.6. Prizes that include tickets are subject to certain terms and conditions as specified thereon. Seat locations will be determined by Sponsor. Winner and his or her companion must comply with all venue rules and regulations. Failure to do so may result in forfeiture of such portion of the Prize.

5. HOW TO ENTER.

Entrants may enter the Sweepstakes during the Sweepstakes Period by visiting the Raiders App and completing the below steps during one (1) or more Entry Periods. An eligible Entry will be entered for that specific Entry Period in which the Entry was received. Any non-winning Entries from an Entry Period will not roll over into subsequent Entry Periods.

- 5.1. Download and open the Raiders App, the Sweepstakes is open only to people who have the Raiders App downloaded. If You already have a profile, log in using Your existing credentials. If You don't have a profile, create one by following the on-screen instructions to sign up and create an account. The Raiders App is free to download on the Google Play here: <https://play.google.com/store/apps/details?id=com.yinzcam.nfl.raiders> or the App Store here: <https://apps.apple.com/us/app/raiders-allegiant-stadium/id672521799>.
- 5.2. An "Exclusive Drops" button will appear on the homepage of the Raiders App. Tap the "Exclusive Drops" button to view the drops page. Tap the relevant drop you'd like to join during the corresponding Entry Period in order to join the Sweepstakes promotion. By tapping "Enter Now," You will be prompted to agree to the Official Rules and then be placed into a virtual Drop Room (a chat-room style environment) where a countdown clock will be displayed.

- 5.3. During each Entry Period, remain in the Drop Room until the countdown timer reaches zero. When the timer reaches zero, Sponsor via the YinzCam system will select one (1) potential Winner from all eligible Entrants who are present in the Drop Room at the time for each Entry Period.
- 5.4. For each Entry Period, once the countdown reaches zero: All entrants in the Drop Room will receive a notification stating, "you lost," except for the one (1) randomly selected potential Winner. The potential Winner will receive a notification stating, "You won" and Sponsor will reach out to the potential Winner on or around December 19, 2025.
- 5.5. Limit one (1) Entry per person during each Entry Period. Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete or inaccurate Entries are void. All Entries must include a valid email address for the Entrant.
- 5.6. In the event of a dispute regarding Entries received from multiple users having the same email or social media account (when applicable), the authorized subscriber of the email or social media account at the time of entry will be deemed to be the Entrant and must comply with these Rules. Authorized account subscriber is the natural person who is assigned the email address or social media account by the Internet Service Provider (ISP), on-line service provider, or other organization responsible for assigning email addresses or the social media account in question.
- 5.7. No Automated Entries. All automated or robotic Entries submitted by individuals or organizations will be disqualified. All Entries by Entrants must be made manually by such Entrants. Any attempt by an Entrant to submit multiple Entries by using multiple/different email addresses, phone numbers, identities, registrations, logins or any other methods will void such Entrant's Entries, and that Entrant may be disqualified. Final eligibility for the award of any Prize is subject to the eligibility verification of these Rules. All Entries must be received by the end of applicable Entry Period to be eligible for the Prize associated with that Entry Period.

6. WINNER SELECTION AND NOTIFICATION.

- 6.1. **A Winner in the Sweepstakes is only a potential Winner subject to notification, verification, acceptance of such Prize, and full compliance with these Official Rules.** On or about December 18, 2025, at the close of each Entry Period, a potential Winner will be selected randomly from eligible Entries. Potential Winners will be contacted on or around December 19, 2025 with details on how to claim their Prize.
- 6.2. The potential Winner will be awarded the Prize subject to verification of eligibility and compliance with the terms of these Official Rules. If the potential Winner fails to complete the Prize documents as set forth in Section 6.3 within forty-eight (48) hours of notification, the potential Winner may be disqualified at Sponsor's sole and absolute discretion. In the event the potential Winner is disqualified, Sponsor retains the right to select an alternate potential Winner by random selection from all remaining Entries, subject to compliance with the verification of eligibility requirements. Within forty-eight (48) hours of the secondary drawing, the alternate potential Winner will also be contacted at the email address associated with their Raiders profile on the Raiders mobile App. If the alternate potential Winner of the Prize fails to respond to the verification email within forty-eight (48) hours of notification or the email notification is returned as undeliverable after two (2) attempts, the alternate potential Winner of the Prize may be disqualified at Sponsor's sole and absolute discretion. In the event the potential Winner of the Prize is disqualified for any reason, Sponsor may terminate the Sweepstakes without a Winner at their sole and absolute discretion and subject to applicable law.

- 6.3. Sponsor is not responsible for any delay or failure to receive notification for any reason, including inactive account(s), technical difficulties associated therewith, or an Entrant's failure to adequately monitor the Sponsor's App and/or the Drop Room. The potential Winner may be required to sign and return an affidavit or declaration of eligibility and release of liability, and a publicity release on behalf of themselves and their child (collectively "the Prize Claim Documents"). Further, the potential Winner may also be required to complete and file an IRS Form 1099 or W-9 with the Internal Revenue Service and/ or provide their Social Security number or tax ID for tax reporting purposes if Sponsor is required to file an IRS Form 1099 or W-9 with the Internal Revenue Service for the fair market value of a Prize awarded and accepted. No substitution or transfer of a Prize is permitted except by Sponsor.

7. INTELLECTUAL PROPERTY OWNERSHIP.

Entrant hereby acknowledges and agrees that, in the event the Sweepstakes requires or permits submission of any content by Entrant, including but not limited to Entrant's photograph, artwork, text or other content ("Content"), all such Content submitted by Entrant shall be deemed a 'work made for hire', as defined in the United States Copyright Act. Entrant agrees that Sponsor shall be the exclusive owner of such Content and all rights therein. Sponsor's ownership includes without limitation the rights to: (i) exhibit, broadcast, use, reproduce, distribute, perform and license others to use all or any part of the Content; (ii) edit or modify the Content in any manner, or combine same with any other materials; and (iii) use and license third parties to use the Content and/or any portion thereof in any manner of exploitation and, in the case of (i), (ii) or (iii), in any digital, print or other medium whether now known or hereafter discovered, worldwide and in perpetuity with no obligation of further consideration or of notice, review or approval.

8. PRIVACY.

- 8.1. Personally identifiable information ("PII") that is submitted by Entrant as part of this Sweepstakes will be used to administer the Sweepstakes, select and announce the Winner. Entrant hereby waives any claims that Entrant may have or acquire against the Sponsor for libel, slander, invasion of privacy, copyright or trademark violation, moral rights, right of publicity, rights of privacy, or false light arising out of or in connection with such use. Entrant agrees that this is a waiver of privacy rights and constitutes a valid consent to uses of any PII as may be required under applicable data protection laws. Any PII that You provide in participating in the Sweepstakes is subject to the privacy policies of the Sponsor and YinzCam. Please review the Sponsor privacy policy at [Raiders Privacy Policy](#). By entering the Sweepstakes, You grant Sponsor and YinzCam permission to share Your email address and any other PII with the other Sweepstakes partners for the purpose of administration and Prize fulfillment, including use in a publicly available Winners' list. Winner, by acceptance of Prize, except where legally prohibited, grants permission for Sponsor and its designees to use his/her name, address (city and state), photograph, voice and other likeness and Prize information for advertising, trade and promotional purposes without further compensation, in all media (including digital media) now known or hereafter discovered, worldwide in perpetuity, without notice or review or approval. Notwithstanding anything to the contrary set forth in these Official Rules, Sponsor will not collect or use the name, photograph, image, likeness, voice, or opinions of any child 13 years of age or under without prior verifiable consent from such child's parent or legal guardian.
- 8.2. BY ENTERING THIS CONTEST, PARTICIPANT ACKNOWLEDGES AND AGREES, WHEN APPLICABLE THAT THE PARTICIPANTS HAVE READ AND CONSENT TO SPONSOR'S PRIVACY POLICY.

PARTICIPANTS FURTHER ACKNOWLEDGE THAT A PARTICIPANT'S PERSONAL IDENTIFYING INFORMATION MAY BE DISCLOSED TO THIRD PARTIES INCLUDING, WITHOUT LIMITATION, PLACING YOUR NAME ON A WINNERS' LIST.

9. COMMUNITY GUIDELINES.

- 9.1. Any language or submissions to the Sweepstakes must comply with the Rules, including this Section 9. When participating in the Sweepstakes, You must treat all Entrants with kindness and good sportsmanship, and You must refrain from:
 - 9.1.1. Fighting, taunting, instigating, inciting, or encouraging any action that may harm, endanger, threaten, or bring discomfort to anyone.
 - 9.1.2. Use of foul, abusive, or obscene language and/or gestures, including the use of language or gestures concerning a person's race, ethnicity, color, gender, religion, creed, disability, age, sexual orientation, gender identity/expression or national origin.
 - 9.1.3. Any action that is illegal, unruly, causes a disruption, creates an unsafe environment, or interferes with the Sweepstakes, including any conduct deemed inappropriate or dangerous to fans, players, participants, officials, or stadium staff.
 - 9.1.4. Actions that impair others' ability to enjoy the Sweepstakes, including mistreatment of other entrants, physical or verbal abuse, harassment, profanity, confrontation, intimidation, or threatening and irresponsible behavior.
- 9.2. Further, all Entrant submissions, posts, or content related to the Sweepstakes must comply with the following restriction. You must refrain from submitting:
 - 9.2.1. Content that contains personal information, including without limitation, name, email address, social security information, credit or debit card information, telephone number, etc.
 - 9.2.2. Content that may violate or infringe any patent, trademark, trade secret, copyright, right of publicity, or other intellectual property or proprietary rights of any party.
 - 9.2.3. Content containing advertising, campaign materials, promotional materials, spam, or other forms of commercial solicitation.
 - 9.2.4. Content containing spyware, malware, viruses, worms, encrypted messages, or any downloadable items.
 - 9.2.5. Content that is objectionable or restricts or inhibits any person from enjoying Sponsor's App, including, without limitation, use of all capital letters or continuous posting of repetitive comments.
 - 9.2.6. Content that is unlawful, libelous, defamatory, obscene, sexually explicit, harmful to minors, offensive, lewd, vulgar, suggestive, harassing, threatening, tortious, invasive of another's privacy, abusive, inflammatory, hateful, fraudulent, or otherwise objectionable.
 - 9.2.7. Content that may expose Sponsor to harm or liability of any type.
- 9.3. Sponsor reserves the right to disqualify any potential Winner in violation of this Section 9.

10. GENERAL CONDITIONS.

Released Parties (as defined below) are not responsible for lost, late, incomplete, inaccurate, stolen, misdirected, undelivered, garbled, illegible or postage-due mail, Entries or email; or for lost,

interrupted or unavailable network, server, Internet Service Provider (ISP), Platform, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of Entries, the announcement of the Prize or in any Sweepstakes-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by other Entrants or third parties, tampering, hacking, or by any equipment or programming associated with or utilized in the Sweepstakes. Released Parties are not responsible for injury or damage to Entrants' or to any other person's computer related to or resulting from participating in this Sweepstakes or downloading materials from or use of the Platform. Should any portion of the Sweepstakes, in Sponsor's sole opinion, be compromised by virus, worms, bugs, non-authorized human intervention or other causes which, in the sole opinion of the Sponsor, corrupt or impair the administration, security, fairness or proper play, or submission of Entries, Sponsor reserves the right at its sole and absolute discretion to suspend, modify or terminate the Sweepstakes and, if terminated, at its sole and absolute discretion, select the potential Winner from all eligible, non-suspect Entries received prior to action taken or as otherwise deemed fair and appropriate by Sponsor. Entrants, by participating, agree that Raiders Football Club, LLC, LV Stadium Events Company, LLC, The Raider Image, LLC, LVR Real Property, LLC, The Oakland Raiders, a California limited partnership, Raiders Foundation NV, YinzCam, SNS Group and their respective parents, affiliates, subsidiaries and advertising and promotion agencies and all of their respective officers, partners, owners, members, managers, assignees, directors, employees, shareholders, successors, representatives and agents (collectively, "Released Parties") will have no liability whatsoever for, and shall be held harmless by Entrants against, any liability, for any injuries, losses or damages of any kind, including death, to persons, or property resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any Prize, including any travel/activity related thereto, or participation in this Sweepstakes. **CAUTION: ANY ATTEMPT TO DAMAGE THE PLATFORM OR TO UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE; SPONSOR WILL DISQUALIFY ANY SUCH INDIVIDUAL AND RESERVES THE RIGHT TO SEEK DAMAGES (INCLUDING ATTORNEYS' FEES) AND OTHER REMEDIES FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT PERMITTED BY LAW.**

11. DISPUTES, ARBITRATION AND CHOICE OF LAWS.
