

DIETZ & WATSON MEAT THE ROOKIES SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Eligibility

Sweepstakes is offered only in the United States to legal residents of Delaware, New Jersey, and Pennsylvania who are eighteen (18) years of age or older, as of the date of entry. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (the “Eagles”), Dietz & Watson, Inc. One (1) drawing in total will be conducted by the Eagles following the conclusion of the Sweepstakes Period and held on or about May 28, 2026. One (1) winner will be selected randomly by the Eagles from all eligible entries received during the Sweepstakes Period. Winner of the drawing will be notified by e-mail within approximately one (1) day of the drawing. If, after two (2) attempts, contact has not been made, prize will be forfeited, and an alternate winner may be randomly selected from the eligible entries received during the Sweepstakes Period. Fulfillment agent must speak with potential winner. Final designation as the winner depends on verification of eligibility as determined by Sponsor.

5. Prize/Odds

In accordance with these Official Rules, one (1) winner will be awarded the following prize: four (4) tickets (Approximate Retail Value (“ARV”) \$200) and four (4) pre-game sideline passes (ARV \$260) to a home game in which the Eagles play during the 2026 NFL pre-season at Lincoln Financial Field (the “Event”) and an autographed authentic Eagles helmet (ARV \$190). Total ARV \$650. Player autograph and Eagles pre-season home game and seat locations to be determined by Eagles in its sole discretion.
