

2026 EAGLES x ARENA CLUB VIP EXPERIENCE SWEEPSTAKES OFFICIAL RULES

Important: Please read these Official Rules before entering the 2026 Eagles x Arena Club VIP Experience Sweepstakes (the “Sweepstakes”).

By participating in this Sweepstakes, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. TRAVEL AND LODGING NOT INCLUDED.

BY CHECKING THE OPTIONAL AGREEMENT TO RECEIVE MARKETING EMAILS BOX UPON ENTERING THE SWEEPSTAKES, YOU AGREE TO RECEIVE EMAIL MARKETING COMMUNICATIONS FROM ARENA CLUB AND WILL RECEIVE A DISCOUNT CODE FOR \$10 OFF YOUR FIRST ARENA CLUB TRADING CARD PACK, VIA THE EMAIL ADDRESS PROVIDED IN YOUR ENTRY, REGARDLESS OF WHETHER YOU ARE SELECTED AS THE POTENTIAL WINNER. Sweepstakes void where prohibited by law. Subject to applicable federal, state, and local laws.

1. **Eligibility:** The Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia, excluding Rhode Island (the “Eligible Territory”), who are at least eighteen (18) years old (or the age of majority in their jurisdiction of residence, whichever is older). Directors, officers, members, managers, existing agents, representatives and employees of Arena Club, Inc. (“**Sponsor**”), Philadelphia Eagles, LLC (the “**Eagles**”), the National Football League (the “**NFL**”) and its member clubs, and any of their respective parent companies, affiliate companies, subsidiaries, agents, professional advisors, advertising, promotional, public relations, and fulfillment agencies, consultants, legal counsel, website providers, web masters, and immediate family members (immediate family members include spouses, parents, children, siblings, grandparents, and “step” child, wherever they may live) or members of their same households (whether related or not) of each are not eligible to win any prize. IF YOU DO NOT MEET THESE REQUIREMENTS, OR ANY OTHER ELIGIBILITY REQUIREMENTS IN THESE OFFICIAL RULES, YOU ARE NOT ELIGIBLE TO WIN A PRIZE. 2. **Sweepstakes Period:** The Sweepstakes starts at 12:00:00 p.m. Eastern Time (ET) on August 3, 2026, and ends at 11:59:59 p.m. ET on September 4, 2026 (the “**Sweepstakes Period**”). All entries must be received during the Sweepstakes Period and meet other requirements in these Official Rules to be eligible to win a

prize. Sponsor's or its designee's computer is the official time-keeping device for the Sweepstakes.

3. **How to Enter:** To enter, during the Sweepstakes Period, visit www.philadelphiaeagles.com/promotions/arena-club-sweepstakes and follow the instructions to enter the Sweepstakes. After following the link, click on the icon to access the registration form and enter your date of birth and country of residence, and then enter your first and last name, email address, zip code, and confirm that you have read and agree to these Official Rules. Upon completing the entry method, and subject to the conditions below, you will be automatically entered into the Sweepstakes and receive one entry into the Sweepstakes. Limit one entry per person during the Sweepstakes Period. Any attempts to obtain additional entries, including through multiple or duplicate accounts, will result in disqualification. All entrants who submit a valid entry during the Sweepstakes Period and opt-in to receive an email from Arena Club with a discount code will receive \$10 off their first Arena Club trading card pack, via the email address provided at entry, regardless of whether they are selected as the potential winner.

If participating in this Sweepstakes via your mobile device (which service may only be available via select devices and participating wireless carriers and is not required to enter), you may be charged for standard data use from your mobile device according to the terms in your wireless service provider's data plan. Normal airtime and carrier charges and other charges may apply to data use and will be billed on your wireless device bill or deducted from your pre-paid balance. All entries must be submitted by the individual entrant. Bulk or automated entries will be disqualified (including entries made using any script, macro, bot, or promotional service). Multiple participants are not permitted to share the same email account. 4. **Identity of Entrant:** In the event of a dispute about the identity of the entrant, entries will be declared made by the authorized account holder of the email address submitted with the entry. An “**authorized account holder**” means the natural person who is assigned to an email address by an Internet access provider, online service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. A potential winner may be required to provide Sponsor with proof that a potential winner is the authorized account holder of the account associated with the winning entry.
5. **Random Drawing:** Within three (3) days after the end of the Sweepstakes Period, one (1) potential winner will be randomly drawn from among all eligible entries. The odds of winning depend on the number of eligible entries received.
6. **Notification of Winner:** The potential winner will be notified via email address provided when entering the Sweepstakes on or about the date of the random drawing. To the fullest extent permitted by applicable law, Sponsor may require potential winner to sign and return, as specified by Sponsor, an Affidavit of Eligibility

However, after the selection of two (2) alternate winners, Sponsor may, in its sole discretion, abandon the selection of a winner for the Sweepstakes. 7. **Prize: One (1)** winner will receive two (2) tickets and two (2) pregame sideline passes to the Philadelphia Eagles vs. Washington Commanders game (the "**Game**"), scheduled to take place at Lincoln Financial Field on Sunday, September 13, 2026. Seat and sideline locations to be determined by Eagles in its sole discretion. In addition, at a separate date and time to be determined by Sponsor and Eagles in their sole discretion, Winner and one (1) guest will receive a guided tour of the Jefferson Health Training Complex and the opportunity to open one (1) Arena Club trading card pack in the Philadelphia Eagles' draft room (collectively, the "**Prize**"). The Prize does not include travel, lodging, food and beverage, gratuities, or other expenses not expressly stated above. Approximate Retail Value ("**ARV**") of the Prize: \$4,000 USD. Travel and accommodations and any other costs associated with attendance at the Game shall be the sole responsibility of winner.

Prize Restrictions: ALL FEDERAL, STATE AND LOCAL TAXES ASSOCIATED WITH THE RECEIPT OR USE OF ANY PRIZE ARE THE SOLE RESPONSIBILITY OF THE WINNER. Prizes are not transferable. No substitutions or exchanges of any prize (including for cash) will be permitted, except that Sponsor reserves the right to substitute a prize of comparable or greater value for any prize. The tour of the Jefferson Health Training Complex and the trading card pack opening in the Philadelphia Eagles' draft room will be scheduled by Sponsor and Eagles for a separate date and time than the Game, and must take place on such date determined by Sponsor and Eagles. The winner will be responsible for arriving at the designated meeting location(s) and time(s) communicated by the Sponsor. Failure to appear at any designated time and location may result in forfeiture of the applicable portion of the prize. Travel and accommodations and any other costs associated with attendance at the Jefferson Health Training Complex and/or Lincoln Financial Field shall be the sole responsibility of winner.
9. **Disclaimer:** Sponsor, Eagles, Eagles Stadium Operator, LLC, the NFL and its member professional clubs, and any of their respective parent companies, subsidiaries, affiliates, directors, officers, professional advisors, consultants, contractors, legal counsel, public relations firms, employees and advertising, fulfillment and marketing agencies (collectively, the "**Released Parties**") will not be responsible for: (a) any late, lost, misrouted, garbled or distorted or damaged transmissions or entries; (b) phone, electronic, hardware, software, network, Internet, or other computer or communications-related malfunctions or failures beyond Sponsor or the Released Parties' reasonable control; (c) any Sweepstakes disruptions, injuries, losses or damages caused by events beyond the reasonable control of Sponsor or the Released Parties by non-authorized human intervention; or (d) any printing or typographical errors in any materials associated with the Sweepstakes.
