

2026 IT'S MILLER TIME SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Eligibility

The 2026 It's Miller Time Sweepstakes ("Sweepstakes") is offered only in the United States to legal residents of Pennsylvania, New Jersey, Delaware, Maryland, and the District of Columbia, who are twenty-one (21) years of age or older as of the date of entry. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC ("Eagles"), Molson Coors Beverage Company USA LLC ("Molson Coors" or "Sponsor"), and any of their respective agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize. 2. Sweepstakes Period

Sweepstakes period begins on Monday, August 24, 2026 at 9:00:00 a.m. Eastern Time ("ET") and ends on the date set forth in the Drawing and Home Game Chart in Section 4 of these Official Rules and no later than Sunday, January 24, 2027 at 11:59:59 p.m. ET (the "Sweepstakes Period"). There will be up to twelve (12) entry periods (each, an "Entry Period") during the Sweepstakes Period as set forth in the chart below, and two (2) winners will be selected following the conclusion of each Entry Period.

3. Entry

You may enter by going to <https://forms.philadelphiaeagles.com/f/miller-sweepstakes>, clicking on the icon to access the entry form during the relevant Entry Period during the Sweepstakes Period and entering your date of birth, country of residence, name, zip code, e-mail address, phone number, and confirming that you are twenty-one (21) years of age or older and have read and agree to the Official Rules. Upon completing the entry method, and subject to the conditions below, you will automatically be entered into the Sweepstakes. Proof of entry submission does not equate to proof of receipt. Entrants agree to be bound by the Official Rules. The Eagles' computer shall be the official clock of the Sweepstakes.

LIMIT ONE (1) ENTRY PER PERSON DURING THE SWEEPSTAKES PERIOD (REGARDLESS OF WHETHER MORE THAN ONE (1) PERSON USES THE SAME E-MAIL ACCOUNT). If more than one (1) entry is submitted, only the first entry will be entered into the Sweepstakes, and all other entries will be disregarded. In the event of a dispute as to any entry, the authorized account holder of the e-mail address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address. The potential winners may be required to show proof of being the authorized account holder.

Any attempt by any person to submit more than the stated number of entries by using multiple/different accounts or any other methods will void that person's entry and that person will be disqualified. Automated entries (including but not limited to any entries submitted using any robot, script, macro or other automated service) are not permitted and will be disqualified.

The Eagles and/or Sponsor will prosecute any fraudulent activities to the fullest extent of the law. The Eagles and/or

Sponsor reserve the right to suspend or terminate this Sweepstakes without notice if, in the Eagles or Sponsor's sole discretion, the Sweepstakes becomes infected or otherwise corrupted.

4. Winner

Up to twelve (12) drawings in total will be conducted by the Eagles following the conclusion of the Sweepstakes Period.

Following the conclusion of each Entry Period, two (2) winners will be selected randomly at each drawing by the Eagles from all eligible entries received during that Entry Period. Non-winning entries from prior Entry Periods will automatically carry over to each subsequent Entry Period during the Sweepstakes Period. Winners of the drawing will be notified by e-mail and/or phone within approximately two (2) business days of the drawing. If, after two (2) attempts contact has not been made, prize will be forfeited, and an alternate winner may be randomly selected from the eligible entries received during the Entry Period. Final designation as a winner depends on verification of eligibility as determined by Eagles. Winners may not substitute or redeem prize for cash, but Eagles reserves the right to substitute prize with a prize of equal or greater value should the advertised prize become unavailable for any reason. Number of drawings and drawing dates are subject to change at Eagles' and Sponsor's sole discretion.

5. Prize/Odds

In accordance with these Official Rules, the following prize will be awarded to two (2) winners for each Entry Period (up to a total of fourteen (14) winners): two (2) tickets in the Miller Lite PHLite Deck to the Philadelphia Eagles home game scheduled to take place at Lincoln Financial Field as set forth in the

Drawing and Home Game Chart in Section 4 of these Official Rules (each, a “Game”). Approximate Retail Value (“ARV”) of each prize awarded during the 2026 NFL regular season: \$310 (\$155/ticket). ARV of each prize awarded during the 2026 NFL post-season: \$480 (\$240/ticket).

Odds of winning will be determined by the total number of eligible entries received during the Sweepstakes Period for each Entry Period drawing. No assignment, transfer or substitution of prize is permitted except by Sponsor or Eagles in the event of prize unavailability.
