

THAT DESERVES A CROWN CONTEST OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW. MUST BE 21 YEARS OF AGE OR OLDER TO SUBMIT A NOMINATION; MUST BE 25 YEARS OF AGE OR OLDER TO BE NOMINATED.

1. Eligibility

The That Deserves a Crown Contest (the “Contest”) is being offered only in the United States. Eligibility for individuals submitting a nomination in the Contest is limited to persons who are legal residents of Delaware, New Jersey or Pennsylvania and who are twenty-one (21) years of age or older, as of the date of entry (“Entrants”). Eligibility for nominees is limited to individuals who are legal residents of Delaware, New Jersey or Pennsylvania and who are twenty-five (25) years of age or older, as of the date of submission (“Nominees”). For clarity, Entrants cannot nominate themselves. If selected, Entrant and Nominee each will be asked to provide proof of eligibility in a format deemed acceptable to Eagles and Crown Royal.

Employees, owners, officers, directors, agents and representatives of Philadelphia Eagles, LLC (the “Eagles”), Diageo Americas, Inc. (“Crown Royal” or “Sponsor”), the NFL Entities (as defined below), Fanatics Retail Group Fulfillment, LLC (“Fanatics”) and any of their respective agencies, owners, members, subsidiaries and affiliates, advertising and promotion agencies or of alcohol beverage suppliers, importers, wholesalers, distributors, retailers, and individual retail licensees or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate either as Entrants or Nominees. By entering, you agree to these Official Rules and the decisions of the Eagles and Sponsor, which are final and binding in all respects. “NFL Entities” shall mean, collectively, NFL Ventures, L.P., NFL Ventures, Inc., NFL Productions LLC, NFL Enterprises LLC, NFL Properties LLC, NFL International LLC, all of the NFL Member Clubs, any successor or future entity that is, directly or indirectly, jointly owned and/or controlled by all or substantially all of the NFL member clubs under the NFL Constitution and each and all of their respective affiliates, subsidiaries, successors and assigns.

2. Contest Period

Contest period begins on Tuesday, August 18, 2026, at 10:00 a.m. Eastern Time and ends on Tuesday, December 1, 2026, at 11:59 p.m. Eastern Time (the “Contest Period”). There will be four (4) entry periods (“Entry Periods”) during the Contest Period. One (1) winner will be selected after the end of each Entry Period. The Eagles’ computer shall be the official clock of the Contest.

3. How to Nominate

To nominate a person for the Contest, eligible persons must go to <https://www.philadelphiaeagles.com/fans/deserves-a-crown> and click on the icon to access the entry form during the Contest Period. An Entrant must secure the consent of the person they wish to nominate for the Contest before doing so; and, as part of such consent, such Entrant should advise Nominee of the nature of the prize including their availability on one of the Eagles home game dates (as set forth below). To submit a complete and correct nomination entry (“entry”), an Entrant must enter his or her country of residence, name, e-mail address, zip code, and phone number, as well as the name of the Nominee, e-mail address of the Nominee and phone number of the Nominee. Entrants must also confirm that they are twenty-one (21) years of age or older, confirm that the Nominee is twenty-five (25) years of age or older, confirm they have secured the

consent of the person they wish to nominate for the Contest, and agree to be bound by these Official Rules. Next, in **250 words or less** explain why the Nominee should be recognized as a hero and how the Nominee is making a positive impact on their local community. Nomination must have been created by Entrant specifically for this Contest. **Entrant represents and warrants that, to the best of his/her knowledge and belief, the statements included in the nomination are true and accurate, with the understanding that the Eagles and Crown Royal are directly relying on such representation and warranty and would not have accepted the nomination or awarded a prize to the Nominee (if applicable) in the absence of same.**

Subject to the conditions below, the Nominee will automatically be entered into the Contest. Proof of entry submission does not equate to proof of receipt. Any effort by an Entrant to misrepresent himself or herself (or the identity of any Nominee) through the use of aliases or multiple e-mail addresses or telephone numbers or misrepresent his or her (or the Nominee's) eligibility, age or criteria for the Contest will disqualify that Entrant's nomination and possibly the Entrant's Nominee; however, disqualification shall not represent the sole remedy available to Eagles or Crown Royal under such circumstances. Entrants and Nominees agree to be bound by the Official Rules.

A nomination or entry may identify only one (1) person as the Nominee. An organization, association or entity cannot function as the Nominee. Only one (1) entry per Entrant shall be considered. If multiple entries are received for a single Nominee, only the highest scored nomination for such Nominee shall be considered. Any eligible entry submitted during one (1) Entry Period but not selected as the winner for that Entry Period will automatically be eligible for subsequent Entry Period(s). The Eagles reserves the right to disqualify any entries that it determines, in its sole discretion, contain inappropriate, improper, hateful or discriminatory content or language.

By submitting a nomination, Entrant and Nominee grant, without payment or consideration or further notice of any kind, Eagles and Crown Royal an unlimited, worldwide, royalty-free, perpetual, irrevocable, non-exclusive and freely transferrable license and right to publish, use, reproduce, modify, adapt, publicly perform, display, distribute, create derivative works from and otherwise disclose to third parties any part and all of such entry (including all written material and motion pictures, and all trademarks and logos of the Nominee included therein) for any purpose, whether commercial or noncommercial, anywhere, in any form of media, whether now known or later developed.

No responsibility is assumed for lost, late, incomplete, stolen, misdirected or illegible entry or for any computer, telephone, cable, network, satellite, electronic or Internet hardware or software malfunctions, failures, connections, availability or garbled or jumbled transmissions, or service provider/Internet/Web site/use net accessibility or availability, traffic congestion, or unauthorized human intervention. No mass entries or mechanically reproduced entries will be accepted. All entries become the exclusive property of the Eagles and Crown Royal and will not be returned or acknowledged. Any attempts by an individual to access the website via a bot script or other brute-force attack will result in that IP address becoming ineligible. The Eagles and/or Crown Royal will prosecute any fraudulent activities to the fullest extent of the law. The Eagles reserves the right to suspend or terminate this Contest without notice if it determines, in its sole discretion, that the Contest becomes infected or otherwise corrupted.

4. Winner

Four (4) Nominees will be selected as winners ("Winners") based on the essays that express why the Nominee is most deserving of being recognized as being a hero making a positive impact on

their local community, as determined by the Eagles and Sponsor in their sole discretion. There will be four (4) separate selections as set forth in the chart below, and one (1) Winner will be selected as set forth below from all eligible entries received during the applicable Entry Period. Non-winning entries will automatically be eligible for subsequent Entry Period(s).

Winners will be notified by email and/or phone within approximately forty-eight (48) hours of the selection. If, after two (2) attempts, contact has not been made, any potential prize will be forfeited, and an alternate winner will be selected from the remaining eligible entries received for the applicable Entry Period (including from any preceding Entry Period(s)), time permitting.
