

2026 EAGLES LANDING X VISIT DELCO SWEEPSTAKES – OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. AIRFARE NOT INCLUDED. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Eligibility

The 2026 Eagles Landing x Visit Delco Sweepstakes (“Sweepstakes”) is offered only in the United States to legal residents of the fifty (50) United States and the District of Columbia, except New York, Florida and Rhode Island, who are twenty-one (21) years of age or older (or the age of majority in the jurisdiction in which they reside, whichever is older) as of the date of entry. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (“Eagles”), The Brandywine Conference and Visitors Bureau, Inc. d/b/a Visit Delco, PA (“Visit Delco”) and any of their respective agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize. 2. Sweepstakes Period

Sweepstakes period begins on Monday, August 24, 2026 at 12:00 p.m. Eastern Time (“ET”) and ends on Thursday, December 10, 2026 at 5:00 p.m. ET (the “Sweepstakes Period”). The Eagles’ computer shall be the official clock of the Sweepstakes.

3. Entry

There are two (2) ways to enter:

- (a) During the Sweepstakes Period, you may enter by scanning the QR code on the co-branded coasters available at any participating Eagles Landing location throughout the United States. Upon scanning the QR code, an entrant will be taken to <https://www.philadelphiaeagles.com/visitdelcosweepstakes>, where they can enter into the Sweepstakes by completing the entry form with the following information: date of birth and country of residence, and then entering your first name, last name, zip code, e-mail address, and confirm that you have read and agree to the Official Rules. Subject to the conditions below, you will automatically be entered into the Sweepstakes. Proof of entry submission does not equate to proof of receipt. Entrants agree to be bound by the Official Rules. Eagles Landing locations are subject to change. - (b) You also may enter by going directly to <https://www.philadelphiaeagles.com/visitdelcosweepstakes>, clicking on the icon to access the entry form during the Sweepstakes Period and entering your date of birth and country of residence, and then entering your first name, last name, zip code, e-mail address, and confirm that you have read and agree to the Official Rules. Upon completing the entry method, and subject to the conditions below, you will automatically be entered into the Sweepstakes. Proof of entry submission does not equate to proof of receipt. Entrants agree to be bound by the Official Rules.

IF YOU ACCESS THE EAGLES WEB SITE USING A MOBILE DEVICE, DATA RATES MAY APPLY.

No mass entries or mechanically reproduced entries will be accepted. All entries become the exclusive property of the Eagles and will not be returned or acknowledged. Any attempts by an individual to access the Sweepstakes via a bot script or other brute-force attack will result in that IP address becoming ineligible. The Eagles will prosecute any fraudulent activities to the fullest extent of the law. The Eagles reserves the right to suspend or terminate this Sweepstakes without notice if, in the Eagles sole discretion, the Sweepstakes becomes infected or otherwise corrupted.

4. Winner

One (1) drawing in total will be conducted by the Eagles following the conclusion of the Sweepstakes Period and held on or about Friday, December 11, 2026. One (1) winner will be selected randomly by the Eagles from all eligible entries received during the Sweepstakes Period (the “Winner”). Winner will be notified by e-mail within approximately two (2) days of the drawing. If, after two (2) attempts contact has not been made, prize will be forfeited and an alternate winner may be randomly selected from the eligible entries received during the Sweepstakes Period. Final designation as the Winner depends on verification of eligibility as determined by Eagles. Winner may not substitute or redeem any prize for cash, but the Eagles reserves the right to substitute any prize with a prize of equal or greater value should the advertised prize become unavailable for any reason.

5. Prize/Odds

In accordance with these Official Rules, one (1) winner will be awarded the following prize: two (2) tickets to the Philadelphia Eagles vs. Seattle Seahawks game scheduled to take place at Lincoln Financial Field on December 19, 2026 (the “Game”) (Approximate Retail Value “ARV” is \$430 (\$215/ticket)). Prize also consists of standard double-occupancy hotel accommodations (one (1) room) for two (2) nights at The Inn at Swarthmore, located at 10 S. Chester Road, Swarthmore, PA 19081 (ARV is \$578) provided by Visit Delco (the “Hotel”) and round-trip ground transportation from the Hotel for Winner and one (1) guest to and from the Game only (ARV is \$200) (collectively, the Prize). Total ARV of Prize is \$1208.

Seat locations to be determined by Eagles in its sole discretion. If Winner’s guest is a minor, Winner must be the parent or legal guardian of such guest. Hotel check-in will be on Friday, December 18, 2026 and Hotel check-out will be on Sunday, December 20, 2026. Airfare and other travel expenses, other than those explicitly mentioned above, and any other costs associated with attendance at the Game, including without limitation meals, tips and gratuities, taxes and fees associated with the receipt and/or use of the tickets, are not included in the Prize and shall be the sole responsibility of Winner. Eagles reserves the right to remove or deny entry to any event or component of the prize if, in its sole discretion, the Winner’s behavior or the behavior of such individual’s guest is disruptive, belligerent, abusive, intended to annoy, threaten or harass, any other person at the venue or event. Under such circumstances, the individual (and/or guest) may be asked to leave and may forfeit all remaining portions of the prize. Tickets are subject to certain terms and conditions

as specified therein. Resale of tickets is prohibited. In the event that the Game or any related event associated with the prize does not occur, Eagles reserves the right to cancel and the Winner may not receive any prize.
