

2026 CALEB WILLIAMS X MADDEN POSTER SWEEPSTAKES
OFFICIAL RULES

HOW TO ENTER: The entry period for the Chicago Bears Madden Poster Sweepstakes (the "Sweepstakes") begins August 26, 2026 at 10 a.m. central standard time ("CT") and ends August 26, 2026 11:59 p.m. CT ("Entry Period"). To enter the Sweepstakes, Fill out the Sweepstakes entry form ("Entry Form") during the Entry Period. Limit one entry per person.
