

2026-2027 Rep Your Nation Promotion Rules

THERE IS NO PURCHASE OR PAYMENT NECESSARY IN ORDER TO ENTER OR WIN THE PROMOTION. ANY PURCHASE OR PAYMENT OF ANY KIND THAT YOU MAKE WILL NOT INCREASE YOUR CHANCES OF WINNING. THE PROMOTION IS SUBJECT TO ALL APPLICABLE FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS, AND IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW. PLEASE READ THESE PROMOTION RULES CAREFULLY BEFORE ENTERING INTO THE PROMOTION.

Welcome to the 2026–2027 Rep Your Nation Promotion (“**Contest**” (defined in Section 1.1) and “**Sweepstakes**” (defined in Section 1.2), Contest and Sweepstakes collectively referred to as the “**Promotion**”), sponsored by Raiders Football Club, LLC and Allegiant Air, LLC (collectively, “**Sponsor**”). The Promotion starts on September 13, 2026 at 9:00 am Pacific Time (“**PT**”) and ends January 4, 2027 12:00 am PT (the “**Promotion Period**”). Pacific Time shall control for all purposes of the Promotion. Wit’s computer shall be the official clock for purposes of the Promotion.

This Promotion is powered and administered by Wit Labs, Inc. (“**Wit**” or the “**Administrator**”) on behalf of Sponsor, and is accessible via the Wit website at <https://web.witcontests.com/raiders/sweepstakes/vote/raiders-rep-your-nation-260913> (the “**Platform**”). For the avoidance of doubt, Wit administers and provides the Platform for the Promotion but is not the sponsor for the Promotion. As a legal requirement for participating in this Promotion as a participant or voter (collectively, “**You**”), You hereby agree to be bound by these Promotion Rules (the “**Official Rules**” or “**Rules**”) which form a legal contract by and between You and Sponsor. If You do not agree and consent to these Rules, please do not enter the Promotion or use the Platform. To participate in the Promotion, You must agree to the Wit [Terms of Use](#). The Promotion is subject to applicable federal, state, provincial, municipal, territorial, and local laws and regulations and is **VOID WHERE PROHIBITED OR RESTRICTED BY LAW**. Winning and receiving a prize (each a “**Prize**,” collectively, the “**Prizes**,” as further described in Section 5) is contingent upon fulfilling all requirements set forth herein.

1. PROMOTION.

The Promotion is comprised of a Contest and Sweepstakes:

- 1.1. Contest Description. Three (3) participants (each a “**Participant**”) have been invited by Sponsor to participate in a contest for the Raiders Fan of the Year (“**Contest**”). The Contest is comprised of six (6) challenges (each a “**Challenge**,” collectively, the “**Challenges**”), each worth a fixed number of points, which will be tracked on a leaderboard hosted on Raiders.com, and the Participant with the most points at the completion of the Contest wins the Contest grand prize (“**Contest Grand Prize**,” as further described in Section 5).
- 1.2. Sweepstakes Description. Eligible individuals (as defined in Section 3) who agree to prepare and submit the required vote form for the Fan Voting Challenge (a “**Vote**,” collectively the “**Votes**”) in accordance with the Official Rules as described herein will be deemed a voter (“**Voter**”) and entered into a drawing (the “**Sweepstakes**”) for the Sweepstakes prize (the “**Sweepstakes Prize**,” as further described in Section 5).

- 1.3. Rules. By participating in the Promotion, You unconditionally accept and agree to comply with and abide by these Rules, waive any right to claim ambiguity in the Rules or Promotion related advertising/materials and agree that the decisions of Wit or Sponsor with respect to the Promotion and any Prize awards shall be final and binding in all respects. Sponsor reserves the right to alter the terms of these Official Rules at their discretion. Any such changes to the Official Rules will be prominently displayed and any conflicting changes to the Official Rules will be superseded by the most recent version of the Official Rules.
- 1.4. Promotion Administration. Wit, on behalf of Sponsor, performs the collection, submission or processing of Votes, notification of potential winners, as well as the overall administration of the Promotion. Voter may contact Wit with any questions, comments or problems related to administration of the Promotion. Wit may be reached by email at raiders@witcontests.com during the Promotion Period.

2. THE CONTEST.

Subject to verification of eligibility and compliance with the Official Rules, there will be one (1) Contest winner who wins the Contest Grand Prize. The three (3) Participants who have been invited to participate in the Contest will compete in six (6) Challenges each worth a fixed number of points as set forth below. Points will be tracked on a leaderboard hosted on Raiders.com, and the Participant with the most cumulative points at the completion of the Contest wins the Contest Grand Prize.

2.1. The Challenges.

2.1.1. *Challenge 1 – Fan Voting*. The Raiders will produce three (3) short video clips (one per Participant) featuring each Participant's Raiders fandom story. Clips will be hosted on the Wit landing page, at <https://web.witcontests.com/raiders/sweepstakes/vote/raiders-rep-your-nation-260913> (the "**Promotion Landing Page**") where the public can vote for their favorite Participant. The Fan Voting Challenge opens on September 13, 2026 at 9:00 am PT and closes on December 13, 2026 at 11:59 pm PT (the "**Voting Period**"). The Participant who receives the most Votes wins the Fan Voting Challenge. Wit will assist with tabulating Votes. In conjunction with this Challenge, an embedded Sweepstakes will be conducted whereby Voters in the Fan Voting Challenge will be entered into a separate random drawing, as further described in Section 3 below.

2.1.2. *Challenge 2 –Name Game (Pre-Filmed)*. Each Participant will compete in a timed challenge that tests Raiders-related knowledge and recall. Participants will be scored based on the number of qualifying responses provided during a twenty (20) second round. The Participant with the highest score wins the Challenge. This Challenge airs on October 25, 2026, at the Raiders home game.

2.1.3. *Challenge 3 – QB Challenge (Pre-Filmed at Allegiant Stadium or Raiders Headquarters)*. Each Participant will throw a regulation NFL football to hit as many targets as possible in

ninety (90) seconds. The Participant who hits the most targets wins the Challenge. This Challenge airs on November 15, 2026 (at the Raiders home game).

2.1.4. *Challenge 4 – Nonstop Paper Flight (Pre-Filmed)*. Each Participant will be given five (5) minutes to build a paper airplane from materials provided by Sponsor. All planes will be launched from the same yard marker, and the plane that travels the furthest distance wins the Challenge. This Challenge airs on December 13, 2026 (at the Raiders home game).

2.1.5. *Challenge 5 – Trivia/Puzzle (Live at Allegiant Stadium, December 20, 2026)*. Each Participant will complete a Raiders-themed trivia puzzle challenge in which three (3) puzzle blocks must be correctly stacked using Raiders-related knowledge. The Participant who correctly completes the puzzle in the fastest verified time will win the Challenge. The Challenge will be displayed live on the in-stadium videoboards at Allegiant Stadium.

2.1.6. *Challenge 6 – Just Win Baby: Championship Competition (Live at Allegiant Stadium, December 27, 2026) – DOUBLE POINTS*. Each Participant will be positioned on the one end of the endzone and outfitted with the same size football pads, jersey, helmet, and football. Each Participant will suit up, pick up the football, and race to the opposite end of the end zone. The first Participant to reach the end zone wins the Challenge.

2.2. Leaderboard Updates. The Contest leaderboard will be updated following each Challenge, and the results of each Challenge will be reflected on the leaderboard no later than the dates set forth below:

2.2.1. *Challenge 1 (Fan Voting)*: December 21, 2026

2.2.2. *Challenge 2 (Hall of Fame Name Game)*: November 2, 2026

2.2.3. *Challenge 3 (QB Challenge)*: November 23, 2026

2.2.4. *Challenge 4 (Nonstop Paper Flight)*: December 21, 2026

2.2.5. *Challenge 5 (Trivia/Puzzle)*: December 28, 2026

2.2.6. *Challenge 6 (Championship Competition)*: January 4, 2027 (Final leaderboard and Grand Prize winner determination)

2.3. Scoring for the Challenges. The three (3) Participants will be scored in each of the Challenges as follows:

2.3.1. *Challenges 1–5:*

1st Place = 300 points

2nd Place = 200 points

3rd Place = 100 points

2.3.2. *Challenge 6 - Championship Competition (Double Points):*

1st Place = 600 points

2nd Place = 400 points

3rd Place = 200 points

- 2.4. Tiebreaker. If two (2) or more Participants finish with the same total point value at the end of the each Contest, the Contest winner will be determined by a coin toss(es).

3. THE SWEEPSTAKES.

- 3.1. HOW TO ENTER. In conjunction with Challenge 1 – Fan Voting, eligible Voters may enter the Sweepstakes during the Voting Period by visiting the Wit website and doing the following.

3.1.1. Visit the Promotion Landing Page and complete a Promotion vote form, which requires the following information and affirmative actions from each Voter:

3.1.1.1. Selecting Voter's favorite Participant as displayed on the entry form;

3.1.1.2. Preferred email address for contact and notification purposes;

3.1.1.3. First and last name;

3.1.1.4. Checking the box to verify that the Voter is at least eighteen (18) years of age; and

3.1.1.5. Checking the box to verify that the Voter has read and agreed to these Official Rules, Wit's Privacy Policy, and consents to having his or her personal information shared with Sponsor.

3.1.2. By successfully transmitting a completed online vote form as directed after visiting the Promotion Landing Page, You will be entered into the Promotion. Limit one (1) Vote per email address, per day.

3.1.3. Voters must fully complete and submit all non-optional data requested on the online vote form to be eligible. Incomplete or inaccurate Votes are void. All Votes must include a valid email address for the Voter.

3.1.4. In the event of a dispute regarding Votes received from multiple users having the same email, the authorized subscriber of the email account at the time of Vote will be deemed to be the Voter and must comply with these Rules. Authorized account subscriber is the natural person who is assigned the email address or social media account by the Internet Service Provider (ISP), on-line service provider, or other organization responsible for assigning email addresses or the social media account in question.

- 3.2. NO AUTOMATED VOTES. All automated or robotic Votes submitted by individuals or organizations will be disqualified. All Votes by Voters must be made manually by such Voters. Any attempt by a Voter to submit multiple Votes by using multiple/different email addresses, identities, registrations, logins or any other methods will void such Voter's Votes and that Voter may be disqualified. Final eligibility for the award of any Prize is subject to the eligibility verification of these Rules. All Votes must be submitted by the end of the Voting Period in order to participate.

3.3. SWEEPSTAKES ELIGIBILITY.

3.3.1. *Eligible Voters.* The Sweepstakes is open only to: (i) legal residents of all states in the United States, except for Florida, New York, and Rhode Island, who are 18 years of age or older as of the date of vote; (ii) who are not a person barred from participation in the Promotion; and (iii) who at all times abide by these Official Rules. Individuals may be asked to provide documentation verifying eligibility.

3.3.2. *Non-eligible Persons.* Sponsor, its parents, subsidiaries, affiliates, distributors, retailers, sales representatives, Promotion administrator, advertising and promotion agencies; and each of their respective officers, directors, employees, consultants and contractors (the “**Sponsor Entities**”), are ineligible to enter the Promotion or win any related Prize. “**Household Members**” means those people who share the same residence as any Sponsor Entity for at least three (3) months during a given year. “**Immediate Family Members**” means parents, step-parents, legal guardians, children, step-children, siblings, step-siblings or spouses of any Sponsor Entity. Household Members and Immediate Family Members of any Sponsor Entities are also not eligible to enter or win the Sweepstakes.

4. **WINNER SELECTION AND NOTIFICATION.**

Winners in the Promotion are only potential winners subject to notification, verification and acceptance of such Prizes.

4.1. Contest Winner. At the completion of all six (6) Challenges, the Participant with the most cumulative points will be selected as the potential Contest Grand Prize winner. The final Contest leaderboard will be finalized on or about January 7, 2027.

4.2. Sweepstakes Winner. On or about January 7, 2027, one (1) potential Sweepstakes winner will be selected by random drawing from all eligible Votes received during the Voting Period for the Sweepstakes Prize (as defined in 5).

4.3. Winner Notification. Within seven (7) days of the random drawing and Vote tabulation, Wit will contact the potential winner of the Sweepstakes Prize at the email addresses provided at the conclusion of the Promotion Period or otherwise provided to Sponsor. The potential winner will be awarded the Prizes subject to verification of eligibility and compliance with the terms of these Official Rules. If the potential winner fails to respond to the verification email within forty-eight (48) hours of notification or the email notification is returned as undeliverable after two (2) attempts, the potential winner may be disqualified at Sponsor’s sole discretion. In the event the potential winner is disqualified for any reason, Sponsor may award the Prize to an alternate potential winner. For the Contest Grand Prize, the potential winner will be determined at the end of Challenge 6 on January 4, 2027 based on the highest number of cumulative points (as outlined in Section 2.3 above). If an alternate potential winner may need to be determined, the alternate potential winner may be the Participant with the next highest cumulative number of points. For the Sweepstakes Prize, the alternate potential winner may be selected by random drawing from among all remaining eligible Votes. Within twenty-four (24) hours of the secondary drawing, the

alternate potential winner will also be contacted at the email address provided at the time of vote or otherwise provided to Sponsor. If the alternate potential winner fails to respond to the verification email within forty-eight (48) hours of notification or the email notification is returned as undeliverable after two (2) attempts, the alternate potential winner may be disqualified at Sponsor's sole discretion. In the event the potential winner is disqualified for any reason, Sponsor and/ or Wit retain the right to repeat this process until an alternate potential winner complies with the verification of eligibility requirements or to terminate the promotion without a winner at their sole discretion and subject to applicable law.

- 4.4. Prize Claim Documents. Sponsor and Wit are not responsible for any delay or failure to receive notification for any reason, including inactive account(s), technical difficulties associated therewith, or a Voter's failure to adequately monitor the Wit Landing Page, app or website. The potential winner may be required to sign and return an affidavit of eligibility and release of liability, and a publicity release (collectively "**the Prize Claim Documents**"). Further, the potential winners may also be required to complete and file an IRS Form 1099 or W-9 with the Internal Revenue Service and/ or provide their Social Security number or tax ID for tax reporting purposes if Sponsor is required to file an IRS Form 1099 or W-9 with the Internal Revenue Service for the fair market value of a Prize awarded and accepted. In the case of Prizes that include guests, the potential winner understands and agrees that, as a condition of participation in the Prize, guests may be required to sign and return a similar release of liability and a publicity release that grants Sponsor the same permissions for use of their names, likenesses and other information as set out in Section 9 below, and that refusal to sign those releases may result in guest being denied the ability to participate in the Prize. No substitution or transfer of a Prize is permitted except by Sponsor.

5. PRIZES AND ODDS OF WINNING.

- 5.1 Prizes Awarded. Subject to verification of eligibility and compliance with the Official Rules, there will be one (1) Contest winner who wins the Contest Grand Prize and one (1) Sweepstakes winner who wins the Sweepstakes Prize. For the Contest Grand Prize listed below, one (1) potential Contest winner will be selected based upon that Participant who received the most cumulative points at the end of the Promotion Period. For the Sweepstakes Prize listed below, one (1) potential Sweepstakes winner will be randomly selected from eligible Votes on or about January 7, 2027 after the conclusion of the Voting Period. Odds of winning the Sweepstakes Prize depend on the number of eligible Votes received. Odds of winning the Contest Grand Prize depend on the Participant's skill in the six (6) challenges.

- 5.2 Contest Grand Prize. There will be one (1) Grand Prize awarded consisting of:

- 5.2.1 Two (2) tickets to Super Bowl LXI on February 14, 2027 and one (1) fly away voucher with Allegiant Air for five hundred dollars (\$500.00). The approximate retail value ("**ARV**") of the Contest Grand Prize is \$4,000.00.

- 5.3 Sweepstakes Prize. There will also be one (1) Sweepstakes Prize awarded consisting of:

5.3.1 One (1) \$750.00 fly away voucher with Allegiant Air, subject to applicable expiration dates and terms. The ARV of the Sweepstakes Prize is \$750.00.

5.4 Total (ARV) of the Prizes. The Contest Grand Prize and Sweepstakes Prize are collectively referred to herein as the “Prizes”. The total ARV of all Prizes to be awarded as part of the Promotion is \$4,750.00. The ARV for the Prizes are an estimate made before the Promotion begins. If the actual retail value of a Prize is less than or greater than the stated ARV, the respective Prize winner will not receive the difference.

6. PRIZE CONDITIONS.

6.1 General Prize Conditions:

6.1.1 No more than one (1) Prize will be awarded per person. All potential winners are subject to verification by Sponsor or Wit, whose decisions are final. Prizes cannot be transferred, redeemed for cash or substituted by a Participant or Voter. All federal, state, provincial and local taxes, and all costs and expenses, related to the acceptance or use of the Prize, and not specified herein as being provided, are the sole responsibility of the winner. Any required tax reporting forms will be furnished to the appropriate authorities. Sponsor reserves the right in its sole and absolute discretion to change the prize, award a substitute Prize of equal or greater estimated value if a Prize described in these Rules is unavailable or cannot be awarded, in whole or in part, for any reason. That determination is final and binding and cannot be appealed. Sponsor makes no representation or warranty concerning the appearance, safety or performance of any Prize awarded.

6.1.2 Sponsor reserves the right to determine if and how Prizes will be delivered to any potential winner. All Prizes may be claimed in and shipped to an address in the 50 United States and/or the District of Columbia, except in Sponsor’s sole and absolute discretion. All Prizes may be delivered to the winners by regular mail, United Postal Service or courier such as Federal Express or any other delivery method at Sponsor’s discretion. Type of delivery service will be at sole and absolute discretion of Sponsor. Sponsor estimates that Prize delivery will take approximately six (6) to eight (8) weeks for delivery after winner’s verification. Sponsor is not responsible for and will not replace any lost, mutilated or stolen Prizes. Sponsor assumes no liability for non-deliverability.

6.1.3 In the event that the Promotion is cancelled or postponed by Sponsor for any reason whatsoever, the Prizes (or their equivalent ARV) shall not be awarded except and solely to the extent decided by Sponsor or Wit in their sole discretion or as otherwise required by law. Sponsor and/ or Wit shall have no responsibility or obligation to the winner or a potential winner who is unable or unavailable to, or who does not for any reason, accept or utilize the Prize. In the event of non-compliance with these Official Rules, or if the Prize is unclaimed, the Prize will be forfeited. A forfeited Prize may be awarded to an alternate winner, at Sponsor’s sole discretion.

- 6.1.4 The Allegiant flight voucher are subject to additional terms and conditions imposed by Allegiant. The Allegiant flight voucher is valid for one year from the date of issuance. All booking and travel must be completed within one (1) year from date of issuance. Any unused portions of the Allegiant travel voucher will be forfeited. Any amounts due over the value of the Allegiant flight voucher will be the sole responsibility of the winner. No credit or cash will be returned or refunds issued if the full value of the Allegiant flight voucher has not been used by its respective expiration date, if any. Allegiant flight vouchers will not be replaced if lost or stolen but Sponsor may, in its sole and absolute discretion, replace a lost, stolen or malfunctioning flight voucher or card. In no event will an Allegiant flight voucher value exceed its stated value.
- 6.1.5 EACH PRIZE IS AWARDED AS IS AND WITHOUT WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. SOME JURISDICTIONS MAY NOT ALLOW (OR MAY LIMIT) DISCLAIMERS OF CERTAIN WARRANTIES, IN WHICH CASE THE FOREGOING DISCLAIMERS WILL BE ENFORCED TO THE MAXIMUM EXTENT PERMITTED BY LAW.

6.2 Conditions for the Contest Grand Prize:

- 6.2.1 By participating in this Promotion or accepting the Contest Grand Prize, Participants further acknowledge and agree to the following Contest Grand Prize restrictions: Contest Grand Prize winner and his or her companion must follow all instructions of Sponsor and/or the National Football League (“NFL”) relative to the Contest Grand Prize or any element thereof. In the event the Contest Grand Prize winner or his or her travel companion engages in behavior that, as determined by Sponsor at its sole discretion, is obnoxious or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to terminate the Contest Grand Prize or other applicable experience early, in whole or in part. In such event, Contest Grand Prize winner may also be required to reimburse the Sponsor for the ARV of the Contest Grand Prize.
- 6.2.2 Game tickets must be taken or utilized on date specified by Sponsor or the applicable Prize will be forfeited and Sponsor will have no further obligation to such winner. Sponsor and/or NFL reserves right to change dates. Winner is responsible for arranging travel to and from Super Bowl LXI at winner’s sole expense. All other costs not described in the Rules are the responsibility of winner. Winner is subject to all stadium and NFL rules, procedures, and code of conduct when attending Super Bowl LXI.
- 6.2.3 Tickets are subject to certain terms and conditions as specified thereon. Seat locations will be determined by Sponsor and/or NFL. Winner and guest must comply with all venue rules and regulations. Failure to do so may result in forfeiture of such portion of Prize.

7. INTELLECTUAL PROPERTY OWNERSHIP.

Participant and Voter hereby acknowledge and agree that, in the event the Promotion requires or permits submission of any content by Participant or Voter, including but not limited to Participant or Voter's photograph, artwork, text or other content ("**Content**"), all such Content submitted by Participant or Voter shall be deemed a "work made for hire", as defined in the United States Copyright Act. Participant and Voter agree that Sponsor shall be the exclusive owner of such Content and all rights therein. Sponsor's ownership includes without limitation the rights to: (i) exhibit, broadcast, use, reproduce, distribute, perform and license others to use all or any part of the Content; (ii) edit or modify the Content in any manner, or combine same with any other materials; and (iii) use and license third parties to use the Content and/or any portion thereof in any manner of exploitation and, in the case of (i), (ii) or (iii), in any digital, print or other medium whether now known or hereafter discovered, worldwide and in perpetuity with no obligation of further consideration or of notice, review or approval.

8. PRIVACY.

Personally identifiable information ("**PII**") that is submitted by Participant or Voter as part of this Promotion will be used to administer the Promotion, select and announce the winner. Participant and Voter hereby waive any claims that Participant or Voter may have or acquire against the Sponsor for libel, slander, invasion of privacy, copyright or trademark violation, moral rights, right of publicity, rights of privacy, or false light arising out of or in connection with such use. Participant and Voter agree that this is a waiver of privacy rights and constitutes a valid consent to uses of any PII as may be required under applicable data protection laws. Any PII that You provide in participating in the Promotion is subject to the privacy policies of the Sponsor and Wit. Please review the privacy policies of the Sponsors at [Raiders Privacy Policy](#) and [Allegiant Privacy Policy](#), as well as the Wit privacy policy at Wit [Privacy Policy](#). By entering the Promotion, You grant Sponsor and Wit permission to share your email address and any other PII with the other Promotion partners for the purpose of administration and Prize fulfillment, including use in a publicly available winners list. Winners, by acceptance of Prize, except where legally prohibited, grants permission for Sponsor and its designees to use his/her name, address (city and state), photograph, voice and other likeness and Prize information for advertising, trade and promotional purposes without further compensation, in all media (including digital media) now known or hereafter discovered, worldwide in perpetuity, without notice or review or approval.

BY ENTERING THIS PROMOTION, PARTICIPANT AND VOTER ACKNOWLEDGE AND AGREE, WHEN APPLICABLE, THAT THEY HAVE READ AND CONSENT TO SPONSOR'S AND ADMINISTRATOR'S PRIVACY POLICY. PARTICIPANTS AND VOTERS FURTHER ACKNOWLEDGE THAT THEIR PII MAY BE DISCLOSED TO THIRD PARTIES INCLUDING, WITHOUT LIMITATION, PLACING YOUR NAME ON A WINNERS' LIST.

9. GENERAL CONDITIONS.

Released Parties (as defined below) are not responsible for lost, late, incomplete, inaccurate, stolen, misdirected, undelivered, garbled, illegible or postage-due mail, Votes, Contest participation or email; or for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), Platform, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or

difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Promotion, including, without limitation, errors or difficulties which may occur in connection with the administration of the Promotion, the processing of Votes or Contest participation, the announcement of the Prizes or in any Promotion-related materials.
