Official Rules

1. Description of Giveaway

Welcome to the FanDuel & Carolina Panthers Bryce Young Signed Jersey Giveaway (the "Giveaway") where one (1) selected winner will receive one (1) autographed jersey by Carolina Panthers quarterback Bryce Young.

The Giveaway is sponsored by FanDuel, Inc. ("**FanDuel**" or the "**Sponsor**"), located at 1 Madison Avenue, Floor 23, New York, NY 10010. The terms "**you**" or "**your**" mean the person who participates in this Giveaway. Participation in the Giveaway is expressly conditioned upon acceptance of and compliance with all of these Giveaway "**Official Rules**". Giveaway participants may be required to sign paperwork issued by the Sponsor.

2. Giveaway Period

The Giveaway will begin at 9:00 AM ET on September 11, 2026, and end at 11:59 PM ET on September 13, 2026 (the "**Giveaway Period**"). All entries must be received by the Sponsor by 11:59 PM ET on September 13, 2026.

3. Eligibility

The Giveaway is only open to individuals who are at least 18 years of age, are physically present in North Carolina during the Giveaway Period. If your social security number is associated with another FanDuel Account (as defined below) in Sponsor's database, you may only earn one Prize in respect of all such FanDuel Accounts under this Giveaway.
