## **Playoffs Fly Away Sweepstakes**

## **Official Rules**

## NO PURCHASE OR PAYMENT NECESSARY TO PLAY. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Playoffs Fly Away Sweepstakes (the "Sweepstakes") is sponsored by Minnesota Vikings Football, LLC, 2600 Vikings Circle, Eagan, MN 55121 ("Vikings").

**Entry Period**: The Sweepstakes begins Tuesday, January 7, 2025, at 9:00am CT, and ends Friday, January 10, 2025, at 7:00pm CT (the "Entry Period"). Vikings' computer is the Sweepstakes official clock.

**Eligibility:** To participate in the Sweepstakes, you must be at least eighteen (18) years of age on the date of entry and a resident of the United States of America (excluding residents of Alaska, Florida, New York, and Rhode Island). Void where otherwise prohibited. - 3. One (1) Marriott Bonvoy gift card valued at Two Thousand Dollars (\$2,000).
