2023 Gray Duck Vodka "Vikings In Vegas" Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO PLAY. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The 2023 Gray Duck Vodka "Vikings In Vegas" Sweepstakes (the "Sweepstakes") is sponsored by Minnesota Vikings Football, LLC, 2600 Vikings Circle, Eagan, MN 55121 ("Vikings") and Gray Duck Spirits, LLC, 18064 Green Gables Trail, Lakeville, MN 55044 ("Gray Duck").

Entry Period: The Sweepstakes begins September 5, 2023, at 8:00 AM CST, and ends November 5, 2023, at 11:59 PM CST (the "Sweepstakes Period"). Vikings' computer is the Sweepstakes official clock.

Eligibility: To participate in the Sweepstakes, you must be at least twenty-one (21) years of age on the date of entry and physically located within the United States. VOID in Alaska, Florida, New York, Rhode Island, outside the U.S., and where prohibited. Employees of Vikings, Gray Duck, or their affiliates, parent companies, marketing agencies, sweepstakes vendors, subsidiaries and advertising and promotion agencies, any contractors working directly on the Sweepstakes and the immediate family members or those living in the same household of each are not eligible to participate.

Entry: To enter the Sweepstakes, entrants must either (i) utilize a smartphone camera or Quick Response Code (QR Code) reader, scan the QR Code found on Sweepstakes advertising materials that have been placed in select retail locations throughout the Twin Cities metro and fill out the registration form; or (ii) go to the site below and fill out the registration form:

No other method of entry will be accepted. Limit of one (1) entry per person. Additional entries beyond the specified limit will be void. Participation in the Sweepstakes constitutes an entrant's full and unconditional agreement to these Official Rules and Vikings' decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

Prize: There is one (1) prize in the Sweepstakes – The prize will consist of a trip for one (1) winner and one (1) guest to the Minnesota Vikings away game at Allegiant Stadium in Las Vegas, Nevada against the Las Vegas Raiders on December 12, 2023 (the "Game").

The prize includes:

- Two (2) upper level game tickets (seat location selected by Vikings in its sole discretion) to the Game;
- Round-trip coach class airfare for two (2) between a commercial airport near winner's residence and Las Vegas, Nevada, as determined by Vikings in its sole discretion;
- Two (2) nights standard hotel accommodations (single room, double occupancy) at a Vikings' determined hotel in its sole discretion;
- One (1) Five Hundred Dollar (\$500) visa gift card; and
- To be determined Gray Duck merchandise, as determined in the sole discretion of Gray Duck.

The winner's guests must be at least twenty-one (21) years of age or be the minor child or legal ward of the winner. All airfare and hotel accommodation booking arrangements will be administered by Vikings' authorized designee; provided that winner shall provide Vikings with the full name and date of birth of the winner and winner's guest. All travel must be booked prior to departure. Travel is subject to capacity controls, availability, weather, seasonal influences, and certain other restrictions, all of which are subject to change. No changes will be made to travel details once any element(s) of the arrangements have been booked, except in Vikings' sole discretion.

No refund or compensation will be made in the event of the cancellation or delay of any flight. Travel is subject to the terms and conditions set forth in these Official Rules and those set forth by Vikings' travel prize supplier, as detailed in any contract issued by such supplier. If the winner elects to travel without a guest, no additional compensation will be awarded.

The winner and winner's guest are each solely responsible for obtaining any desired or necessary travel documents. The winner and winner's guest hereby acknowledges that Vikings have not and will not obtain or provide travel insurance or any other form of insurance for any part of the prize. The winner and winner's guest are responsible for all in-room charges (e.g., mini-bar, movies), telephone calls, Wi-Fi internet, meals, beverages, gratuities, upgrades, personal incidentals, amenities and any other fees and expenses not specifically mentioned in these Official Rules. The winner will be required to provide a major credit card upon hotel check-in and all in-room charges will be charged to such credit card.

Game tickets are awarded pursuant to a revocable, nontransferable license that is personal to the winner and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated, or otherwise conveyed (except to a surviving spouse). A violation of these restrictions shall revoke winner's license, and may result in the prize not being honored.

Winner and guests must abide by all Vikings and venue policies, protocols, and Game ticket terms and conditions. Vikings reserves the right to revoke the Game tickets from winner and/or guests who do not abide the aforementioned policies, protocols, or ticket terms and conditions, or who the Vikings or venue personnel deem, in their sole discretion, may be intoxicated, be a safety risk, or have violated any venue policy or law.

Total Approximate Value: Five Thousand Dollars (\$5,000). Actual prize value is subject to fluctuations in the price of airfare, hotel accommodations, and game tickets, and winner will not receive the difference between actual value and approximate value.

All costs and expenses not specifically included herein, including but not limited to, transportation to and from the hotel and/or stadium, are solely the winner's responsibility. No refund or compensation will be made in the event of the cancellation of the Game.

Taxes on any prize, including any federal, state, local, sales and income taxes (if applicable), are solely the responsibility of the winners, and the winner agrees to provide a W-9 Form. Winner acknowledges that he or she will be issued a 1099 Form if the value of all prizes won (from any promotion) by winner from Vikings during the 2023 calendar year meets or exceeds Six Hundred Dollars (\$600) or other amount as determined by the IRS. by e-mail and must respond or reply to Vikings within three (3) business days. In the event a winner is unreachable, a winner's prize notification is returned as undeliverable, or a winner is not in compliance with these Official Rules, the winner will forfeit the prize. A forfeited prize may be awarded to an alternate winner in a random drawing from all remaining eligible entries received for that corresponding Entry Period. No substitutions are permitted except if the prize is unavailable, in which case the prize of equal or greater value may be awarded. Prize is not redeemable for cash.

IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("AAA RULES"). THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MINNESOTA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN HENNEPIN COUNTY, MINNESOTA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THESE OFFICIAL RULES OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
