

2024 Gray Duck Vodka "VIP Tailgating Experience" Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO PLAY. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The 2024 Gray Duck Vodka "VIP Tailgating Experience" Sweepstakes (the "Sweepstakes") is sponsored by Minnesota Vikings Football, LLC, 2600 Vikings Circle, Eagan, MN 55121 ("Vikings") and Gray Duck Spirits, LLC, 18064 Green Gables Trail, Lakeville, MN 55044 ("Gray Duck").

Entry Period: The Sweepstakes begins August 26, 2024, at 8:00 AM CST, and ends November 11, 2024, at 11:59 PM CST (the "Sweepstakes Period"). Vikings' computer is the Sweepstakes official clock.

Eligibility: To participate in the Sweepstakes, you must be at least twenty-one (21) years of age on the date of entry and physically located within Minnesota. Employees of Vikings, Gray Duck, or their affiliates, parent companies, marketing agencies, sweepstakes vendors, subsidiaries and advertising and promotion agencies, any contractors working directly on the Sweepstakes and the immediate family members or those living in the same household of each are not eligible to participate.

Entry: To enter the Sweepstakes, entrants must either (i) utilize a smartphone camera or Quick Response Code (QR Code) reader, scan the QR Code found on Sweepstakes advertising materials that have been placed in select retail locations throughout the Twin Cities metro and fill out the registration form; or (ii) go to the site below and fill out the registration form:

No other method of entry will be accepted. Limit of one (1) entry per person. Additional entries beyond the specified limit will be void. Participation in the Sweepstakes constitutes an entrant's full and unconditional agreement to these Official Rules and Vikings' decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

Prize: There is one (1) prize for eight (8) different winners in the Sweepstakes – The prize will consist of two (2) tickets for each of the eight (8) different winners to the Minnesota Vikings home game at U.S. Bank Stadium in Minneapolis, MN against the Arizona Cardinals on December 1, 2024 (the "Game").

Each of the eight (8) winners will be selected to win a prize, which consists of the following:

- Two (2) lower-level game tickets (seat location selected by Vikings in its sole discretion) to the Minnesota Vikings home game at U.S. Bank Stadium in Minneapolis, MN against the Arizona Cardinals on December 1, 2024 (the "Game") (approx. \$325);
- Private tailgating experience with Chad Greenway at Union Labor building prior to the Game (approx. \$75);
- One (1) Game Day parking pass (approx. \$30); and
- Vikings prizes and merchandise, as determined in the sole discretion by Vikings (approx. \$125).

The winner's guests must be at least twenty-one (21) years of age or be the minor child or legal ward of the winner. Winner shall provide Vikings with the full name and date of birth of the winner and winner's guest.

Game tickets are awarded pursuant to a revocable, nontransferable license that is personal to the winner and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated, or otherwise conveyed (except to a surviving spouse). A violation of these restrictions shall revoke winner's license, and may result in the prize not being honored.

Winner and guests must abide by all Vikings and venue policies, protocols, and Game ticket terms and conditions. Vikings reserves the right to revoke the Game tickets from winner and/or guests who do not abide the aforementioned policies, protocols, or ticket terms and conditions, or who the Vikings or venue personnel deem, in their sole discretion, may be intoxicated, be a safety risk, or have violated any venue policy or law.

Total Approximate Value: Five Hundred and Eighty Dollars (\$580). Actual prize value is subject to fluctuations in the price of accommodations and game tickets. Winner will not receive the difference between actual value and approximate value.

All costs and expenses not specifically included herein, including but not limited to, transportation to and from the stadium, are solely the winner's responsibility. No refund or compensation will be made in the event of the cancellation of the Game.

Taxes on any prize, including any federal, state, local, sales and income taxes (if applicable), are solely the responsibility of the winners, and the winner agrees to provide a W-9 Form. Winner acknowledges that he or she will be issued a 1099 Form if the value of all prizes won (from any promotion) by winner from Vikings during the 2024 calendar year meets or exceeds Six Hundred Dollars (\$600) or other amount as determined by the IRS. The winner will not be required to make any payments to Vikings.

Odds of winning depend on the number of entries received.

Winner Selection and Notification: A random drawing selecting eight (8) winners, among all eligible entries received, will be conducted on or about November 12, 2024, by a Vikings representative, whose decisions are final on all matters relating to the Sweepstakes. The potential winners will be notified by e-mail and must respond or reply to Vikings within three (3) business days. In the event a winner is unreachable, a winner's prize notification is returned as undeliverable, or a winner is not in compliance with these Official Rules, the winner will forfeit the prize. A forfeited prize may be awarded to an alternate winner in a random drawing from all remaining eligible entries received for that corresponding Entry Period. No substitutions are permitted except if the prize is unavailable, in which case the prize of equal or greater value may be awarded. Prize is not redeemable for cash.
