2024 London Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO PLAY. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The 2024 London Sweepstakes (the "Sweepstakes") is sponsored by Minnesota Vikings Football, LLC, 2600 Vikings Circle, Eagan, MN 55121 ("Vikings") and On-Location Events, LLC, 7 Renaissance Square, White Plains, NY 10601 ("On-Location" and, together with Vikings, "Sponsor").

Entry Period: The Sweepstakes begins May 15, 2024, at 6:30am CST, and ends June 14, 2024, at 5:00pm CST (the "Sweepstakes Period"). Vikings' computer is the Sweepstakes official clock.

Eligibility: To participate in the Sweepstakes, you must be at least eighteen (18) years of age on the date of entry and a resident of the United States of America (excluding residents of Alaska, Florida, New York, and Rhode Island). Void where otherwise prohibited. Employees of Vikings or On Location or its affiliates, parent companies, marketing agencies, sweepstakes vendors, subsidiaries and advertising and promotion agencies, any contractors working directly on the Sweepstakes and the immediate family members or those living in the same household of each are not eligible to participate.

Entry: Enter the Sweepstakes online by completing an online entry form located at the following link: https://minnesotavikings.formstack.com/forms/2024 london contest.

No other method of entry will be accepted. Limit of one (1) entry per person. Additional entries beyond the specified limit will be void. Participation in the Sweepstakes constitutes an entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

Prize: There will be one (1) prize, the "London Games Experience", awarded in the Sweepstakes:

One (1) first place winner will receive a trip for four (4) to the 2024 Vikings game taking place in London, England on Sunday, October 6, 2024 (the "London Game") against the New York Jets. This prize includes select experiences and/or events as determined in Sponsor's sole discretion, including:

- Two (2) pairs of tickets (total of four (4) tickets) to the London Game, with seat locations selected by On-Location, at its sole discretion;
- Round-trip coach class airfare for four (4) between a commercial airport near Winner's residence and London, England, as determined by On-Location, at its sole discretion; and
- Two (2) single hotel rooms (with double occupancy) with standard accommodations for up to four (4) nights, as determined by On-Location, at its sole discretion.
- A. All other expenses not specified herein as being covered by Sponsor in connection with the London Games Experience, including, but not limited to, meals, beverages, gratuities, taxes, hotel incidentals, excursions, fees, surcharges, service charges, departure and airport taxes,

security fees, transfers and ground transportation, including taxis, are the responsibility of Winner.

- B. Sponsor is not liable for any expense incurred as a consequence of flight cancellation/delay or any acts or omissions whatsoever by air carriers, hotel or other transportation companies. No refund or compensation will be made. Winner and each guest is responsible for obtaining any necessary travel documentation such as a valid state identification, passport or other required identification.
- C. Winner and each guest may be required to present a valid credit card at the hotel at the time of check-in. Winner and each guest must comply with all applicable requirements and restrictions related to the prize including, without limitation, applicable travel dates, travel documentation and reservation and confirmation procedures. Sponsor will not obtain or provide travel insurance or any other form of insurance. Baggage fees on flights may apply and are the responsibility of the Winner and each guest. Once travel arrangements have been booked, no changes will be allowed. If Winner does not have three (3) companions to accompany Winner, the prize will otherwise be awarded in applicable increments and in such event, no substitute prize or additional compensation will be awarded.
- D. Any federal and state taxes in connection with the award and use of the prize, are solely the Winner's responsibility.
- E. The winner's guest(s) must be at least eighteen (18) years of age or be the minor child or legal ward of the winner. All hotel accommodation booking arrangements will be administered by Sponsor or its authorized designee. Hotel accommodations are subject to capacity controls, availability, weather, seasonal influences, and certain other restrictions, all of which are subject to change.
- F. Game tickets are awarded pursuant to a revocable, nontransferable license that is personal to the winner and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated, or otherwise conveyed. A violation of these restrictions shall revoke winner's license, and may result in the prize not being honored.
- G. Winner and all guests must abide by all venue policies and game ticket terms and conditions. The NFL reserves the right to revoke the game tickets from winner and/or any guest who the NFL or venue personnel deem, in their sole discretion, may be intoxicated, be a safety risk, or have violated any venue policy or law.

Approximate Value: Total Approximate Value of Prize: \$20,000.00. Actual prize value is subject to fluctuations in the price of air travel and hotel accommodations and winner will not receive the difference between actual value and approximate value. The odds of winning depend on the number of eligible entries received.

Taxes on the prize, including any federal, state, local, sales and income taxes (if applicable), are solely the responsibility of each winner, and each winner agrees to provide a W-9 Tax form. Each winner will not be required to make any payments to Sponsor.

Winner Selection and Notification: A random drawing for the winners, among all eligible entries received, will be conducted the week of June 17, 2024, by a Vikings representative, whose decisions are final on all matters relating to the Sweepstakes. The potential winner will be notified by e-mail and must respond or reply to Vikings within three (3) business days. In the event a winner is unreachable, a winner's prize notification is returned as undeliverable, or a winner is not in compliance with these Official Rules, the winner will forfeit the prize. A forfeited prize may be

awarded to an alternate winner in a random drawing from all remaining eligible entries received for that corresponding Entry Period. No substitutions are permitted except if the prize is unavailable, in which case the prize of equal or greater value may be awarded. Prize is not redeemable for cash.

The winners of the prize and his/her guest will be required to complete and return an Affidavit of Eligibility, a Release of Liability and Publicity Release (the "Affidavit") including, but not limited to, providing proof of identity, which must be executed and returned to Vikings within five (5) business days of the date specified on the notification. If the Affidavit is returned as undeliverable or not returned to Vikings within five (5) business days of the date specified on the notification, the prize will be forfeited and may be awarded to an alternate winner in a separate random drawing.

If a winner is otherwise ineligible under these Official Rules, the prize will not be awarded to the entrant. Prizes are non- assignable and non-transferable except to a surviving spouse. No substitutions are permitted except if a prize is unavailable, in which case a prize of equal or greater value may be awarded.

Prizes are not redeemable for cash. Taxes on any prize, including any federal, state, local, sales and income taxes (if applicable), are solely the responsibility of the winner and winner agrees to provide a W-9 Tax form. Winners will not be required to make any payments to Vikings. Winner acknowledges that he or she will be issued a 1099 Form if the value of all prizes won (from any promotion) by winner from Vikings during the 2024 calendar year meets or exceeds Six Hundred Dollars (\$600) or other amount as determined by the IRS.

IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("AAA RULES"). THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MINNESOTA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN HENNEPIN COUNTY, MINNESOTA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THESE OFFICIAL RULES OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
