

2026 Season Ticket Member Renewal Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO PLAY. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The 2026 Season Ticket Member Renewal Sweepstakes (the "Sweepstakes") is sponsored by Minnesota Vikings Football, LLC, with an address of 2600 Vikings Circle, Eagan, MN 55121 ("Vikings").

Entry Period: The Sweepstakes begins February 10, 2026, at 12:00am CT, and ends March 9, 2026, at 11:59pm CT (the "Entry Period"). Vikings' computer is the Sweepstakes official clock.

Eligibility: To participate in the Sweepstakes, you must be at least twenty-one (21) years of age on the date of entry and a resident of the United States of America (excluding residents of Alaska, Florida, New York, and Rhode Island). Void where otherwise prohibited. Employees of Vikings or its affiliates, parent companies, marketing agencies, sweepstakes vendors, subsidiaries and advertising and promotion agencies, any contractors working directly on the Sweepstakes and the immediate family members or those living in the same household of each are not eligible to participate.

Entry: There are two (2) ways to enter the Sweepstakes:

1. **Online Entry:** If you are a Season Ticket Member and will have fully paid for your 2026 Vikings season tickets on or before March 9, 2026, visit https://minnesotavikings.formstack.com/forms/2026_stm_renewal_sweepstakes and follow the instructions provided to complete and submit the Sweepstakes entry form during the Entry Period. Upon payment of your 2026 season tickets and completion of the entry form, you will be entered in the Sweepstakes.
2. **Mail-in Entry:** To enter for free by mail, send a 3" x 5" postcard with the following hand-written information – name (first and last), phone number, email address, and zip code – to Minnesota Vikings Football, LLC, 2600 Vikings Circle, Eagan, MN 55121, Attention: 2026 Season Ticket Member Renewal Sweepstakes - Marketing. Mail-in entries must be postmarked on or after the first day of the Entry Period and received no later than the last day of the Entry Period.

Limit one (1) entry per person regardless of the method of entry used. The odds of winning depend on the number of eligible entries received.

Participation in the Sweepstakes constitutes an entrant's full and unconditional agreement to these Official Rules and Vikings' decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

Prizes: There will be fifty-four (54) prizes awarded in the Sweepstakes:

Prize 1: Four (4) first place winners will receive an NFL Draft Experience. The NFL Draft Experience consists of a trip for the winner and one (1) guest to attend the 2026 National Football League ("NFL") Draft, which will be held in Pittsburgh, Pennsylvania, starting on April 23, 2026, and ending on April 25, 2026. This prize includes:

- Round-trip coach class airfare for two (2) between a commercial airport near winner's residence and Pittsburgh, Pennsylvania, as determined by Vikings in its sole discretion;
- Up to three (3) nights standard hotel accommodations (single room, double occupancy), as determined by Vikings in its sole discretion;

- Two (2) NFL Draft tickets (seat locations selected by the NFL in its sole discretion); and
- Access for two (2) to an NFL Draft VIP Experience, which includes select experiences and/or events as determined in the NFL's sole discretion.

Approximate Value: Two Thousand One Hundred Sixty-Seven Dollars (\$2,167) per person; Total Approximate Value of Prize: Four Thousand Three Hundred Thirty-Four Dollars (\$4,334). Actual prize value is subject to fluctuations in the price of air travel and hotel accommodations. Winner will not receive the difference between actual value and approximate value.

Prize 2: Fifty (50) second place winners will receive a Vikings Away Game Experience for the winner and one (1) guest to attend a 2026 Minnesota Vikings away game, which will be chosen by Vikings in its sole discretion. Transportation/airfare is not included and is the sole responsibility of each winner and their guest. Additional details including the date and the opponent will be confirmed as part of the NFL's full schedule announcement in May 2026. This prize includes:

- Up to one (1) night standard hotel accommodations (single room, double occupancy), as determined by Vikings in its sole discretion; and
- Two (2) tickets to a Minnesota Vikings away game at a to-be-determined location (seat locations selected by Vikings in its sole discretion).

Approximate Value: One Thousand Three Hundred Sixty Dollars (\$1,360) per person; Total Approximate Value of Prize: Two Thousand Seven Hundred Twenty Dollars (\$2,720). Actual prize value is subject to fluctuations in the price of game tickets (which may vary depending on the selected NFL market) and hotel accommodations. Winner will not receive the difference between actual value and approximate value.

All costs and expenses not specifically included herein are solely the winner's responsibility.

The following terms and conditions apply to the prizes:

- A. Travel restrictions and blackout dates may apply.
- B. The winner's guest must be at least twenty-one (21) years of age or be the minor child or legal ward of the winner. All airfare (if applicable) and hotel accommodation booking arrangements will be administered by Vikings' authorized designee. All travel must be booked prior to departure. Travel is subject to capacity controls, availability, weather, seasonal influences, and certain other restrictions, all of which are subject to change. No changes will be made to travel details once any element(s) of the travel arrangements have been booked, except in Vikings' sole discretion.
- C. No refund or compensation will be made in the event of the cancellation or delay of any flight. Travel is subject to the terms and conditions set forth in these Official Rules and those set forth by Vikings' travel prize supplier, as detailed in any contract issued by such supplier. If the winner elects to travel without a guest, no additional compensation will be awarded.
- D. The winner and his/her guest are each solely responsible for obtaining any desired or necessary travel documents (including government-issued photo identification). The winner and his/her guest hereby acknowledge that Vikings have not and will not obtain or provide travel insurance or any other form of insurance for any part of the prize. The winner and his/her guest are responsible for all in-room charges (e.g., mini-bar, movies), telephone calls, Wi-Fi internet, meals, beverages, gratuities, upgrades, personal incidentals, amenities and any other fees and expenses not specifically mentioned in these Official Rules. The winner will be required to provide a major credit card upon hotel check-in and all in-room charges will be charged to such credit card.

- E. NFL Draft tickets and Vikings away game tickets are awarded pursuant to a revocable, nontransferable license that is personal to the winner and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated, or otherwise conveyed. A violation of these restrictions shall revoke winner's license and may result in the prize not being honored.
- F. Winner and their guest must abide by all venue policies and NFL Draft or game ticket terms and conditions. The NFL reserves the right to revoke the draft or game tickets from winner and/or their guest who the NFL or venue personnel deem, in their sole discretion, may be intoxicated, be a safety risk, or have violated any venue policy or law.

Winner Selection and Notification: A random drawing for the winners, among all eligible entries received, will be conducted on or around March 10, 2026, by a Vikings representative, whose decisions are final on all matters relating to the Sweepstakes. The winners will be notified by email and must respond or reply to Vikings within thirty (30) days. In the event a winner is unreachable, a winner's prize notification is returned as undeliverable, or a winner is not in compliance with these Official Rules, the winner will forfeit the prize. A forfeited prize may be awarded to an alternate winner in a random drawing from all remaining eligible entries received for the Sweepstakes.

The winners and their guests will be required to complete and return an Affidavit of Eligibility, a Release of Liability and Publicity Release (the "Affidavit") including, but not limited to, providing proof of identity, which must be executed and returned to Vikings within five (5) business days of the date specified on the notification. If the Affidavit is returned as undeliverable or not returned to Vikings within five (5) business days of the date specified on the notification, the prize will be forfeited and may be awarded to an alternate winner in a separate random drawing.

If a winner is otherwise eligible under these Official Rules but is nevertheless deemed a minor in his or her state of primary residence, the prize will not be awarded to the entrant. Prizes are non-assignable and non-transferable except to a surviving spouse. No substitutions are permitted except if a prize is unavailable, in which case a prize of equal or greater value may be awarded.

Prizes are not redeemable for cash. Taxes on any prize, including any federal, state, local, sales and income taxes (if applicable), are solely the responsibility of the winner and winner agrees to provide a W-9 Tax form. Winners will not be required to make any payments to Vikings. Each winner acknowledges that they will be issued a 1099 Form if the value of all prizes won (from any promotion) by the winner from Vikings during the 2026 calendar year meets or exceeds Two Thousand Dollars (\$2,000) or other amount as determined by the IRS.

THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MINNESOTA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN HENNEPIN COUNTY, MINNESOTA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THESE OFFICIAL RULES OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
