

## 2020 Minnesota Vikings Legends Connection Meet & Greet Sweepstakes

### Official Rules

#### **NO PURCHASE OR PAYMENT NECESSARY TO PLAY. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

The 2020 Minnesota Vikings Legends Connection Meet & Greet Sweepstakes (the "Sweepstakes") is sponsored by Minnesota Vikings Football, LLC, 2600 Vikings Circle, Eagan, MN 55121 ("Vikings") and CenturyTel Service Group, LLC, 100 CenturyLink Drive, Monroe, LA 71203 ("CenturyLink").

**Sweepstakes Period:** The Sweepstakes begins September 13, 2020, at 9:00am CT, and ends December 6, 2020, at 11:59pm CT (the "Sweepstakes Period"). Vikings' computer is the Sweepstakes official clock. The Sweepstakes Period will consist of four (4) entry periods (each, an "Entry Period"), as outlined in the table below:

Non-winning entries will not carry forward into subsequent Entry Periods.

**Eligibility:** To participate in the Sweepstakes, you must be at least eighteen (18) years of age on the date of entry AND a Minnesota resident. Employees of Vikings, CenturyLink or their affiliates, parent companies, marketing agencies, sweepstakes vendors, subsidiaries and advertising and promotion agencies, any contractors working directly on the Sweepstakes and the immediate family members or those living in the same household of each are not eligible to participate.

#### **There are two (2) ways to enter the Sweepstakes:**

2. **Push Notification Entry:** Upon receiving a push notification from Vikings directing the user to the Registration Form, click on the push notification, and complete the Registration Form.

Participation in the Sweepstakes constitutes an entrant's full and unconditional agreement to these Official Rules and Vikings' decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

Limit of one (1) entry per person per Entry Period, regardless of the method of entry used.

#### **Winner Selection and Notification:**

On or about each of the Random Drawing Date(s) set forth in the table above, Vikings will randomly draw two (2) potential prize winners from all eligible entries received during that corresponding Entry Period. Winners will be notified by phone or e-mail and must respond or reply to Vikings

within three (3) business days. In the event a winner is unreachable, a winner's prize notification is returned as undeliverable, or a winner is not in compliance with these Official Rules, the winner will forfeit the prize. A forfeited prize may be awarded to an alternate winner in a random drawing from all remaining eligible entries received for that corresponding Entry Period.

**Prizes: There are a total of eight (8) prizes in the Sweepstakes**

Each winner will receive the opportunity to join one (1) web-based platform video call with the other prize winner from that corresponding Entry Period and one (1) to-be-determined former player of the Minnesota Vikings, as determined in Vikings sole discretion, for approximately thirty (30) minutes, at a date and time determined in Vikings sole discretion. For clarity, the two prize winners from each Entry Period will collectively join one (1) video call with a to-be-determined former player of the Minnesota Vikings. Staff members of Vikings or CenturyLink may join such calls, as determined in Vikings or CenturyLink's sole discretion.

Approximate Value Per Prize: Two Hundred Fifty Dollars (\$250).

The odds of winning depend on the number of eligible entries received.

All costs and expenses not specifically included herein, including internet and/or cellular data, are solely each winner's responsibility.

No substitutions are permitted except if a prize is unavailable, in which case a prize of equal or greater value may be awarded. Prizes are not redeemable for cash.

IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("AAA RULES"). THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THESE OFFICIAL RULES OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
